**ASSEMBLY AMENDMENT 1,
TO ASSEMBLY BILL 903**

February 13, 2018 - Offered by Representative MACCO.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 9: after "boards" insert ", the nursing workforce survey,
3 extending the time limit for emergency rule procedures, and providing an exemption
4 from emergency rule procedures".

5 **2.** Page 5, line 11: after that line insert:

6 "SECTION 13m. 106.30 (1) of the statutes is repealed."

7 **3.** Page 6, line 12: delete the material beginning with that line and ending with
8 page 7, line 9, and substitute:

9 "SECTION 21c. 441.01 (7) (a) (intro.) of the statutes is amended to read:

10 441.01 (7) (a) (intro.) The board shall ~~require~~ request that each applicant for
11 the renewal of a registered nurse or licensed practical nurse license, certificate, or
12 permit issued under this chapter ~~to do all of the following as a condition for when~~
13 renewing the license, certificate, or permit:

1 **SECTION 22c.** 441.01 (7) (a) 1. of the statutes is amended to read:

2 441.01 (7) (a) 1. Complete and submit to the department with the application
3 for renewal of the license, ~~certificate, or permit~~ a nursing workforce survey developed
4 by the department of workforce development under s. 106.30 (2).

5 **SECTION 23c.** 441.01 (7) (b) of the statutes is amended to read:

6 441.01 (7) (b) The board may not require that an applicant complete the
7 nursing workforce survey or pay the nursing workforce survey fee in order to renew
8 a registered nurse or licensed practical nurse license, certificate, or permit under this
9 chapter ~~unless the renewal applicant has completed the nursing workforce survey~~
10 ~~to the satisfaction of the board.~~

11 (c) The board ~~shall~~ may establish standards to determine whether the survey
12 has been completed.

13 (d) The board shall, by no later than June 30 of each odd-numbered year,
14 submit all completed nursing workforce survey forms to the department of workforce
15 development.”.

16 **4.** Page 7, line 20: after that line insert:

17 **“SECTION 25m.** 441.10 (6) of the statutes is amended to read:

18 441.10 (6) On or before the applicable renewal date specified under s. 440.08
19 (2) (a), a licensed practical nurse practicing for compensation shall submit to the
20 board, on forms furnished by the department, an application for license renewal,
21 together with a statement giving name, residence, nature and extent of practice as
22 a licensed practical nurse during the prior year and prior unreported years, ~~the~~
23 ~~nursing workforce survey and fee required under s. 441.01 (7), and other facts~~
24 bearing upon current competency that the board requires, accompanied by the

1 applicable license renewal fee determined by the department under s. 440.03 (9)
2 (a).”.

3 **5.** Page 9, line 14: after that line insert:

4 **“SECTION 31m. Nonstatutory provisions.**

5 (1m) The board of nursing may promulgate emergency rules under section
6 227.24 of the statutes necessary to implement this act. Notwithstanding section
7 227.24 (1) (c) and (2) of the statutes, emergency rules promulgated under this
8 subsection remain in effect until May 1, 2019, or the date on which permanent rules
9 take effect, whichever is sooner. Notwithstanding section 227.24 (1) (a) and (3) of the
10 statutes, the board is not required to provide evidence that promulgating a rule
11 under this subsection as an emergency rule is necessary for the preservation of the
12 public peace, health, safety, or welfare and is not required to provide a finding of
13 emergency for a rule promulgated under this subsection.

14 **SECTION 32m. Initial applicability.**

15 (1m) The treatment of sections 441.07 (7) (a) (intro.) and 1. and (b), 441.08,
16 441.15 (3) (b), and 441.16 (3) (d) of the statutes first applies to renewals of a license,
17 permit, or registration for a renewal that occurs on the effective date of this
18 subsection.”.
