**ASSEMBLY AMENDMENT 1,
TO ASSEMBLY BILL 219**

October 15, 2019 – Offered by Representative VRUWINK.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 13: after that line insert:

3 “**SECTION 3m.** 341.14 (6r) (b) 1m. i. of the statutes is created to read:

4 341.14 (**6r**) (b) 1m. i. Upon receipt of a contribution totaling an amount equal
5 to the department’s final estimate of the initial costs of production of the special
6 group plates under par. (f) 70. or \$15,500, whichever is less, from any person or group
7 interested in the special group plates under par. (f) 70., the department shall
8 commence any development work necessary to implement the provisions of par. (f)
9 70. and related provisions under this subsection and shall complete the development
10 work within one year of its commencement. As soon as possible, the department
11 shall post notice on the department’s Internet site of its final estimate of the initial
12 costs of production of the special group plates under par. (f) 70. The development
13 work under this subd. 1m. i. shall be funded only from the appropriation under s.

1 20.395 (4) (ch) from the contribution received by the department for purposes of this
2 subd. 1m. i. No contribution received by the department under this subd. 1m. i. may
3 be applied to any fee established under subd. 2. The department may not issue any
4 special group plates under par. (f) 70. until the department has completed the
5 development work specified in this subd. 1m. i. If, in the 3rd year beginning after
6 special group plates under par. (f) 70. are first issued under par. (f) 70., or any 3rd
7 year thereafter, the department receives, in the calendar year, fewer than 500
8 applications for registration renewal for vehicles for which these special plates were
9 issued, the department shall inform the department of natural resources that the
10 special group plates will be discontinued if fewer than 500 applications are received
11 in the following year. If, in that following calendar year, the department receives
12 fewer than 500 applications for registration renewal for vehicles for which these
13 special plates were issued, the department shall cease issuing special group plates
14 under par. (f) 70.”.

15 **2.** Page 2, line 15: delete the material beginning with “In addition” and ending
16 with “shall be” on line 17 and substitute “A voluntary payment of \$40 that is in
17 addition to the fee under subd. 2. shall be”.

18 **3.** Page 3, line 1: delete the material beginning with “In addition” and ending
19 with “s. 27.01 (7) (f) 1.” on line 3 and substitute “A voluntary payment of \$80 that is
20 in addition to the fee under subd. 2.”.

21 **4.** Page 3, line 10: delete the material beginning with “All” and ending with
22 “parks.” on line 13 and substitute “All moneys received under this subdivision in
23 excess of \$15,500 or the actual cost of design and production of the special group
24 plates, whichever is less, for the initial costs of production for the special group

1 plates, shall be deposited in the department of natural resource's administrative
2 parks account of the conservation fund for use for state parks.”.

3 **5.** Page 3, line 13: after that line insert:

4 **“SECTION 4m.** 341.14 (6r) (c) of the statutes is amended to read:

5 341.14 **(6r)** (c) Special group plates shall display the word “Wisconsin”, the
6 name of the applicable authorized special group, a symbol representing the special
7 group, not exceeding one position, and identifying letters or numbers or both, not
8 exceeding 7 positions and not less than one position. Except as provided in this
9 paragraph, the department shall specify the design for special group plates, but the
10 department shall consult the president of the University of Wisconsin System before
11 specifying the word or symbol used to identify the special groups under par. (f) 35.
12 to 47., the secretary of natural resources before specifying the word or symbol used
13 to identify the special groups under par. (f) 50. and 59., the chief executive officer of
14 the professional football team and an authorized representative of the league of
15 professional football teams described in s. 229.823 to which that team belongs before
16 specifying the design for the applicable special group plate under par. (f) 55., the chief
17 trademark officer of Harley-Davidson Michigan, LLC before specifying the design
18 for the applicable special group plate under par. (f) 61r., the department of veterans
19 affairs before specifying the design for the special group plates under par. (f) 49d.,
20 49h., and 49s., the department of tourism and chief executive officer of the
21 organization specified in par. (f) 55m. before specifying the design and word or
22 symbol used to identify the special group name for special group plates under par.
23 (f) 55m., and the Three Harbors Council, Boy Scouts of America NESA License
24 Committee before specifying the designs for the initial special group plate under par.

1 (f) 66. Special group plates under par. (f) 50. shall be as similar as possible to regular
2 registration plates in color and design. Special group plates issued under par. (f) 62.
3 shall display the words “In God We Trust”. The department shall make available 2
4 designs for the special group plates under par. (f) 60. The department may not specify
5 any design for the special group plates under par. (f) 60. unless the design is approved
6 by the executive vice president of the Milwaukee Brewers Baseball Club LP. The
7 department may not specify any design for the special group plates under par. (f) 65.
8 unless the design is approved by the president of the Milwaukee Bucks. The word
9 or symbol used to identify the special group under par. (f) 59. shall be different from
10 the word or symbol used to identify the special group under par. (f) 50. and the design
11 shall cover the entire plate. Special group plates under par. (f) 61m. shall display a
12 logo or image of the lion associated with the Lions Clubs International. Special group
13 plates under par. (f) 61r. shall display a bar and shield logo associated with
14 Harley-Davidson, Inc., on the left portion of the plates and the words “share the
15 road” on the bottom portion of the plates. Special group plates under par. (f) 63. shall
16 display the words “Trout Unlimited.” Special group plates under par. (f) 65m. shall
17 display the words “Help Cure Childhood Cancer” in purple lettering and a symbol
18 comprised of a purple handprint superimposed upon a red heart superimposed upon
19 a gold ribbon. Special group plates under par. (f) 66. shall display the words
20 “Scouting Alumni” and, at the option of the vehicle owner, either a logo or symbol
21 associated with the Boy Scouts of America or a logo or symbol associated with the
22 Eagle Scouts. Special group plates under par. (f) 67. shall display a logo or symbol
23 associated with Whitetails Unlimited. Special group plates under par. (f) 68. shall
24 display a logo or symbol associated with the Wisconsin Rocky Mountain Elk
25 Foundation. Special group plates under par. (f) 69. shall display the words “Nurses

1 Change Lives” and an image of a heart partially encircled by a stethoscope. The
2 department may not specify any design for the special group plates under par. (f) 70.
3 unless the design is approved by the secretary of natural resources.
4 Notwithstanding par. (e), special group plates under par. (f) 33m. and 48m. shall be
5 the same color and design that was specified by the department for special group
6 plates under par. (f) 33. and 48., respectively, immediately prior to January 1, 2007.
7 The design for special group plates under par. (f) 33. and 48. shall be different from
8 the design of special group plates under par. (f) 33m. and 48m., respectively.”.

9 **6.** Page 3, line 24: after that line insert:

10 “**SECTION 7m. Effective date.**

11 (1) This act takes effect on first day of the 12th month beginning after
12 publication.”.
