**ASSEMBLY AMENDMENT 1,  
TO ASSEMBLY BILL 82**

August 8, 2019 - Offered by Representative BROOKS.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 21, line 22: delete the material beginning with that line and ending  
3 with page 22, line 2, and substitute:

4 “440.996 (1) (intro.) An athlete agent, ~~with the intent to induce a student~~  
5 ~~athlete to enter into an agency contract,~~ may not intentionally do any of the following  
6 or encourage another individual to do or assist another individual in doing any of the  
7 following on behalf of the athlete agent:

8 **SECTION 69c.** 440.996 (1) (a) of the statutes is amended to read:

9 440.996 (1) (a) Give any a student athlete or, if the student athlete is a minor,  
10 a parent or guardian of the student athlete materially false or misleading  
11 information or make a materially false promise or representation with the intent to  
12 influence the student athlete, parent, or guardian to enter into an agency contract.

1           **SECTION 69g.** 440.996 (1) (b) of the statutes is renumbered 440.996 (1) (b)  
2 (intro.) and amended to read:

3           440.996 (1) (b) (intro.) Furnish ~~anything a thing~~ of value to a student athlete  
4 ~~before the student athlete enters into the agency contract.~~ or another individual, if  
5 to do so may result in the loss of the student athlete's eligibility to participate in the  
6 student athlete's sport, unless both of the following apply:

7           **SECTION 69n.** 440.996 (1) (b) 1. of the statutes is created to read:

8           440.996 (1) (b) 1. The athlete agent notifies the athletic director of the  
9 educational institution at which the student athlete is enrolled or at which the  
10 athlete agent has reasonable grounds to believe the student athlete intends to enroll,  
11 not later than 72 hours after furnishing the thing of value.

12           **SECTION 69r.** 440.996 (1) (b) 2. of the statutes is created to read:

13           440.996 (1) (b) 2. The student athlete or, if the student athlete is a minor, the  
14 parent or guardian of the student athlete acknowledges to the athlete agent in a  
15 record that receipt of the thing of value may result in the loss of the student athlete's  
16 eligibility to participate in the student athlete's sport.

17           **SECTION 69w.** 440.996 (1) (c) of the statutes is repealed.”.

18           **2.** Page 22, line 5: delete “any other individual to do” and substitute “another  
19 individual to do or assist another individual in doing”.

20           **3.** Page 22, line 16: delete lines 16 to 20 and substitute:

21           “440.996 (2) (g) Fail to notify a student athlete or, if the student athlete is a  
22 minor, the parent or guardian of the student athlete before the student athlete,  
23 parent, or guardian signs ~~or otherwise authenticates~~ an agency contract for a  
24 particular sport that the signing ~~or authentication~~ may ~~make the student athlete~~

1 ~~ineligible~~ result in the loss of the student athlete's eligibility to participate as a  
2 ~~student athlete in that~~ in the student athlete's sport.".
