**SENATE AMENDMENT 1,  
TO SENATE BILL 137**

May 21, 2019 - Offered by Senator TESTIN.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 2: before “granting” insert “extending the time limit for  
3 emergency rule procedures,”.

4 **2.** Page 3, line 5: after “section.” insert “The department shall, after  
5 subtracting the amount available for distribution to counties under par. (b), reserve  
6 one-third of the remaining moneys for grants to applicants given preference under  
7 sub. (6).”.

8 **3.** Page 3, line 9: after “sub. (4).” insert “A county may contract with other  
9 counties, with well drillers or pump installers licensed through the department of  
10 natural resources under ch. 280, or with plumbers licensed by the department of  
11 safety and professional services under s. 145.06 to provide testing services under this  
12 section and may use moneys received from the department of health services under

1 this section to ensure reimbursement for its costs or those incurred by other entities  
2 with which the county has a contract for testing under this section.”.

3 **4.** Page 3, line 19: delete “Replacement” and substitute “Repair or  
4 replacement”.

5 **5.** Page 3, line 22: delete “contact” and substitute “make a request to”.

6 **6.** Page 3, line 23: delete the material beginning with “If the well owner’s” and  
7 ending with “the following:” on page 4, line 2, and substitute “If the well owner’s  
8 county has chosen to participate in the program under this section, upon a request  
9 from a private well owner, the local health department shall provide a list of entities,  
10 public or private, that are available to complete the testing. The private well owner  
11 may contact any of the available entities on the list provided by the local health  
12 department. An available public or private entity that agrees to do the testing for  
13 the private well owner shall collect the necessary samples and do all of the  
14 following:”.

15 **7.** Page 4, line 4: delete “, as determined by the department of health services”.

16 **8.** Page 4, line 8: delete the material beginning with “by the” and ending with  
17 “health department” on line 9.

18 **9.** Page 4, line 13: delete “local health department” and substitute “entity that  
19 completed the testing”.

20 **10.** Page 4, line 15: delete “by a local health department”.

21 **11.** Page 5, line 3: after “department” insert “of health services”.

22 **12.** Page 5, line 7: after that line insert:

1           “(2) The department of health services may promulgate emergency rules under  
2           s. 227.24 to implement s. 254.25. Notwithstanding s. 227.24 (1) (c) and (2),  
3           emergency rules promulgated under this subsection remain in effect until January  
4           1, 2021, or the date on which permanent rules take effect, whichever is sooner.”.
