SENATE AMENDMENT 1, TO ASSEMBLY BILL 245

June 14, 2023 - Offered by Senator LEMAHIEU.

- 2. Page 13, line 1: delete the material beginning with that line and ending with page 14, line 4.
 - **3.** Page 19, line 23: after "except" insert "as provided under s. 66.0305 (6) or".
 - 4. Page 22, line 13: delete the material beginning with "This subsection" and ending with "(a)." on line 14 and substitute "If the county imposes a tax under s. 77.70 (2) (a) and subsequently repeals the tax, this subsection does not apply after the repeal.".

For such a retirement system, the terms of the system, including, but not limited to, the contribution rates, pension benefit calculation, or factors used to calculate a pension benefit under the system for employees who are part of a bargaining unit composed of public safety employees, shall be the same as those in effect on December 30, 2022.

SECTION 219p. 111.70 (4) (mc) 8. of the statutes is created to read:

111.70 (4) (mc) 8. In any municipality with a retirement system established under chapter 201, laws of 1937, any terms of such a retirement system, including, but not limited to, the costs, payments, contribution rates, pension benefit calculation, or design, including all impacts or effects that any changes made to the retirement system might have upon the wages, hours, or conditions of employment, with any bargaining unit composed of public safety employees or any employees treated as public safety employees under par. (bn)."
