AN ACT to amend 29.09 (9m) (a) 1m., 29.09 (9m) (b) and 29.092 (13m) (a); and to create 29.092 (2) (ky), 29.092 (13m) (am) and 29.1075 (1m) of the statutes; relating to: issuing bonus deer hunting permits to certain landowners and granting rule-making authority.

Analysis by the Legislative Reference Bureau

Under current law, the department of natural resources (DNR) may issue bonus deer hunting permits to residents and nonresidents who hold licenses that authorize the hunting of deer. This allows the holder to kill an additional deer of the sex or type authorized by DNR. Under current law, applicants for these permits must pay a fee for the permit, plus an application processing fee. Under this bill, if DNR determines that the number of bonus deer hunting permits available for a deer management area will exceed the number of applications submitted for the permits, DNR by rule may authorize the issuance of bonus deer hunting permits for free to residents of this state who own at least 100 acres of land that are located in whole or in part in the deer management area.
