



1995 SENATE BILL 195

May 16, 1995 - Introduced by Senators LEEAN, ELLIS and RUDE, by request of Governor Tommy G. Thompson. Referred to Committee on Human Resources, Labor, Tourism, Veterans and Military Affairs.

1 **AN ACT to amend** 20.435 (4) (df); and **to create** 49.193 (1) (f) of the statutes;
2 **relating to:** carrying forward funding for certain employment and training
3 programs.

Analysis by the Legislative Reference Bureau

Under current law, the department of health and social services (DHSS) has an appropriation for employment and training programs, which include the job opportunities and basic skills (JOBS) program and the food stamp employment and training project. Under this appropriation, funds that are not encumbered by December 31 of each year lapse to the general fund on the next January 1 unless transferred to the next calendar year by the joint committee on finance.

This bill allows DHSS to carry forward for a county funds that are committed to the county under a performance-based contract for a specific calendar year and that are earned by the county in that year to the following calendar year, if the carry-forward is approved by the secretary of administration. The funds carried forward do not affect a county's base allocation.

4 **SECTION 1.** 20.435 (4) (df) of the statutes is amended to read:

9 provided in s. 49.193 (1) (f), all funds allocated by the department but not
10 encumbered by December 31 of each year lapse to the general fund on the next
11 January 1 unless transferred to the next calendar year by the joint committee on
12 finance.

13 **SECTION 2.** 49.193 (1) (f) of the statutes is created to read:

14 49.193 (1) (f) The department may carry forward for a county funds that are
15 committed to the county under a performance-based contract for a specific calendar
16 year and that are earned by the county in that year to the following calendar year,
17 if the carry-forward is approved by the secretary of administration. The funds
18 carried forward under this paragraph do not affect a county's base allocation.
