



## 1997 SENATE BILL 69

February 12, 1997 - Introduced by Senators DARLING, HUELSMAN, FARROW, FITZGERALD and ZIEN, cosponsored by Representatives BRANDEMUEHL, NASS, DUFF, AINSWORTH, JENSEN, POWERS, GOETSCH, SERATTI, VRAKAS, HANDRICK, F. LASEE, SKINDRUD and GROTHMAN. Referred to Committee on Labor, Transportation and Financial Institutions.

1     **AN ACT to amend** 111.70 (1) (a) and 120.12 (15); and **to create** 111.70 (4) (o) of  
2             the statutes; **relating to:** making the establishment of the school calendar a  
3             permissive subject of collective bargaining for municipal employers.

### *Analysis by the Legislative Reference Bureau*

Under current law, an employer in a school district is required to bargain collectively in good faith with the majority representative of its employees in a collective bargaining unit concerning the wages, hours and conditions of employment of the employees. Among the subjects that are mandatory subjects of collective bargaining is any school calendaring proposal that is *primarily related to* wages, hours and conditions of employment. *Beloit Ed. Assn. v. WERC*, 73 Wis. 2d 43, 61-62 (1976).

This bill provides that an employer for a school district is not required to bargain collectively with respect to the establishment of the school calendar, but expressly requires a school district to bargain collectively with respect to the *impact* of any school calendar decision on wages, hours and conditions of employment.

***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

**SENATE BILL 69****SECTION 1**

1           **SECTION 1.** 111.70 (1) (a) of the statutes, as affected by 1995 Wisconsin Act 289,  
2 is amended to read:

3           111.70 (1) (a) "Collective bargaining" means the performance of the mutual  
4 obligation of a municipal employer, through its officers and agents, and the  
5 representative of its municipal employes in a collective bargaining unit, to meet and  
6 confer at reasonable times, in good faith, with the intention of reaching an  
7 agreement, or to resolve questions arising under such an agreement, with respect to  
8 wages, hours and conditions of employment, and with respect to a requirement of the  
9 municipal employer for a municipal employe to perform law enforcement and fire  
10 fighting services under s. 61.66, except as provided in sub. (4) (m) ~~and (n)~~ to (o) and  
11 s. 40.81 (3) and except that a municipal employer shall not meet and confer with  
12 respect to any proposal to diminish or abridge the rights guaranteed to municipal  
13 employes under ch. 164. The duty to bargain, however, does not compel either party  
14 to agree to a proposal or require the making of a concession. Collective bargaining  
15 includes the reduction of any agreement reached to a written and signed document.  
16 The municipal employer shall not be required to bargain on subjects reserved to  
17 management and direction of the governmental unit except insofar as the manner  
18 of exercise of such functions affects the wages, hours and conditions of employment  
19 of the municipal employes in a collective bargaining unit. In creating this subchapter  
20 the legislature recognizes that the municipal employer must exercise its powers and  
21 responsibilities to act for the government and good order of the jurisdiction which it  
22 serves, its commercial benefit and the health, safety and welfare of the public to  
23 assure orderly operations and functions within its jurisdiction, subject to those  
24 rights secured to municipal employes by the constitutions of this state and of the  
25 United States and by this subchapter.

**SENATE BILL 69**

1           **SECTION 2.** 111.70 (4) (o) of the statutes is created to read:

2           111.70 (4) (o) *Permissive subjects of collective bargaining.* In a school district,  
3 the municipal employer is not required to bargain collectively with respect to the  
4 establishment of the school calendar. This paragraph shall not be construed to  
5 eliminate a school district's duty to bargain collectively with the recognized or  
6 certified representative of school district employes in a collective bargaining unit  
7 concerning the total number of days of work and the number of those days which are  
8 allocated to different purposes such as days on which school is taught, in-service  
9 days, staff preparation days, convention days, paid holidays and parent-teacher  
10 conference days, and to bargain collectively with that representative with regard to  
11 the impact of the school calendar on wages, hours and conditions of employment.

12           **SECTION 3.** 120.12 (15) of the statutes is amended to read:

13           120.12 (15) SCHOOL HOURS. Establish rules scheduling the hours of a normal  
14 school day. The school board may differentiate between the various elementary and  
15 high school grades in scheduling the school day. The equivalent of 180 such days, as  
16 defined in s. 115.01 (10), shall be held during the school term. ~~This subsection shall~~  
17 ~~not be construed to eliminate a school district's duty to bargain with the employe's~~  
18 ~~collective bargaining representative over any calendaring proposal which is~~  
19 ~~primarily related to wages, hours and conditions of employment.~~

20           **SECTION 4. Initial applicability.**

21           (1) SCHOOL DISTRICTS; PERMISSIVE SUBJECTS OF BARGAINING. The treatment of  
22 section 111.70 (1) (a) and (4) (o) of the statutes applies to collective bargaining  
23 agreements that cover periods of time that initially begin after June 30, 1998.

24           **SECTION 5. Effective date.**
