

## **1999 ASSEMBLY BILL 905**

March 21, 2000 – Introduced by JOINT COMMITTEE ON EMPLOYMENT RELATIONS. Referred to Committee on Rules.

AN ACT relating to: ratification of the agreement negotiated between the state of Wisconsin and the Teaching Assistants' Association, AFT, Local 3220, AFL-CIO, for the 1999-01 biennium, covering employes in the program, project and teaching assistants of the University of Wisconsin-Madison and University of Wisconsin-Extension collective bargaining unit, and authorizing an expenditure of funds.

### Analysis by the Legislative Reference Bureau

This proposal is introduced under section 111.92 (1) of the statutes. The proposal ratifies the collective bargaining contract for state employes in the program, project and teaching assistants of the University of Wisconsin–Madison and University of Wisconsin–Extension collective bargaining unit negotiated for the 1999–01 biennium under the state employment labor relations act. Currently, statutory program supplement appropriations fund the costs of collective bargaining agreements to the extent that they exceed budgeted costs. The proposal authorizes expenditure of moneys from those appropriations to fund the cost of this agreement.

# The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

#### **ASSEMBLY BILL 905**

Agreement ratified. The legislature ratifies the tentative 1 SECTION 1.  $\mathbf{2}$ agreement negotiated for the 1999-01 biennium between the state of Wisconsin. 3 department of employment relations, and the Teaching Assistants' Association, AFT, Local 3220, AFL-CIO, covering employes in the program, project and teaching 4 5 assistants of the University of Wisconsin-Madison and University of 6 Wisconsin-Extension collective bargaining unit under subchapter V of chapter 111 7 of the statutes, as approved by the employes of the program, project and teaching assistants of the University of Wisconsin-Madison and University 8 of 9 Wisconsin-Extension collective bargaining unit and approved and recommended by 10 the joint committee on employment relations, and authorizes the necessary 11 expenditure of moneys for implementation from the appropriations made by section 1220.865 (1) of the statutes, subject to section 20.865 (intro.) of the statutes. The 13secretary of employment relations shall file an official copy of the agreement, 14certified by the cochairpersons of the joint committee on employment relations, with 15the secretary of state. No formal or informal agreement between the parties which 16 is not a part of the official copy is deemed to be approved by the legislature under this 17act.

### SECTION 2. Effective date.

(1) This act takes effect on the day following publication, except that those
provisions specifically identified as having other effective dates in the agreement
covering employes in the program, project and teaching assistants of the University
of Wisconsin-Madison and University of Wisconsin-Extension collective bargaining
unit are effective on the dates provided in that agreement.
