Relating to: commending the University of Wisconsin women's basketball team on 1 $\mathbf{2}$ its recent WNIT tournament appearance and championship. 3 Whereas, the 1999–2000 University of Wisconsin women's basketball team has 4 an excellent recruitment, training and coaching staff, including Head Coach Jane 5 Albright; and 6 Whereas, the University of Wisconsin women's basketball team achieved its 4th 7 20-win season in the past 6 years and subsequently advanced to its 2nd consecutive 8 WNIT championship final with a 78-60 win over Colorado State on Saturday, March 9 25, 2000; and 10 Whereas, the team won the WNIT championship game, on March 29, 2000, over Florida with a final score of 75-74, making it the first postseason title for the 11 12 University of Wisconsin women's basketball team; and 13 Whereas, this is the 3rd straight year a Big Ten team has been a WNIT finalist and the 2nd consecutive year that the University of Wisconsin women's basketball 14

team has participated in the WNIT tournament; and

Whereas, the University of Wisconsin women's basketball team has the 2nd highest RPI statistics and has played the 2nd strongest team schedule (25th); and Whereas, the University of Wisconsin women's basketball team tied its own WNIT record for greatest winning margins with a 37-point victory over Fairfield and held its WNIT opponents to .349 percent from the floor, while hitting .461 percent; now, therefore, be it
