Relating to: the life and public service of Senator Henry Dorman. 2 Whereas, Henry Dorman was born on September 24, 1916, in Racine, and died 3 on November 9, 1998, in Racine; and 4 Whereas, Mr. Dorman graduated from William Horlick High School in Racine, received a Ph.B. in American Institutions from the University of Wisconsin-Madison 5 6 in 1940, and earned a law degree from the University of Wisconsin-Madison in 1947; 7 and 8 Whereas, during World War II, he attended Officer Candidate School at Yale 9 University in 1943 and served in the U.S. Army Air Corps as a communications 10 officer; and 11 Whereas, Mr. Dorman practiced law in Racine from 1947 until his retirement 12 in 1991; and Whereas, he was a member of various legal committees and assisted in the 13

creation of legal aid offices in the Racine County courthouse; and
