

State of Misconsin 2005 - 2006 LEGISLATURE

2005 ASSEMBLY BILL 1230

July 12, 2006 – Introduced by JOINT COMMITTEE ON EMPLOYMENT RELATIONS.

1 AN ACT relating to: ratification of the agreement negotiated between the state 2 of Wisconsin and the Wisconsin Professional Employees Council, WFT/AFT, 3 AFL-CIO, for the 2005-07 biennium, covering employees in the professional 4 fiscal and staff services collective bargaining unit, and authorizing an 5 expenditure of funds.

Analysis by the Legislative Reference Bureau

This proposal is introduced under section 111.92 (1) of the statutes. The proposal ratifies the collective bargaining contract for state employees in the professional fiscal and staff services collective bargaining unit negotiated for the 2005–07 biennium under the State Employment Labor Relations Act. Currently, statutory program supplement appropriations fund the costs of collective bargaining agreements to the extent that they exceed budgeted costs. The proposal authorizes expenditure of moneys from those appropriations to fund the cost of this agreement.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

ASSEMBLY BILL 1230

SECTION 1. Agreement ratified. The legislature ratifies the tentative 1 agreement negotiated for the 2005-07 biennium between the state of Wisconsin. the $\mathbf{2}$ 3 office of state employment relations, and the Wisconsin Professional Employees 4 Council, WFT/AFT, AFL-CIO, covering employees in the professional fiscal and staff services collective bargaining unit under subchapter V of chapter 111 of the statutes, $\mathbf{5}$ 6 as approved by the employees of the professional fiscal and staff services collective 7 bargaining unit and approved and recommended by the joint committee on 8 employment relations, and authorizes the necessary expenditure of moneys for 9 implementation from the appropriations made by section 20.865 (1) of the statutes. subject to section 20.865 (intro.) of the statutes. The director of the office of state 10 11 employment relations shall file an official copy of the agreement, certified by the 12cochairpersons of the joint committee on employment relations, with the secretary of state. No formal or informal agreement between the parties that is not a part of 1314 the official copy is deemed to be approved by the legislature under this act.

SECTION 2. Effective date.

(1) This act takes effect on the day following publication, except that those
provisions specifically identified as having other effective dates in the agreement
covering employees in the professional fiscal and staff services collective bargaining
unit are effective on the dates provided in that agreement.
