2005 SENATE BILL 414

November 1, 2005 – Introduced by Senators ZIEN, DARLING, A. LASEE, HANSEN, LEIBHAM, CARPENTER, ROESSLER, BRESKE and DECKER, cosponsored by Representatives MOULTON, SUDER, GRONEMUS, HAHN, LOTHIAN, OTT, HINES, GUNDERSON, MCCORMICK, MONTGOMERY, KREIBICH, NELSON, VOS, TURNER, DAVIS, KRAWCZYK, FRISKE, VAN ROY, HONADEL, LEHMAN and KERKMAN. Referred to Committee on Veterans, Homeland Security, Military Affairs, Small Business and Government Reform.

1 AN ACT to amend 36.27 (3m) (b) 1. and 2. and 38.24 (5) (b) 1. and 2. of the statutes;

2 relating to: fee remission for children and surviving spouses of ambulance

- 3 drivers, correctional officers, emergency medical services technicians, fire
- 4 fighters, and law enforcement officers.

Analysis by the Legislative Reference Bureau

Current law grants a full remission of fees to a resident undergraduate student registered at the University of Wisconsin System or at a technical college who is the child or surviving spouse of an ambulance driver, correctional officer, emergency medical services technician, fire fighter, or law enforcement officer who was killed in the line of duty in Wisconsin. Current law also grants "duty" disability benefits to a participant in the Wisconsin Retirement System, the Employees' Retirement System of the city of Milwaukee, or the Milwaukee County Employee's Retirement System who develops a permanent work-related disability (qualifying disability) that forces the employee to retire or to reduce his work assignment.

This bill extends this fee remission to the child or surviving spouse of an ambulance driver, correctional officer, emergency medical services technician, fire fighter, or law enforcement officer who was a participant in one of the three retirement systems, qualified for duty disability benefits, and later died from the qualifying disability.
