### **2007 SENATE BILL 199**

June 1, 2007 – Introduced by Senator Taylor, cosponsored by Representatives Bies and Albers, by request of Director of State Courts. Referred to Committee on Judiciary and Corrections.

AN ACT to amend 753.06 (5) (b), 753.06 (6) (c), 753.06 (6) (e), 753.06 (7) (h), 753.06 (10) (am), 753.06 (10) (d) and 753.06 (10) (k) of the statutes; relating to: adding a circuit court branch in Barron, Chippewa, Dodge, Green, Juneau, Monroe, and St. Croix counties.

### Analysis by the Legislative Reference Bureau

This bill adds one additional circuit court branch for Barron, Chippewa, Dodge, Green, Juneau, and St. Croix counties on August 1, 2008, and one additional circuit court branch for Monroe County on August 1, 2010.

(10) The authorized FTE positions for the circuit courts are increased by 1.0
GPR circuit judge position on August 1, 2010, to be funded from the appropriation
under section 20.625 (1) (a) of the statutes, to provide one circuit court judge for the

(11) The authorized FTE positions for the circuit courts are increased by 1.0 GPR court reporter position on August 1, 2010, to be funded from the appropriation under section 20.625 (1) (a) of the statutes, to provide one court reporter for the Monroe County circuit court branch created by this act.
