AN ACT to create 20.435 (2) (km), 20.505 (8) (hm) 25. and 51.606 of the statutes;

relating to: reimbursement of counties and Indian tribes for unexpected or

unusually high-cost placement of Indians in mental health treatment facilities

and making an appropriation.

Analysis by the Legislative Reference Bureau

This bill appropriates \$500,000 in Indian gaming receipts to the Department of Health Services in the 2009–11 fiscal biennium to reimburse tribes and county departments of human services or social services for unexpected or unusually high-cost placements of Indian tribe members in a mental health institute.
