



2009 SENATE BILL 714

December 15, 2010 – Introduced by JOINT COMMITTEE ON EMPLOYMENT RELATIONS.
Referred to Committee on Senate Organization.

1 **AN ACT relating to:** ratification of the agreement negotiated between the state
2 of Wisconsin and the Milwaukee Graduate Assistants Association,
3 AFT-Wisconsin, Local 2169, AFL-CIO, for the 2009-11 biennium, covering
4 employees in the program, project, and teaching assistants of the University of
5 Wisconsin-Milwaukee collective bargaining unit, and authorizing an
6 expenditure of funds.

Analysis by the Legislative Reference Bureau

This proposal is introduced under section 111.92 (1) of the statutes. The proposal ratifies the collective bargaining contract for state employees in the program, project, and teaching assistants of the University of Wisconsin-Milwaukee collective bargaining unit negotiated for the 2009-11 biennium under the State Employment Labor Relations Act. Currently, statutory program supplement appropriations fund the costs of collective bargaining agreements to the extent that they exceed budgeted costs. The proposal authorizes expenditure of moneys from those appropriations to fund the cost of this agreement.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

1 **SECTION 1. Agreement ratified.** The legislature ratifies the tentative
2 agreement negotiated for the 2009–11 biennium between the state of Wisconsin, the
3 office of state employment relations, and the Milwaukee Graduate Assistants
4 Association, AFT–Wisconsin, Local 2169, AFL–CIO, covering employees in the
5 program, project, and teaching assistants of the University of Wisconsin–Milwaukee
6 collective bargaining unit under subchapter V of chapter 111 of the statutes, as
7 approved by the employees of the program, project, and teaching assistants of the
8 University of Wisconsin–Milwaukee collective bargaining unit and approved and
9 recommended by the joint committee on employment relations, and authorizes the
10 necessary expenditure of moneys for implementation from the appropriations made
11 by section 20.865 (1) of the statutes, subject to section 20.865 (intro.) of the statutes.
12 The director of the office of state employment relations shall file an official copy of
13 the agreement, certified by the cochairpersons of the joint committee on employment
14 relations, with the secretary of state. No formal or informal agreement between the
15 parties that is not a part of the official copy is deemed to be approved by the
16 legislature under this act.

17 **SECTION 2. Effective date.**

18 (1) This act takes effect on the day following publication, except that those
19 provisions specifically identified as having other effective dates in the agreement
20 covering employees in the program, project, and teaching assistants of the

1 University of Wisconsin-Milwaukee collective bargaining unit are effective on the
2 dates provided in that agreement.
