1	Relating to: commending Michael R. Lovell as Chancellor of the University of
2	Wisconsin-Milwaukee.
3	Whereas, Michael R. Lovell, Ph.D., was confirmed as Chancellor of the
4	University of Wisconsin–Milwaukee by the University of Wisconsin System Board
5	of Regents on May 2, 2011; and
6	Whereas, since his arrival on the University of Wisconsin–Milwaukee campus,
7	Chancellor Lovell has been named a State of Wisconsin Distinguished Professor, a
8	designation by the University of Wisconsin System that recognizes and supports
9	professorships in areas of vital or emerging significance to the state; and
10	Whereas, one of Chancellor Lovell's most significant accomplishments since
11	joining the University of Wisconsin-Milwaukee includes helping to create the
12	Wisconsin Energy Research Consortium, a historic partnership among University of
13	Wisconsin-Milwaukee, Marquette University, Milwaukee School of Engineering,
14	University of Wisconsin–Madison, and regional power and energy industries; and

1	Whereas, as dean of the University of Wisconsin-Milwaukee College of
2	Engineering and Applied Science from 2008 to 2010, Chancellor Lovell guided the
3	college to a 250 percent increase in research expenditures and nearly a 350 percent
4	increase in philanthropic support; and
5	Whereas, Chancellor Lovell celebrated his inauguration as the eighth
6	chancellor in the history of University of Wisconsin–Milwaukee on October 14, 2011;

8	Whereas, through his hard work and dedication, Chancellor Lovell will guide
9	the University of Wisconsin–Milwaukee to new heights and focus the faculty, staff,
10	and students to make a difference through their teaching and research on the
11	challenges facing our region, state, nation, and world; now, therefore, be it

13	legislature commends Chancellor Michael Lovell as he begins his new assignment
14	and wishes him continued success in teaching our new state leaders in how to serve
