## 2011 ASSEMBLY RESOLUTION 22

March 6, 2012 - Introduced by Committee on Rules.

- 1 **Relating to:** establishing special orders of business for Tuesday, March 13, 2012.
- 2 Resolved by the assembly, That:

    - (2) At 11:02 a.m., 2011 Assembly Bill 154, or 2011 Senate Bill 92, if it is in the Assembly, relating to: prohibiting coverage of abortions through health plans sold through exchanges.
