2013 ASSEMBLY JOINT RESOLUTION 99

February 18, 2014 – Introduced by Representative MURPHY, cosponsored by Senator Ellis. Referred to Committee on Rules.

1	Relating to: the life and community service of Joyce A. Bytof of Appleton, Wisconsin.
2	Whereas, Joyce Bytof came to the Fox Valley in the late 1950s and became an
3	invaluable leader in the community; and
4	Whereas, Joyce worked for the Times Mirror in 1953, now the Los Angeles
5	<i>Times</i> , where she worked in advertising, and she received her real estate license in
6	1964, and then attained the Council of Real Estate Brokerage designation; and
7	Whereas, in 1975 Joyce joined Bytof Realtors, Inc., in Appleton, and in 1988 she
8	became president and chief executive officer of Coldwell Banker The Real Estate
9	Group, Inc., the company founded by her husband, Otto, which now employs more
10	than 500 realtors across northeastern Wisconsin; and
11	Whereas, Joyce served as the president of the Northeast Wisconsin Realtors
12	Association in 1985–86, was appointed to the Wisconsin Realtors Association Board
13	of Directors in 1983, serving as president from 1995–97, and was named to the
14	National Realtors Association Board of Directors in 2003; and

1	Whereas, Joyce received many honors for her outstanding contributions to the
2	real estate industry, including the 1985 Wisconsin Realtor of the Year Award, the
3	1990 Fox Cities Chamber of Commerce Athena Business Woman of the Year Award,
4	the 1997 Small Business Person of the Year Award, and the 2001 Volunteer Business
5	of the Year Award; and
6	Whereas, Joyce lead multiple committees and community projects in the Fox
7	Valley Area, including, but not limited to, her company's nonprofit organization,
8	TREG Foundation, Inc.; the YMCA of the Fox Cities Corporate Board; the United
9	Way Board; the Community Foundation Board; the Goodwill Board; the Chamber of
10	Commerce Board; the Big Brothers-Big Sisters Board; and Habitat for Humanity;
11	and in 1993 she was elected the first woman chair of the Fox Cities Chamber of
12	Commerce; and
13	Whereas, Joyce was a lifetime member of the Girl Scouts and served on the
14	Board of Directors of Girl Scouts of the Fox River Area, the President's Council of
15	Junior Achievement, the Senior Advisory Board, the Make–A–Wish Board, and the
16	Children's Hospital Board; and
17	Whereas, Joyce served as a member of the University of Wisconsin Curriculum
18	Council and president of the University of Wisconsin Foundation; and
19	Whereas, Joyce was a tireless worker and an inspiration to the entire Fox Cities
20	community and the state of Wisconsin for more than 50 years; now, therefore, be it
21	Resolved by the assembly, the senate concurring, That the members of the
22	Wisconsin legislature honor the exemplary life of Joyce A. Bytof for her outstanding
