2015 SENATE BILL 420

December 3, 2015 – Introduced by Senators L. TAYLOR and STROEBEL, cosponsored by Representatives SANFELIPPO, RODRIGUEZ, ALLEN, BERNIER, HUTTON, MURPHY, ROHRKASTE, SINICKI, SKOWRONSKI and YOUNG. Referred to Committee on Education.

1 **AN ACT to create** 20.255 (2) (er) and 115.28 (63) of the statutes; **relating to:**
2 grants to the Institute for the Transformation of Learning at Marquette
3 University to conduct a summer reading improvement program in Milwaukee
4 and making appropriations.

Analysis by the Legislative Reference Bureau

This bill requires the Department of Public Instruction to award a grant to the Institute for the Transformation of Learning at Marquette University to conduct a summer reading program in the summers following the 2015–16 and 2016–17 school years.

10 115.28 (63) SUMMER READING IMPROVEMENT PROGRAM. (a) Submit a request to
11 supplement the appropriation under s. 20.255 (2) (er) with the funds that are held
12 in the appropriation account under s. 20.865 (4) (a) for the purpose described in par.
13 (b), to the joint committee on finance for consideration by the committee at its next
14 quarterly meeting under s. 13.10. Upon approval of the state superintendent's
15 request under this paragraph, the joint committee on finance shall release the funds.

16 (b) Distribute the amount appropriated under s. 20.255 (2) (er) to the Institute
17 for the Transformation of Learning at Marquette University to conduct a reading
18 improvement program during the summers following the 2015-16 and 2016-17

20 (c) Require the Institute for the Transformation of Learning at Marquette
21 University to prepare a report at the conclusion of each year, to submit the report to
22 the joint committee on finance, the department, and the appropriate standing
23 committee in each house of the legislature under s. 13.172 (3), and to post the report

1 Marquette University shall include in the report the number of pupils who
2 participated in the summer reading program and a discussion of the results achieved
3 through the program.

4 **SECTION 4. Fiscal changes.**

5 (1) In the schedule under section 20.005 (3) of the statutes for the appropriation
6 to the joint committee on finance under section 20.865 (4) (a) of the statutes, as
7 affected by the acts of 2015, the dollar amount for fiscal year 2015-16 is increased
8 by \$375,000 for the purpose of funding a summer reading improvement program
9 under section 115.28 (63) of the statutes. In the schedule under section 20.005 (3)
10 of the statutes for the appropriation to the joint committee on finance under section
11 20.865 (4) (a) of the statutes, as affected by the acts of 2015, the dollar amount for
12 fiscal year 2016-17 is increased by \$750,000 for the purpose of funding a summer
13 reading improvement program under section 115.28 (63) of the statutes.
