## 2017 ASSEMBLY BILL 510

September 25, 2017 – Introduced by Representatives JACQUE, QUINN, KREMER, KUGLITSCH, TITTL, GENRICH and GOYKE, cosponsored by Senators LASEE and HANSEN. Referred to Committee on Education.

1 AN ACT to amend 119.04 (1); and to create 120.12 (6m) of the statutes; relating

to: notification of certain construction activities in school buildings.

## Analysis by the Legislative Reference Bureau

This bill requires the school board of a school district to notify certain interested parties, including members of the community, prior to commencing a construction project. The notice requirement applies to a construction project with an estimated cost of \$10,000 or greater that will occur in a school building in which pupils, teachers, and administrators will be present. With certain exceptions, the school board must provide notice at least two months prior to the start date. Notice may be provided by mail, by publication in a newspaper likely to give notice to interested persons, or at a public hearing. Notice to parents and guardians of pupils and others who are assigned to the school building may be provided by e-mail or through a letter sent home with the interested party.

**SECTION 2.** 120.12 (6m) of the statutes is created to read:

13120.12 (**6m**) NOTIFICATION OF CONSTRUCTION ACTIVITIES. Establish (a) 14procedures, consistent with the requirements under par. (b), for notifying parents 15and guardians of pupils enrolled in a school of the school district, teachers, 16 administrators, and other employees of the school district who are assigned to the 17school, and members of the community about a construction project in a school 18 building, other than a construction project undertaken in response to an emergency 19 in the school building involving the health, safety, or welfare of the public, that 20satisfies the following conditions before commencing the construction project:

1. The construction project will occur during the school term or during the summer session while pupils are enrolled in classes in the school building.

2. The estimated cost of the construction project exceeds \$10,000.

(b) Ensure that for each construction project described under par. (a), the notice
complies with the following:

1. a. Except as provided in subd. 1. b., the notice is provided at least 2 months
 prior to the date on which the construction project is scheduled to begin.

b. For an emergency in a school building involving the health, safety, or welfare
of the public, the notice is provided as far in advance of the construction project as
possible.

6 2. The notice includes information about the school board's obligation under 7 sub. (5) to keep the school buildings and grounds in good repair, suitably equipped, 8 and in safe and sanitary condition at all times. The school board shall include under 9 this subdivision information about the measures the school board will take to 10 mitigate any health risks to individuals present in the school building during the 11 construction project.

12 3. The notice is posted on the school district's Internet site, mailed directly to 13 the interested parties described under par. (a), provided at a public hearing, or 14 published as a class 1 notice under ch. 985. Notice to the parents or guardians of 15 pupils enrolled in the school and to those individuals who are assigned to the school 16 building may be provided by electronic mail or through a note sent home with the 17 pupil or individual.
