## 2017 SENATE BILL 283

June 2, 2017 – Introduced by Senators L. TAYLOR, WIRCH, RISSER and VINEHOUT, cosponsored by Representatives KESSLER, C. TAYLOR, BERCEAU and BROSTOFF. Referred to Committee on Government Operations, Technology and Consumer Protection.

1 AN ACT *to amend* 977.08 (4m) (c); and *to create* 977.08 (4m) (d) of the statutes; 2 **relating to:** increasing the rate paid to private attorneys for representing 3 indigent clients.

### Analysis by the Legislative Reference Bureau

Under current law, the state public defender provides legal representation for indigent persons in criminal, delinquency, and certain related cases. The SPD assigns cases either to staff attorneys or to local private attorneys. Generally, a private attorney who is assigned a case by the SPD is paid \$40 per hour for time spent related to the case. This bill increases to \$100 per hour the amount a private attorney is paid for time spent related to the case.
