2017 SENATE BILL 70

February 21, 2017 - Introduced by Senators C. LARSON, JOHNSON, CARPENTER, WIRCH and VINEHOUT, cosponsored by Representatives GOYKE, KREMER, BOWEN, MILROY, KOLSTE, POPE, SINICKI, ANDERSON, FIELDS, MASON, GENRICH, SPREITZER, SARGENT, ZEPNICK, WACHS, CONSIDINE, HESSELBEIN, BILLINGS, C. TAYLOR, SUBECK, KESSLER, HINTZ, BERCEAU, OHNSTAD, CROWLEY, RIEMER, BROSTOFF and ZAMARRIPA. Referred to Committee on Judiciary and Public Safety.

1 **AN ACT relating to:** creation of a committee to study the model used by the state
2 of Missouri to provide rehabilitation for juveniles adjudicated delinquent who
3 are in need of restrictive custodial treatment and to prepare a plan for the
4 development and implementation of a similar model for the rehabilitation of
5 such juveniles in this state.

Analysis by the Legislative Reference Bureau

This bill requires the secretary of corrections to create a committee to study the model used by the state of Missouri to provide rehabilitation for juveniles adjudicated delinquent who are in need of restrictive custodial treatment and to prepare a plan for the development and implementation of a similar model for the rehabilitation of such juveniles in this state. The study must include recommendations for the establishment of smaller juvenile correctional facilities distributed throughout all geographical areas of the state for the placement of juveniles adjudicated delinquent who are in need of restrictive custodial treatment and of policies that would provide for the placement of such juveniles in facilities closer to their homes, while maintaining the current system of funding those placements.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SENATE BILL 70**SECTION 1****1 SECTION 1. Nonstatutory provisions.**

2 (1) STUDY OF MISSOURI JUVENILE JUSTICE MODEL. By June 30, 2018, the secretary
3 of corrections shall create a committee under section 15.04 (1) (c) of the statutes to
4 study the model used by the state of Missouri to provide rehabilitation for juveniles
5 adjudicated delinquent who are in need of restrictive custodial treatment and to
6 prepare a plan for the development and implementation of a similar model for the
7 rehabilitation of such juveniles in this state. The study shall include
8 recommendations for the establishment of smaller juvenile correctional facilities
9 distributed throughout all geographical areas of the state for the placement of
10 juveniles adjudicated delinquent who are in need of restrictive custodial treatment
11 and of policies that would provide for the placement of such juveniles in facilities
12 closer to their homes, while maintaining the current system of funding those
13 placements through assessments on counties for the costs of those placements under
14 section 301.26 (4) of the statutes. By December 31, 2018, the committee shall submit
15 its findings, conclusions, and recommendations, including any proposed legislation
16 that is necessary to implement those recommendations, to the governor, the
17 secretary of corrections, the cochairpersons of the joint committee on finance, and the
18 appropriate standing committees of the legislature in the manner provided under
19 section 13.172 (3) of the statutes, after which the committee shall terminate its
20 activities and cease to exist.
