## 2019 SENATE BILL 347

August 14, 2019 – Introduced by Senators PETROWSKI, CARPENTER, LARSON, RISSER and SCHACHTNER, cosponsored by Representatives SPIROS, SARGENT, ANDERSON, BOWEN, CABRERA, CROWLEY, DOYLE, MILROY, MURSAU, OHNSTAD, QUINN, SINICKI, SKOWRONSKI, SPREITZER, C. TAYLOR, TUSLER, VINING and ZIMMERMAN. Referred to Committee on Education.

1 AN ACT to create 115.28 (44), 118.018 and 121.02 (1) (L) 1m. of the statutes;

relating to: requiring sexual abuse prevention education.

#### Analysis by the Legislative Reference Bureau

This bill requires the Department of Public Instruction to develop, by July 1, 2020, a child sexual abuse prevention policy and instructional program to be provided to pupils in grades kindergarten to six. DPI must include in the program an age-appropriate curriculum to provide pupils with the knowledge and tools to escape from a sexual abuse situation and communicate incidents of sexual abuse. Under the bill, beginning in the 2021-22 school year, each school board must provide a child sexual abuse prevention instructional program to pupils in grades kindergarten to six. Each school board must adopt and administer either DPI's program or its own child sexual abuse prevention instructional program.

**SECTION 1.** 115.28 (44) of the statutes is created to read:

**SECTION 2.** 118.018 of the statutes is created to read:

9 118.018 Sexual abuse prevention education. (1) Beginning in the 10 2021-22 school year, each school board shall provide a child sexual abuse prevention instructional program to pupils in kindergarten to grade 6. The school board shall 11 12either adopt and administer the policy and instructional program under s. 115.28 13(44), or develop and administer its own child sexual abuse prevention instructional 14program.

(2) The school board shall include all of the following in the instructional 16 program under sub. (1):

17(a) Developmentally appropriate, culturally sensitive, and evidence-based 18 instruction for each grade level.

19 (b) Age-appropriate curriculum that includes role-playing, discussion, 20activities, and books to educate students regarding child sexual abuse prevention.

21(c) Instruction providing students with the knowledge and tools to 22communicate incidents of sexual abuse.

23(d) Instruction on how to distinguish between a safe touch and an unsafe touch  $\mathbf{24}$ and between safe secrets and unsafe secrets.
