## 2021 ASSEMBLY BILL 957

February 3, 2022 – Introduced by Representatives ZIMMERMAN, ARMSTRONG, DITTRICH, DUCHOW, HORLACHER, KNODL, KUGLITSCH, KURTZ, MACCO, MAGNAFICI, MOSES, MURPHY, PENTERMAN, PLUMER, PRONSCHINSKE, SORTWELL, STEFFEN, SUBECK, TAUCHEN, THIESFELDT, TITTL and WITTKE, cosponsored by Senators KOOYENGA, BALLWEG, FEYEN and NASS. Referred to Committee on Consumer Protection.

1 AN ACT to create 134.985 of the statutes; relating to: consumer data protection

and providing a penalty.

#### Analysis by the Legislative Reference Bureau

This bill establishes requirements for controllers and processors of the personal data of consumers. The bill defines a "controller" as a person that, alone or jointly with others, determines the purpose and means of processing personal data, and the bill applies to controllers that control or process the personal data of at least 100,000 consumers or that control or process the personal data of at least 25,000 consumers and derive over 50 percent of their gross revenue from the sale of personal data. Under the bill, "personal data" means any information that is linked or reasonably linkable to an individual except for publicly available information.

The bill provides consumers with the following rights regarding their personal data: 1) to confirm whether a controller is processing the consumer's personal data and to access the personal data; 2) to correct inaccuracies in the consumer's personal data; 3) to require a controller to delete personal data provided by or about the consumer; 4) to obtain a copy of the personal data that the consumer previously provided to the controller; and 5) to opt out of the processing of the consumer's personal data; and certain forms of automated processing of the consumer's personal data. These rights are subject to certain exceptions specified in the bill. Controllers may not discriminate against a consumer for exercising rights under the bill, including by charging different prices for goods or providing a different level of quality of goods or services.

The bill requires controllers to respond to consumers' requests to invoke rights under the bill without undue delay. If a controller declines to take action regarding a consumer's request, the controller must inform the consumer of its justification without undue delay. The bill also requires that information provided in response to a consumer's request be provided free of charge up to twice annually per consumer. Controllers must also establish processes for consumers to appeal a refusal to take action on a consumer's request. Within 60 days of receiving an appeal, a controller must inform the consumer in writing of any action taken or not taken in response to the appeal, including a written explanation of the reasons for its decisions. If the appeal is denied, the controller must provide the consumer with a method through which the consumer can contact the attorney general to submit a complaint.

Under the bill, a controller must provide consumers with a privacy notice that discloses the categories of personal data processed by the controller; the purpose of processing the personal data; the categories of third parties, if any, with whom the controller shares personal data; the categories of personal data that the controller shares with third parties; and information about how consumers may exercise their rights under the bill. Controllers may not collect or process personal data for purposes that are not relevant to or reasonably necessary for the purposes disclosed in the privacy notice. The bill's requirements do not restrict a controller's ability to collect, use, or retain data for conducting internal research, effectuating a product recall, identifying and repairing technical errors, or performing internal operations that are reasonably aligned with consumer expectations or reasonably anticipated on the basis of a consumer's relationship with the controller.

Persons that process personal data on behalf of a controller must adhere to a contract between the controller and the processor, and such contracts must satisfy certain requirements specified in the bill. The bill also requires controllers to conduct data protection assessments related to certain activities, including processing personal data for targeted advertising, selling personal data, processing personal data for profiling purposes, and processing sensitive data, as defined in the bill. The attorney general may request that a controller disclose a data protection assessment that is relevant to an investigation being conducted by the attorney general.

The attorney general has exclusive authority to enforce violations of the bill's requirements. A controller or processor that violates the bill's requirements is subject to a forfeiture of up to \$7,500 per violation, and the attorney general may recover reasonable investigation and litigation expenses incurred. Before bringing an action to enforce the bill's requirements, the attorney general must first provide a controller or processor with a written notice identifying the violations. If within 30 days of receiving the notice the controller or processor cures the violation and provides the attorney general with an express written statement that the violation is cured and that no further violations will occur, then the attorney general may not bring an action against the controller or processor. The bill also prohibits cities, villages, towns, and counties from enacting or enforcing ordinances that regulate the collection, processing, or sale of personal data.

**SECTION 1.** 134.985 of the statutes is created to read:

**134.985 Consumer data protection. (1)** DEFINITIONS. In this section:

(a) "Affiliate" means a legal entity that controls, is controlled by, or is under
common control with another legal entity or shares common branding with another
legal entity. For the purposes of this definition, "control" or "controlled" means
ownership of, or the power to vote, more than 50 percent of the outstanding shares
of any class of voting security of a company; control in any manner over the election
of a majority of the directors or of individuals exercising similar functions; or the
power to exercise controlling influence over the management of a company.

10 (b) "Authenticate" means verifying through reasonable means that the 11 consumer, entitled to exercise his or her consumer rights under sub. (2), is the same 12 consumer exercising such consumer rights with respect to the personal data at issue.

(c) "Biometric data" means data generated by automatic measurements of an
individual's biological characteristics, such as a fingerprint, voiceprint, eye retinas,
irises, or other unique biological patterns or characteristics that are used to identify
a specific individual. "Biometric data" does not include a physical or digital
photograph, a video or audio recording or data generated therefrom, or information
collected, used, or stored for health care treatment, payment, or operations under the
federal Health Insurance Portability and Accountability Act of 1996.

(d) "Business associate" has the meaning given in 45 CFR 160.103.

(e) "Child" means an individual younger than 13 years of age.

1	(f) "Consent" means a clear affirmative act signifying a consumer's freely given,
2	specific, informed, and unambiguous agreement to process personal data relating to
3	the consumer. "Consent" may include a written statement, including a statement
4	written by electronic means, or any other unambiguous affirmative action.
5	(g) "Consumer" means an individual who is a resident of this state acting only
6	in an individual or household context. "Consumer" does not include an individual
7	acting in a commercial or employment context.
8	(h) "Controller" means a person that, alone or jointly with others, determines
9	the purpose and means of processing personal data.
10	(i) "Covered entity" has the meaning given in 45 CFR 160.103.
11	(j) "Decisions that produce legal or similarly significant effects concerning a
12	consumer" means a decision made by a controller that results in the provision or
13	denial by the controller of financial and lending services, housing, insurance,
14	education enrollment, criminal justice, employment opportunities, health care
15	services, or access to basic necessities, such as food and water.
16	(k) "Deidentified data" means data that cannot reasonably be linked to an
17	identified or identifiable individual, or a device linked to such person.
18	(L) "Identified or identifiable individual" means a person who can be readily
19	identified, directly or indirectly.
20	(m) "Institution of higher education" has the meaning given in s. 39.32 (1) (a).

(n) "Nonprofit organization" means any corporation organized under ch. 181
or any organization exempt from taxation under section 501 (c) (3), (6), or (12) of the
Internal Revenue Code.

(o) "Personal data" means any information that is linked or reasonably linkable
 to an identified or identifiable individual. "Personal data" does not include
 deidentified data or publicly available information.

(p) "Precise geolocation data" means information derived from technology,
including global positioning system level latitude and longitude coordinates or other
mechanisms, that directly identifies the specific location of an individual with
precision and accuracy within a radius of 1,750 feet. "Precise geolocation data" does
not include the content of communications or any data generated by or connected to
advanced utility metering infrastructure systems or equipment for use by a utility.

(q) "Process" or "processing" means any operation or set of operations
performed, whether by manual or automated means, on personal data or on sets of
personal data, such as the collection, use, storage, disclosure, analysis, deletion, or
modification of personal data.

(r) "Processor" means an individual or person that processes personal data on behalf of a controller.

(s) "Profiling" means any form of automated processing performed on personal
data to evaluate, analyze, or predict personal aspects related to an identified or
identifiable individual's economic situation, health, personal preferences, interests,
reliability, behavior, location, or movements.

(t) "Pseudonymous data" means personal data that cannot be attributed to a
specific individual without the use of additional information, provided that such
additional information is kept separately and is subject to appropriate technical and
organizational measures to ensure that the personal data is not attributed to an
identified or identifiable individual.

1	(u) "Publicly available information" means information that is lawfully made
2	available through federal, state, or local government records, or information that a
3	business has a reasonable basis to believe is lawfully made available to the general
4	public through widely distributed media, by the consumer, or by a person to whom
5	the consumer has disclosed the information, unless the consumer has restricted the
6	information to a specific audience.
7	(v) "Sale of personal data" means the exchange of personal data for monetary
8	consideration by the controller to a 3rd party. "Sale of personal data" does not include
9	any of the following:
10	1. The disclosure of personal data to a processor that processes the personal
11	data on behalf of the controller.
12	2. The disclosure of personal data to a 3rd party for purposes of providing a
13	product or service requested by the consumer.
14	3. The disclosure or transfer of personal data to an affiliate of the controller.
15	4. The disclosure of information that a consumer intentionally made available
16	to the general public via a channel of mass media and did not restrict to a specific
17	audience.
18	5. The disclosure or transfer of personal data to a 3rd party as an asset that is
19	part of a merger, acquisition, bankruptcy, or other transaction in which the 3rd party
20	assumes control of all or part of the controller's assets.
21	(w) "Sensitive data" includes the following:
22	1. Personal data revealing racial or ethnic origin, religious beliefs, mental or
23	physical health diagnosis, sexual orientation, or citizenship or immigration status.
24	2. The processing of genetic or biometric data for the purpose of uniquely
25	identifying an individual.

3. The personal data collected from a known child. 1  $\mathbf{2}$ 4. Precise geolocation data. 3 (x) "Targeted advertising" means displaying advertisements to a consumer 4 where the advertisement is selected based on personal data obtained from that 5consumer's activities over time and across nonaffiliated websites or online applications to predict such consumer's preferences or interests. 6 "Targeted 7 advertising" does not include any of the following: 8 1. Advertisements based on activities within a controller's own websites or 9 online applications. 10 2. Advertisements based on the context of a consumer's current search query, visit to a website, or online application. 11 12 3. (a) A consumer may invoke the 22consumer rights authorized under this subsection at any time by submitting a 23request to a controller specifying the consumer rights the consumer wishes to invoke. 24A known child's parent or legal guardian may invoke such consumer rights on behalf 25of the child regarding processing personal data belonging to the known child. A

controller shall comply with an authenticated consumer request to exercise any of
 the following rights:

3 1. To confirm whether or not a controller is processing the consumer's personal
4 data and to access such personal data.

5 2. To correct inaccuracies in the consumer's personal data, taking into account 6 the nature of the personal data and the purposes of the processing of the consumer's 7 personal data.

8

3. To delete personal data provided by or obtained about the consumer.

9 4. To obtain a copy of the consumer's personal data that the consumer 10 previously provided to the controller in a portable and, to the extent technically 11 feasible, readily usable format that allows the consumer to transmit the data to 12 another controller without hindrance, where the processing is carried out by 13 automated means.

14 5. To opt out of the processing of the personal data for purposes of targeted
15 advertising, the sale of personal data, or profiling in furtherance of decisions that
16 produce legal or similarly significant effects concerning the consumer.

(b) 1. Except as otherwise provided in this section, a controller shall comply
with a request by a consumer to exercise the consumer rights authorized under par.
(a).

20 2. A controller shall respond to a consumer without undue delay, but in all cases 21 within 45 days of receipt of a request submitted under par. (a). The response period 22 may be extended once by 45 additional days when reasonably necessary, taking into 23 account the complexity and number of the consumer's requests, so long as the 24 controller informs the consumer of any such extension within the initial 45-day 25 response period, together with the reason for the extension.

3. If a controller declines to take action regarding a consumer's request, the
 controller shall inform the consumer without undue delay, but in all cases and at the
 latest within 45 days of receipt of the request, of the justification for declining to take
 action and instructions for how to appeal the decision under par. (c).

5 4. Information provided in response to a consumer request shall be provided 6 by a controller free of charge, up to twice annually per consumer. If requests from 7 a consumer are manifestly unfounded, excessive, or repetitive, the controller may 8 charge the consumer a reasonable fee to cover the administrative costs of complying 9 with the request or decline to act on the request. The controller bears the burden of 10 demonstrating the manifestly unfounded, excessive, or repetitive nature of the 11 request.

12 5. If a controller is unable to authenticate the request using commercially 13 reasonable efforts, the controller may not be required to comply with a request to 14 initiate an action under par. (a) and may request that the consumer provide 15 additional information reasonably necessary to authenticate the consumer and the 16 consumer's request.

17A controller shall establish a process for a consumer to appeal the (c) 18 controller's refusal to take action on a request within a reasonable period of time 19 after the consumer's receipt of the decision pursuant to par. (b) 3. The appeal process 20 shall be conspicuously available and similar to the process for submitting requests to initiate action under par. (a). Within 60 days of receipt of an appeal, a controller 2122shall inform the consumer in writing of any action taken or not taken in response to 23the appeal, including a written explanation of the reasons for the decisions. If the 24appeal is denied, the controller shall also provide the consumer with an online

mechanism, if available, or other method through which the consumer may contact

3 (3) DATA CONTROLLER RESPONSIBILITIES; TRANSPARENCY. (a) 1. A controller shall
4 limit the collection of personal data to what is adequate, relevant, and reasonably
5 necessary in relation to the purposes for which such data is processed, as disclosed
6 to the consumer.

2. Except as otherwise provided in this section, a controller may not process
personal data for purposes that are not reasonably necessary to and not compatible
with the disclosed purposes for which such personal data is processed, as disclosed
to the consumer, unless the controller obtains the consumer's consent.

11 3. A controller shall establish, implement, and maintain reasonable 12 administrative, technical, and physical data security practices to protect the 13 confidentiality, integrity, and accessibility of personal data. Such data security 14 practices shall be appropriate to the volume and nature of the personal data at issue.

154. A controller may not process personal data in violation of state and federal laws that prohibit unlawful discrimination against consumers. A controller may not 16 17discriminate against a consumer for exercising any of the consumer rights contained in this section, including denying goods or services, charging different prices or rates 18 19 for goods or services, or providing a different level of quality of goods and services to 20the consumer. Nothing in this subdivision shall be construed to require a controller 21to provide a product or service that requires the personal data of a consumer that the 22controller does not collect or maintain, or to prohibit a controller from offering a 23different price, rate, level, quality, or selection of goods or services to a consumer,  $\mathbf{24}$ including offering goods or services for no fee, if the consumer has exercised his or 25her right to opt out under sub. (2) (a) 5. or the offer is related to a consumer's

voluntary participation in a bona fide loyalty, rewards, premium features, discounts,
 or club card program.

5. A controller may not process sensitive data concerning a consumer without obtaining the consumer's consent, or, in the case of the processing of sensitive data concerning a known child, without processing such data in accordance with the federal Children's Online Privacy Protection Act, 15 USC 6501 et seq.

- 7 (b) Any provision of a contract or agreement that purports to waive or limit
  8 consumer rights under sub. (2) is void and unenforceable.
- 9 (c) A controller shall provide consumers with a reasonably accessible, clear, and
   10 meaningful privacy notice that includes all of the following:
- 11 1. The categories of personal data processed by the controller.
- 12 2. The purpose of processing personal data.
- 13 3. How consumers may exercise their consumer rights under sub. (2), including
  how a consumer may appeal a controller's decision with regard to the consumer's
  request.
- 16 4. The categories of personal data that the controller shares with 3rd parties,17 if any.

18 5. The categories of 3rd parties, if any, with whom the controller shares19 personal data.

(d) If a controller sells personal data to 3rd parties or processes personal data
for targeted advertising, the controller shall clearly and conspicuously disclose such
processing, as well as the manner in which a consumer may exercise the right to opt
out of such processing.

(e) A controller shall establish, and shall describe in a privacy notice, one or
more secure and reliable means for consumers to submit a request to exercise their

consumer rights under this section. Such means shall take into account the ways in which consumers normally interact with the controller, the need for secure and reliable communication of such requests, and the ability of the controller to authenticate the identity of the consumer making the request. Controllers may not require a consumer to create a new account in order to exercise consumer rights under sub. (2) but may require a consumer to use an existing account.

7 (4) RESPONSIBILITY ACCORDING TO ROLE; CONTROLLER AND PROCESSOR. (a) A 8 processor shall adhere to the instructions of a controller and shall assist the 9 controller in meeting its obligations under this section. Such assistance shall include 10 the following:

11 1. Taking into account the nature of processing and the information available 12 to the processor, by appropriate technical and organizational measures, insofar as 13 this is reasonably practicable, to fulfill the controller's obligation to respond to 14 consumer rights requests under sub. (2).

Taking into account the nature of processing and the information available
 to the processor, by assisting the controller in meeting the controller's obligations in
 relation to the security of processing the personal data and in relation to giving notice
 of unauthorized acquisition of personal information under s. 134.98.

19 3. Providing necessary information to enable the controller to conduct and20 document data protection assessments under sub. (5).

(b) A contract between a controller and a processor shall govern the processor's
data processing procedures with respect to processing performed on behalf of the
controller. The contract shall be binding and clearly set forth instructions for
processing data, the nature and purpose of processing, the type of data subject to
processing, the duration of processing, and the rights and obligations of both parties.

- The contract shall also include requirements that the processor shall do all of the
   following:
- 3 1. Ensure that each person processing personal data is subject to a duty of
  4 confidentiality with respect to the data.
- 5 2. At the controller's direction, delete or return all personal data to the 6 controller as requested at the end of the provision of services, unless retention of the 7 personal data is required by law.
- 8 3. Upon the reasonable request of the controller, make available to the 9 controller all information in its possession necessary to demonstrate the processor's 10 compliance with the obligations in this section.
- 11 4. At least one of the following:
- a. Allow, and cooperate with, reasonable assessments by the controller or thecontroller's designated assessor.
- b. Arrange for a qualified and independent assessor to conduct an assessment
  of the processor's policies and technical and organizational measures in support of
  the obligations under this section using an appropriate and accepted control
  standard or framework and assessment procedure for such assessments. The
  processor shall provide a report of such assessment to the controller upon request.
  5. Engage any subcontractor pursuant to a written contract in accordance with
  par. (c) that requires the subcontractor to meet the obligations of the processor with

- (c) Nothing in this section shall be construed to relieve a controller or a
  processor from the liabilities imposed on it by virtue of its role in the processing
  relationship as defined by this section.

1	(d) Determining whether a person is acting as a controller or processor with
2	respect to a specific processing of data is a fact-based determination that depends
3	upon the context in which personal data is to be processed. A processor that
4	continues to adhere to a controller's instructions with respect to a specific processing
5	of personal data remains a processor.
6	(5) DATA PROTECTION ASSESSMENTS. (a) A controller shall conduct and document
7	a data protection assessment of each of the following processing activities involving
8	personal data:
9	1. The processing of personal data for purposes of targeted advertising.
10	2. The sale of personal data.
11	3. The processing of personal data for purposes of profiling, where such
12	profiling presents a reasonably foreseeable risk of any of the following:
13	a. Unfair or deceptive treatment of, or unlawful disparate impact on,
14	consumers.
15	b. Financial, physical, or reputational injury to consumers.
16	c. Physical or other intrusion upon the solitude or seclusion, or the private
17	affairs or concerns, of consumers, where such intrusion would be offensive to a
18	reasonable person.
19	d. Other substantial injury to consumers.
20	4. The processing of sensitive data.
21	5. Any processing activities involving personal data that present a heightened
22	risk of harm to consumers.
23	(b) Data protection assessments conducted under par. (a) shall identify and
24	weigh the benefits that may flow, directly and indirectly, from the processing to the
25	controller, the consumer, other stakeholders, and the public against the potential

risks to the rights of the consumer associated with such processing, as mitigated by safeguards that can be employed by the controller to reduce such risks. The use of deidentified data and the reasonable expectations of consumers, as well as the context of the processing and the relationship between the controller and the consumer whose personal data will be processed, shall be factored into this assessment by the controller.

7 (c) The attorney general may request, pursuant to a civil investigative demand 8 issued under sub. (10) (a), that a controller disclose any data protection assessment 9 that is relevant to an investigation conducted by the attorney general, and the 10 controller shall make the data protection assessment available to the attorney 11 general. The attorney general may evaluate the data protection assessment for 12compliance with the responsibilities set forth in sub. (3). Data protection 13assessments shall be confidential and not subject to the right of inspection and 14copying under s. 19.35 (1). The disclosure of a data protection assessment pursuant 15to a request from the attorney general shall not constitute a waiver of attorney-client 16 privilege or work product protection with respect to the assessment and any 17information contained in the assessment.

- 18 (d) A single data protection assessment may address a comparable set of19 processing operations that include similar activities.

(e) Data protection assessments conducted by a controller for the purpose of compliance with other laws or regulations may comply under this section if the assessments have a reasonably comparable scope and effect.

(f) Data protection assessment requirements shall apply to processing
activities created or generated after January 1, 2024, and are not retroactive.

1	(6) PROCESSING DEIDENTIFIED DATA; EXEMPTIONS. (a) A controller in possession
2	of deidentified data shall do all of the following:
3	1. Take reasonable measures to ensure that the data cannot be associated with
4	an individual.
5	2. Publicly commit to maintaining and using deidentified data without
6	attempting to reidentify the data.
7	3. Contractually obligate any recipients of the deidentified data to comply with
8	all provisions of this section.
9	(b) Nothing in this section shall be construed to require a controller or processor
10	to reidentify deidentified data or pseudonymous data; maintain data in identifiable
11	form; or collect, obtain, retain, or access any data or technology, in order to be capable
12	of associating an authenticated consumer request with personal data.
13	(c) Nothing in this section shall be construed to require a controller or processor
14	to comply with an authenticated consumer rights request under sub. (2) if all of the
15	following apply:
16	1. The controller is not reasonably capable of associating the request with the
17	personal data or it would be unreasonably burdensome for the controller to associate
18	the request with the personal data.
19	2. The controller does not use the personal data to recognize or respond to the
20	specific consumer who is the subject of the personal data, or associate the personal
21	data with other personal data about the same specific consumer.
22	3. The controller does not sell the personal data to any 3rd party or otherwise
23	voluntarily disclose the personal data to any 3rd party other than a processor, except
24	as otherwise permitted in this subsection.

1 (d) The consumer rights contained in subs. (2) (a) 1. to 4. and (3) shall not apply 2 to pseudonymous data in cases where the controller is able to demonstrate any 3 information necessary to identify the consumer is kept separately and is subject to 4 effective technical and organizational controls that prevent the controller from 5 accessing such information.

6 (e) A controller that discloses pseudonymous data or deidentified data shall 7 exercise reasonable oversight to monitor compliance with any contractual 8 commitments to which the pseudonymous data or deidentified data is subject and 9 shall take appropriate steps to address any breaches of those contractual 10 commitments.

(7) LIMITATIONS. (a) Nothing in this section shall be construed to restrict a
controller's or processor's ability to do any of the following:

13 1. Comply with federal, state, or local laws, rules, or regulations.

Comply with a civil, criminal, or regulatory inquiry, investigation, subpoena,
 or summons by federal, state, local, or other governmental authorities.

Cooperate with law enforcement agencies concerning conduct or activity that
the controller or processor reasonably and in good faith believes may violate federal,
state, or local laws, rules, or regulations.

4. Investigate, establish, exercise, prepare for, or defend legal claims.

5. Provide a product or service specifically requested by a consumer, perform a contract to which the consumer is a party, including fulfilling the terms of a written warranty, or take steps at the request of the consumer prior to entering into a contract.

1	6. Take immediate steps to protect an interest that is essential for the life or

9 (c) The obligations imposed on controllers or processors under this section shall 10 not apply where compliance by the controller or processor with this section would 11 violate an evidentiary privilege under ch. 905. Nothing in this section shall be 12 construed to prevent a controller or processor from providing personal data 13 concerning a consumer to a person covered by an evidentiary privilege under ch. 905 14 as part of a privileged communication.

15(d) A controller or processor that discloses personal data to a 3rd-party 16 controller or processor, in compliance with the requirements of this section, is not in 17violation of this section if the 3rd-party controller or processor that receives and 18 processes such personal data is in violation of this section, provided that, at the time 19 of disclosing the personal data, the disclosing controller or processor did not have 20 actual knowledge that the recipient intended to commit a violation. A 3rd-party 21controller or processor receiving personal data from a controller or processor in 22compliance with the requirements of this section is likewise not in violation of this 23section for the transgressions of the controller or processor from which it receives 24such personal data.

(9) VIOLATIONS. (a) The attorney general shall have exclusive authority to enforce violations of this section. 6

7 (b) 1. Prior to initiating any action under this section, the attorney general shall provide a controller or processor 30 days' written notice identifying the specific 8 9 provisions of this section the attorney general, on behalf of a consumer, alleges have 10 been or are being violated. If within the 30 days the controller or processor cures the 11 noticed violation and provides the attorney general an express written statement 12that the alleged violations have been cured and that no further violations shall occur, 13no action for statutory damages shall be initiated against the controller or processor.

9	of any action initiated under this section.
10	(11) LOCAL PREEMPTION. No city, village, town, or county may enact or enforce
11	an ordinance that regulates the collection, processing, or sale of personal data.
