***Analysis by the Legislative Reference Bureau***

This bill makes several changes to the administration of trusts, the power to decant trusts, the creation and exercise of powers of appointment, the disclosure of

certain digital property, and the classification of digital property as individual property for purposes of determining marital property. Important provisions of the bill are summarized as follows:

***Administration of trusts***

The bill makes several technical changes to the administration and regulation of trusts in the state, including the following:

1. The bill provides that notice given to any trustee when more than one person is serving as trustee is considered to be given to all persons serving as trustee, except that notice must be given to all corporations and attorneys that are serving as trustee.

2. The bill expands the concept of representation in a trust proceeding. Under the bill, a person holding a general power of appointment or a broad limited power of appointment may represent and bind the interests of all persons whose interests may be eliminated, regardless of whether there is a conflict of interest. A person holding a nongeneral power of appointment may represent and bind the interests of any person whose interest may be limited by the exercise of the power, provided there is no conflict of interest. A presumptive remainder beneficiary may represent and bind the interests of a contingent successor remainder beneficiary or a more remote contingent successor beneficiary, regardless of whether the beneficiary lacks capacity and provided there is no conflict of interest. If a presumptive remainder beneficiary does not represent a more remote contingent successor remainder beneficiary, a contingent successor remainder beneficiary may represent and bind a more remote contingent successor remainder beneficiary. The bill also confirms that a settlor can nominate in the trust instrument a designated representative to represent and bind any beneficiary.

3. The bill allows for the creation of a trust without initially funding the trust. To create such a trust, the bill requires a person to declare the intention to create a trust with the intention that the trust will be funded by assets of the person who created the trust or by another person with legal authority to fund the trust. Under the bill, the person making the declaration is considered to have created the trust regardless of whether the person funds the trust with the person's own assets.

4. The bill provides for the resolution of debts against a deceased settlor of a trust that was revocable until the settlor's death. First, the bill provides that a claimant must assert a claim for payment of a debt of a deceased settlor within any applicable deadline established by law. A trustee of a trust that was revocable at the settlor's death may shorten the time period and set a deadline for filing claims with the trustee by publishing a legal notice or giving notice to a potential claimant. A claim that was barred by a statute of limitations at the time of the deceased settlor's death is barred and the claimant may not pursue a claim against the trustee, the trust property, or recipients with respect to trust property. However, a claim not barred by a statute of limitations at the time of the settlor's death is not barred thereafter by a statute of limitations if the claim is filed by the deadline for filing a claim after the death of the settlor. The deadlines established for filing a claim after the death of the settlor do not extend the time for commencement of a claim beyond the time provided by any statute of limitations applicable to that claim. Failure of

a claimant to file a claim within applicable deadlines does not bar the claimant from satisfying the claim, if not otherwise barred, from property other than trust property.

5. The bill further provides for the form and verification of claims against a deceased settlor, the trustee response to claims against a deceased settlor, contest and enforcement of claims against a deceased settlor, compromise of claims against a deceased settlor, payment of claims against a deceased settlor, and the priority of claims against a deceased settlor.

6. The bill provides that a trustee of a trust has an insurable interest in the life of an insured under a life insurance policy that is owned by the trustee of the trust acting in a fiduciary capacity or that designates the trust itself as the owner if, on the date the policy is issued, the insured is a settlor of the trust or is an individual in whom a settlor of the trust has, or would have if living at the time the life insurance policy was issued, an insurable interest in the life of the insured and the life insurance proceeds are primarily for the benefit of one or more trust beneficiaries who either have an insurable interest in the life of the insured or have a substantial interest engendered by love or affection in the continuation of the life of the insured and, if the beneficiary does not have an insurable interest in the life of the insured, are related to the insured as provided in the bill.

***Uniform Trust Decanting Act***

Current law allows a trustee to transfer the assets of a trust to a second trust subject to certain requirements. The bill adopts the Uniform Trust Decanting Act (UTDA). The UTDA, as adopted, replaces the current language governing the transfer of assets to a second trust and makes several substantive changes to current law.

The bill defines “decanting power” as the power to 1) modify the terms of a trust or 2) distribute the property of a trust to a second trust. Under the bill, an authorized fiduciary may exercise the decanting power. An “authorized fiduciary” is defined as 1) a trustee or another fiduciary, other than the settlor, that has discretion to distribute or direct a trustee to distribute principal from a trust to a beneficiary; 2) a special fiduciary appointed by a court to exercise the decanting power; 3) a trustee or fiduciary that has the discretion or obligation to distribute property to beneficiaries of a trust that has a beneficiary with a disability; or 4) a trust protector who has been granted the decanting power.

The decanting power under this bill applies only to a trust that 1) is irrevocable or revocable by the settlor only with the consent of the trustee or a person that has an adverse interest in the revocation of the trust and 2) is not held solely for charitable purposes. The bill specifies that a first-trust instrument is deemed to include the decanting power unless the first-trust instrument explicitly prohibits or restricts exercise of the decanting power. The UTDA provisions of the bill apply to any trust created before, on, or after the effective date of the bill if the trust is governed or administered under the law of this state.

Under current law, a trustee may only transfer assets to a second trust with court approval or through a notice procedure. The current notice procedure requires giving notice to the settlor, beneficiaries, and certain powerholders of a trust 30 days prior to transferring assets from that first trust to a second trust. The bill requires

a similar 30-day notice for exercise of the decanting power, but requires notice to be provided to additional powerholders and fiduciaries of the first trust as well as powerholders and fiduciaries of the second trust and, for certain trusts with a charitable interest, the attorney general. Under the bill, an exercise of the decanting power is effective if the authorized fiduciary acted with reasonable care to comply with the notice requirement, even if the fiduciary failed to provide notice to every person entitled to notice.

In addition, under current law, a trustee may not appoint assets to a second trust if a contribution to the first trust qualified for a marital or charitable deduction for federal income, gift, or estate tax purposes and the second trust would prevent the asset from qualifying for the deduction or reduce the amount of the deduction. The bill retains this prohibition and expands it to other tax benefits, including deductions for state income, gift, estate, and inheritance taxes and any tax benefit for which a first trust is clearly designed to qualify. The bill also prohibits the use of the decanting power to 1) increase an authorized fiduciary's compensation, 2) relieve an authorized fiduciary from liability for breach of trust in a second-trust instrument to a greater extent than in the first-trust instrument, or 3) reduce the aggregate fiduciary liability of all fiduciaries of a second trust without court approval or the consent of all of the qualified beneficiaries of a second trust.

The bill includes additional provisions about the decanting power for certain types of trusts. Specifically, in a trust that has a beneficiary with a disability, an authorized fiduciary may exercise the decanting power if the second trust is a special needs trust that benefits the beneficiary with a disability and the authorized fiduciary determines that exercise of the decanting power will further the purposes of the first trust. Under the bill, a "special needs trust" means a trust that the trustee believes would not be considered a resource for purposes of determining whether a beneficiary with a disability is eligible for governmental benefits based on disability. Also, if a first trust contains a charitable interest, a second trust may not diminish the charitable interest, diminish the interest of an identified charitable organization that holds the charitable interest, alter any charitable purpose stated in the first-trust instrument, or alter any condition or restriction related to the charitable interest. In addition, the bill specifies that the decanting power may be exercised over an animal trust. An "animal trust" is defined under the bill as a trust created to provide for the care of an animal that has a person appointed to enforce the trust on behalf of the animal. If a first trust is an animal trust, a second trust must provide that trust property may be applied only to its intended purpose for the period the first trust benefitted the animal.

If the trust instrument for a second trust does not comply with all of the requirements of the UTDA but the exercise of the decanting power would otherwise be effective, then 1) any provision that is included in the second-trust instrument in violation of the UTDA is void and 2) any provision omitted from the second-trust instrument in violation of the UTDA is deemed to be included in the second-trust instrument.

**ASSEMBLY BILL 803*****Uniform Powers of Appointment Act***

The bill adopts the Uniform Powers of Appointment Act. Under the bill, a “power of appointment” means a power that enables a powerholder acting in a nonfiduciary capacity to designate a recipient of an ownership interest in or another power of appointment over the appointive property. A power of appointment is created only if the instrument creating the power governs the disposition of the appointive property and the terms of the instrument manifest the donor’s intention to create in a powerholder a power of appointment over the appointive property exercisable in favor of a permissible appointee. Under the bill, unless the terms of the instrument creating the power of appointment state otherwise, a power of appointment is presumed to be a presently exercisable power of appointment, an exclusionary power of appointment, and a general power of appointment. An “exclusionary power of appointment” means a power of appointment exercisable in favor of one or more permissible appointees to the exclusion of the other permissible appointees. A “general power of appointment” means a power of appointment exercisable in favor of the powerholder, the powerholder’s estate, a creditor of the powerholder, or a creditor of the powerholder’s estate. The bill provides, however, that a power of appointment is presumed to be a nongeneral power of appointment if the power is exercisable only at the powerholder’s death and the permissible appointees of the power are a defined and limited class that does not include the powerholder’s estate, the powerholder’s creditors, or the creditors of the powerholder’s estate.

Under the bill, a power of appointment is exercised only if the instrument exercising the power is valid under law, the terms of the instrument manifest the powerholder’s intent to exercise the power, and the instrument satisfies any requirements of exercise imposed by the donor, if any. If a power of appointment is vested in two or more persons, then the powerholders may only exercise the power of appointment unanimously. Under the bill, a powerholder may exercise their power of appointment by including a residuary clause in the powerholder’s will, or a comparable clause in the powerholder’s revocable trust, if the will or trust instrument manifests intent to do so, the power of appointment is a general power of appointment, there is no gift-in-default clause in the instrument creating the power of appointment, and the powerholder did not previously release the power of appointment.

If the powerholder releases or fails to exercise a general power of appointment, the bill provides that the gift-in-default clause controls the unappointed property or, if there is no gift-in-default clause, the bill provides default rules for how the unappointed property is disposed. A personal representative, trustee, or other fiduciary who holds property subject to a power of appointment may administer the appointive property as if the power of appointment was not exercised if the personal representative, trustee, or other fiduciary has no notice of the existence of any documentation of the powerholder purporting to exercise the power of appointment by will or otherwise within six months after the death of the powerholder.

**ASSEMBLY BILL 803*****Classification of digital property as individual property***

The bill establishes an exception to Wisconsin's general marital property law, allowing digital property to be classified as individual property if the property meets certain criteria. Under the bill, an account and the digital property held in an account, including the content of electronic communications such as personal email, that is created and maintained for personal use is classified as individual property, unless either the account or the digital property in the account was not originally created, purchased, or otherwise acquired exclusively for the personal, noneconomic purposes of the account holder, or the account or the digital property in the account has at any time been used for purposes other than the personal, noneconomic purposes of the spouse holding the account. Under the bill, in the event of a sale, exchange, or other disposition, all property received in exchange for that account, or the digital property in the account, is classified as marital property; and, further, income during marriage and after the determination date attributable to the account, or the digital property in the account, is classified as marital property.

***Disclosure of digital property***

Under current law, a user may use an online tool to direct a custodian of digital property to disclose or not to disclose to a designated recipient some or all of the user's digital property in certain circumstances. If an online tool allows the user to modify or delete a direction at all times, a direction regarding disclosure using an online tool overrides a contrary direction by the user in a will, trust, power of attorney, or any other governing instrument. If a user has not used an online tool or if the custodian has not provided an online tool, the user may allow or prohibit disclosure to a fiduciary of some or all of the user's digital property, including the content of electronic communications sent or received by the user, in a will, trust, power of attorney, or any other governing instrument.

The bill provides that a user may allow or prohibit the disclosure to a fiduciary of some or all of the user's digital property in a consent instrument. A consent instrument is defined as a written notarized document in physical or electronic form evidencing the user's consent to the disclosure of the contents of electronic communications to a then acting fiduciary. However, a direction regarding disclosure using an online tool overrides a contrary direction by the user in a consent instrument in the same way that an online tool overrides a will, trust, power of attorney, or other governing instrument under current law.

6 distribute part or all of the principal of a first trust to one or more current  
7 beneficiaries.

8 2. If no trustee or fiduciary has discretion under subd. 1., a trustee or other  
9 fiduciary, other than a settlor, that has discretion to distribute part or all of the  
10 income of the first trust to one or more current beneficiaries.

11 3. If no trustee or fiduciary has discretion under subds. 1. and 2., a trustee or  
12 other fiduciary, other than a settlor, that is required to distribute part or all of the  
13 income or principal of the first trust to one or more current beneficiaries.

14 (c) “Special-needs trust” means a trust the trustee believes would not be  
15 considered a resource for purposes of determining whether an individual with a  
16 disability is eligible for the supplemental security income program or the medical  
17 assistance program.

18 **(2)** A special-needs fiduciary may exercise the decanting power under s.  
19 701.1311 over the principal of a first trust as if the fiduciary had authority to  
20 distribute principal to a beneficiary with a disability subject to expanded distributive  
21 discretion if all of the following apply:

22 (a) A 2nd trust is a special-needs trust that benefits the beneficiary with a  
23 disability.

24 (b) The special-needs fiduciary determines that exercise of the decanting  
25 power will further the purposes of the first trust.

1           **(3)** In an exercise of the decanting power under this section, the following rules  
2 apply:

3           (a) Notwithstanding s. 701.1311 (3) (b), the interest in the 2nd trust of a  
4 beneficiary with a disability may do any of the following:

5           1. Be an account in a pooled trust for the benefit of the beneficiary with a  
6 disability described in 42 USC 1396p (d) (4) (C) that includes the trust retention  
7 provisions permitted by 42 USC 1396p (d) (4) (C) (iv).

8           2. Contain payback provisions complying with reimbursement requirements  
9 of Medicaid law under 42 USC 1396p (d) (4) (A) or (C).

10          (b) Section 701.1311 (3) (c) does not apply to the interests of the beneficiary with

12          (c) Except as affected by any change to the interests of the beneficiary with a  
13 disability or by the effects on remainder beneficiaries of a transfer to a 2nd trust  
14 under par. (a), if the special needs fiduciary has limited distributive discretion over  
15 the principal of the 2nd trust, or if there are 2 or more 2nd trusts, the 2nd trusts in  
16 the aggregate must grant each other beneficiary of the first trust beneficial interests  
17 in the 2nd trusts that are substantially similar to the beneficiary's beneficial  
18 interests in the first trust.

19           **701.1314 Protection of charitable interest. (1)** In this section:

20          (a) "Determinable charitable interest" means an interest that is all of the  
21 following:

22           1. A charitable interest.

23           2. Entitled to receive a mandatory distribution currently, periodically, on the  
24 occurrence of a specified event, or after the passage of a specified time.

25           3. Unconditional or held solely for charitable purposes.

1           (b) “Unconditional” means not subject to the occurrence of a specified event that  
2 is not certain to occur, other than a requirement in a trust instrument that a  
3 charitable organization be in existence or qualify under a particular provision of the

5 meets the requirement on the date of determination.

6           **(2)** The attorney general may represent and bind a charitable interest only  
7 when the attorney general has the rights of a qualified beneficiary as provided in s.  
8 701.0110 (3).

9           **(3)** If a first trust contains a charitable interest, the 2nd trust or trusts may not  
10 do any of the following:

11           (a) Diminish the charitable interest.

12           (b) Diminish the interest of an identified charitable organization that holds the  
13 charitable interest.

14           (c) Alter any charitable purpose stated in the first-trust instrument.

15           (d) Alter any condition or restriction related to the charitable interest.

16           **(3m)** Notwithstanding subs. (3) and (5), if the first trust is an account in a  
17 pooled trust described in 42 USC 1396p (d) (4) (C), the 2nd trust may be an account  
18 in another pooled trust described in 42 USC 1396p (d) (4) (C) or a trust described in  
19 42 USC 1396p (d) (4) (A) regardless of any of the following:

20           (a) Any effect on a charitable interest in property that is permitted to be  
21 retained in the first trust under 42 USC 1396p (d) (4) (C) (iv).

22           (b) Any effect the trust retention and Medicaid reimbursement provisions of  
23 the 2nd trust may have on a charitable interest in the first trust.

24           (c) Any change in the identified charitable organization.

1 (d) Any change in the governing law or principal place of administration of the  
2 trust.

3 (4) If there are 2 or more 2nd trusts, the 2nd trusts shall be treated as one trust  
4 for purposes of determining whether the exercise of the decanting power diminishes  
5 the charitable interest or diminishes the interest of an identified charitable  
6 organization for purposes of sub. (3).

7 (5) If a first trust contains a determinable charitable interest, the 2nd trust or  
8 trusts that include a charitable interest pursuant to sub. (3) must be administered  
9 under the law of this state unless any of the following applies:

10 (a) The attorney general, after receiving notice under s. 701.1307, fails to object  
11 in a signed record delivered to the authorized fiduciary within the notice period.

12 (b) The attorney general consents in a signed record to the 2nd trust or trusts  
13 being administered under the law of another jurisdiction.

14 (c) The court approves the exercise of the decanting power.

15 (d) The identified charitable organization consents in a signed record delivered  
16 to the authorized fiduciary.

17 (6) This subchapter does not limit the powers and duties of the attorney general  
18 under the laws of this state other than this subchapter.

19 **701.1315 Trust limitation on decanting.** (1) An authorized fiduciary may  
20 not exercise the decanting power to the extent the first-trust instrument expressly  
21 prohibits exercise of any of the following:

22 (a) The decanting power.

23 (b) A power granted by state law to the fiduciary to distribute part or all of the  
24 principal of the trust to another trust or to modify the trust.

16 an authorized fiduciary's compensation, the fiduciary may not exercise the decanting  
17 power to increase the fiduciary's compensation above the specified compensation  
18 unless any of the following applies:

19           (a) All qualified beneficiaries of the 2nd trust consent to the increase in a signed  
20 record.

21           (b) The increase is approved by the court.

22           (2) If a first-trust instrument does not specify an authorized fiduciary's  
23 compensation, the fiduciary may not exercise the decanting power to increase the  
24 fiduciary's compensation above the compensation permitted by this chapter unless  
25 any of the following applies:

4 **(3)** A change in an authorized fiduciary's compensation that is incidental to

6 fiduciary's compensation for purposes of subs. (1) and (2).

7 **(4)** This section does not apply to a decanting from a first trust that is a pooled  
8 trust described in 42 USC 1396p (d) (4) (C), or to a decanting to a 2nd trust that is  
9 a pooled trust described in 42 USC 1396p (d) (4) (C).

10 **701.1317 Relief from liability and indemnification.** **(1)** Except as  
11 otherwise provided in this section, a 2nd-trust instrument may not relieve an  
12 authorized fiduciary from liability for breach of trust to a greater extent than the  
13 first-trust instrument unless any of the following applies:

14 (a) All the qualified beneficiaries of the 2nd trust consent to the relief from  
15 liability in a signed record.

16 (b) The relief from liability is approved by the court.

17 **(2)** A 2nd-trust instrument may provide for indemnification of an authorized  
18 fiduciary of the first trust or another person acting in a fiduciary capacity under the  
19 first trust for any liability or claim that would have been payable from the first trust  
20 if the decanting power had not been exercised.

21 **(3)** Absent consent of all qualified beneficiaries or the approval of the court, the  
22 2nd-trust instrument may not reduce the aggregate fiduciary liability of all  
23 fiduciaries of the 2nd trust.

24 **(4)** Subject to sub. (3), a 2nd-trust instrument may divide and reallocate  
25 fiduciary powers among fiduciaries, including one or more trustees, directing

1 parties, trust protectors, or other persons, and relieve a fiduciary from liability for

4 **701.1318 Removal or replacement of authorized fiduciary.** (1) An  
5 authorized fiduciary may not exercise the decanting power to modify a provision in  
6 a first-trust instrument granting another person power to remove or replace the  
7 fiduciary unless any of the following applies:

8 (a) The person holding the power consents to the modification in a signed record  
9 and the modification applies only to the person.

10 (b) The person holding the power and the qualified beneficiaries of the 2nd trust  
11 consent to the modification in a signed record and the modification grants a  
12 substantially similar power to another person.

13 (c) The court approves the modification and the modification grants a

18 **701.1319 Tax-related limitations.** (1) In this section:

19 (a) “Grantor trust” means a trust as to which a settlor of a first trust is  
20 considered the owner under sections 671 to 677 of the Internal Revenue Code or  
21 section 679 of the Internal Revenue Code.

22 (b) “Nongrantor trust” means a trust that is not a grantor trust.

23 (c) “Qualified benefits property” means property subject to the minimum  
24 distribution requirements of section 401 (a) (9) of the Internal Revenue Code, and

1 any applicable regulations, or to any similar requirements that refer to section 401

3 **(2)** An exercise of the decanting power is subject to the following limitations:

5 for provisions of this subchapter other than this section, for a marital deduction for  
6 purposes of the gift or estate tax under the Internal Revenue Code or a state gift,  
7 estate, or inheritance tax, the 2nd-trust instrument must not include or omit any  
8 term that, if included in or omitted from the trust instrument for the trust to which  
9 the property was transferred, would have prevented the transfer from qualifying for  
10 the deduction, or would have reduced the amount of the deduction, under the same  
11 provisions of the Internal Revenue Code or state law under which the transfer

13 (b) If the first trust contains property that qualified, or would have qualified  
14 but for provisions of this subchapter other than this section, for a charitable  
15 deduction for purposes of the income, gift, or estate tax under the Internal Revenue

17 must not include or omit any term that, if included in or omitted from the trust  
18 instrument for the trust to which the property was transferred, would have  
19 prevented the transfer from qualifying for the deduction, or would have reduced the  
20 amount of the deduction, under the same provisions of the Internal Revenue Code  
21 or state law under which the transfer qualified.

22 (c) If the first trust contains property that qualified, or would have qualified  
23 but for provisions of this subchapter other than this section, for the exclusion from  
24 the gift tax described in section 2503 (b) of the Internal Revenue Code, the 2nd-trust  
25 instrument must not include or omit a term that, if included in or omitted from the

1 trust instrument for the trust to which the property was transferred, would have  
2 prevented the transfer from qualifying under section 2503 (b) of the Internal  
3 Revenue Code. If the first trust contains property that qualified, or would have

5 exclusion from the gift tax described in the Internal Revenue Code section 2503 (b)  
6 by application of section 2503 (c) of the Internal Revenue Code, the 2nd-trust  
7 instrument must not include or omit a term that, if included or omitted from the trust

9 prevented the transfer from qualifying under section 2503 (c) of the Internal  
10 Revenue Code.

11 (d) If the property of the first trust includes shares of stock in an S corporation,  
12 as defined in section 1361 of the Internal Revenue Code, and the first trust is, or but  
13 for provisions of this subchapter other than this section would be, a permitted  
14 shareholder under any provision of section 1361 of the Internal Revenue Code, an  
15 authorized fiduciary may exercise the power with respect to part or all of the  
16 S-corporation stock only if any 2nd trust receiving the stock is a permitted  
17 shareholder under section 1361 (c) (2) of the Internal Revenue Code. If the property  
18 of the first trust includes shares of stock in an S corporation and the first trust is, or  
19 but for provisions of this subchapter other than this section would be, a qualified  
20 subchapter S trust within the meaning of section 1361 (d) of the Internal Revenue

23 (e) If the first trust contains property that qualified, or would have qualified but

25 purposes of the generation-skipping transfer tax under section 2642 (c) of the

1 Internal Revenue Code, the 2nd-trust instrument must not include or omit a term  
2 that, if included in or omitted from the first-trust instrument, would have prevented

5 (f) If the first trust is directly or indirectly the beneficiary of qualified benefits  
6 property, the 2nd-trust instrument may not include or omit any term that, if

9 under section 401 (a) (9) of the Internal Revenue Code and any applicable

21 (h) In this paragraph, “tax benefit” means a federal or state tax deduction,  
22 exemption, exclusion, or other benefit not otherwise listed in this section, except for  
23 a benefit arising from being a grantor trust. Subject to par. (i), a 2nd-trust  
24 instrument may not include or omit a term that, if included in or omitted from the

6 2. The transfer of property held by the first trust or the first trust qualified, or  
7 but for provisions of this subchapter other than this section, would have qualified for

9 (i) Subject to par. (d), all of the following apply:

10 1. Except as otherwise provided in par. (g), the 2nd trust may be a nongrantor  
11 trust, even if the first trust is a grantor trust.

12 2. Except as otherwise provided in par. (j), the 2nd trust may be a grantor trust,  
13 even if the first trust is a nongrantor trust.

14 (j) An authorized fiduciary may not exercise the decanting power if a settlor  
15 objects in a signed record delivered to the fiduciary within the notice period and any

5 a duration that is the same as or different from the duration of the first trust.

6           (2) To the extent that property of a 2nd trust is attributable to property of the  
7 first trust, the property of the 2nd trust is subject to any rules governing maximum  
8 perpetuity, accumulation, or suspension of the power of alienation that apply to  
9 property of the first trust.

10          **701.1321 Need to distribute not required.** An authorized fiduciary may  
11 exercise the decanting power whether or not under the first trust's discretionary  
12 distribution standard the fiduciary would have made or could have been compelled  
13 to make a discretionary distribution of principal at the time of the exercise.

14          **701.1322 Saving provision.** (1) If exercise of the decanting power would be  
15 effective under this subchapter except that the 2nd-trust instrument in part does not  
16 comply with this subchapter, the exercise of the power is effective and the following  
17 rules apply with respect to the principal of the 2nd trust attributable to the exercise  
18 of the power:

19           (a) A provision in the 2nd-trust instrument that is not permitted under this  
20 subchapter is void to the extent necessary to comply with this subchapter.

21           (b) A provision required by this subchapter to be in the 2nd-trust instrument

5 exercised over an animal trust that has an animal protector to the extent the trust  
6 could be decanted under this subchapter if each animal that benefits from the trust  
7 were an individual, if the animal protector consents in a signed record to the exercise  
8 of the power.

9           (2) An animal protector has the rights under this subchapter of a qualified  
10 beneficiary.

11           (3) Notwithstanding any other provision of this subchapter, if a first trust is  
12 an animal trust, in an exercise of the decanting power, the 2nd trust must provide  
13 that trust property may be applied only to its intended purpose for the period the first  
14 trust benefitted the animal.

15           **701.1324 Terms of 2nd trust.** A reference in this chapter to a trust  
16 instrument or terms of the trust includes a 2nd-trust instrument and the terms of  
17 the 2nd trust.

18           **701.1325 Settlor.** (1) For purposes of law of this state other than this  
19 subchapter and subject to sub. (2), a settlor of a first trust is deemed to be the settlor  
20 of the 2nd trust with respect to the portion of the principal of the first trust subject  
21 to the exercise of the decanting power.

22           (2) In determining settlor intent with respect to a 2nd trust, the intent of a  
23 settlor of the first trust, a settlor of the 2nd trust, and the authorized fiduciary may  
24 be considered.

15           **701.1327 Obligations.** A debt, liability, or other obligation enforceable  
16 against property of a first trust is enforceable to the same extent against the property  
17 when held by the 2nd trust after exercise of the decanting power.

18           **SECTION 118.** Chapter 702 of the statutes is repealed and recreated to read:

23           **702.101 Short title.** This act may be cited as the Uniform Powers of  
24 Appointment Act.

25           **702.102 Definitions.** In this chapter:

6 a power of appointment and is not a specific-exercise clause. “Blanket-exercise  
7 clause” includes a clause that does any of the following:

8           (a) Expressly uses the words “any power” in exercising a power of appointment  
9 the powerholder has.

10           (b) Expressly uses the words “any property” in appointing any property over  
11 which a powerholder has a power of appointment.

12           (c) Disposes of all property subject to disposition by the powerholder.

13           **(4)** “Broad limited power of appointment” means a power of appointment  
14 exercisable in favor of anyone other than the powerholder, the powerholder’s estate,  
15 the powerholder’s creditors, or the creditors of the powerholder’s estate.

16           **(5)** “Donor” means a person that creates a power of appointment.

17           **(6)** “Exclusionary power of appointment” means a power of appointment  
18 exercisable in favor of one or more permissible appointees to the exclusion of the  
19 other permissible appointees.

20           **(7)** “General power of appointment” means a power of appointment exercisable  
21 in favor of the powerholder, the powerholder’s estate, a creditor of the powerholder,  
22 or a creditor of the powerholder’s estate.

23           **(8)** “Gift-in-default clause” means a clause that identifies a taker in default  
24 of appointment.

1           **(9)** “Impermissible appointee” means a person that is not a permissible  
2 appointee.

3           **(10)** “Instrument” means a writing.

4           **(11)** “Nongeneral power of appointment” means a power of appointment that  
5 is not a general power of appointment.

6           **(12)** “Permissible appointee” means a person in whose favor a powerholder may  
7 exercise a power of appointment.

8           **(13)** “Person” means an individual, estate, trust, business or nonprofit entity,  
9 public corporation, government or governmental subdivision, agency, or  
10 instrumentality, or other legal entity.

11           **(14)** “Power of appointment” means a power that enables a powerholder acting  
12 in a nonfiduciary capacity to designate a recipient of an ownership interest in or  
13 another power of appointment over the appointive property. “Power of appointment”  
14 does not include a power of attorney.

15           **(15)** “Powerholder” means a person in which a donor creates a power of  
16 appointment.

17           **(16)** “Presently exercisable power of appointment” means a power of  
18 appointment exercisable by the powerholder at the relevant time. “Presently  
19 exercisable power of appointment” includes a power of appointment that is not  
20 exercisable until the occurrence of a specified event, the satisfaction of an  
21 ascertainable standard, or the passage of a specified time, and only after the  
22 occurrence of the specified event, the satisfaction of the ascertainable standard, or  
23 the passage of the specified time, but does not include a power exercisable only at the  
24 powerholder’s death.

1           **(17)** “Specific-exercise clause” means a clause in an instrument that  
2 specifically refers to and exercises a particular power of appointment.

3           **(18)** “Taker in default of appointment” means a person that takes all or part  
4 of the appointive property to the extent the powerholder does not effectively exercise  
5 the power of appointment.

6           **(19)** “Terms of the instrument” means the manifestation of the intent of the  
7 maker of the instrument regarding the instrument’s provisions as expressed in the  
8 instrument or as may be established by other evidence that would be admissible in  
9 a legal proceeding.

10           **702.103 Governing law.** Unless the terms of the instrument creating a power  
11 of appointment manifest a contrary intent, the creation, revocation, or amendment  
12 of a power of appointment is governed by the law of the donor’s domicile at the  
13 relevant time. The exercise, release, or disclaimer of a power of appointment, or the  
14 revocation or amendment of an exercise, release, or disclaimer of a power of  
15 appointment is governed by the law of the powerholder’s domicile at the relevant  
16 time.

17           **702.104 Common law and principles of equity.** The common law and  
18 principles of equity supplement this chapter, except to the extent modified by this  
19 chapter or any other state law.

20           **702.105 Default rules.** The terms of a governing instrument prevail over any  
21 provision of this subchapter.

**SUBCHAPTER II****CREATION, REVOCATION, AND AMENDMENT****OF POWER OF APPOINTMENT**

**ASSEMBLY BILL 803**

1           **702.201 Creation of power of appointment.** (1) A power of appointment  
2 is created only if the instrument creating the power satisfies all of the following:

3           (a) The instrument is valid under applicable law.

4           (b) Except as provided in sub. (2), the instrument governs the disposition of the  
5 appointive property.

6           (c) The terms of the instrument manifest the donor's intent to create in a  
7 powerholder a power of appointment over the appointive property exercisable in  
8 favor of a permissible appointee.

9           (2) Subsection (1) (b) does not apply to a power of appointment that is created  
10 by the exercise of a power of appointment.

11           (3) A power of appointment may not be created in a deceased individual.

12           (4) A power of appointment may be created in an unborn or unascertained  
13 powerholder.

14           **702.202 Nontransferability.** A powerholder may not transfer a power of  
15 appointment. If a powerholder dies without exercising or releasing a power of  
16 appointment, the power lapses.

17           **702.203 Presumption of unlimited authority.** Subject to ss. 702.204 and  
18 702.205, and unless the terms of the instrument creating a power of appointment  
19 manifest a contrary intent, a power of appointment is all of the following:

20           (1) A presently exercisable power of appointment.

21           (2) An exclusionary power of appointment.

22           (3) A general power of appointment.

23           **702.204 Exception to presumption of unlimited authority.** Unless the  
24 terms of the instrument creating a power of appointment manifest a contrary intent,  
25 the power is a nongeneral power of appointment if all of the following apply:

1 (1) The power is exercisable only at the powerholder's death.

2 (2) The permissible appointees of the power are a defined and limited class that  
3 does not include the powerholder's estate, the powerholder's creditors, or the  
4 creditors of the powerholder's estate.

5 **702.205 Rules of classification.** (1) In this section, "adverse party" means  
6 a person with a substantial beneficial interest in appointive property that would be  
7 affected adversely by a powerholder's exercise or nonexercise of a power of  
8 appointment in favor of the powerholder, the powerholder's estate, a creditor of the  
9 powerholder, or a creditor of the powerholder's estate.

10 (2) If a powerholder may exercise a power of appointment only with the consent  
11 or joinder of an adverse party, the power is a nongeneral power of appointment.

12 (3) If the permissible appointees of a power of appointment are not defined and  
13 limited, the power is an exclusionary power of appointment.

14 **702.206 Power to revoke or amend.** A donor may revoke or amend a power  
15 of appointment only to the extent that any of the following applies:

16 (1) The instrument creating the power is revocable by the donor.

17 (2) The donor reserves a power of revocation or amendment over the power of  
18 appointment in the instrument.

19 SUBCHAPTER III

20 EXERCISE OF POWER OF APPOINTMENT

21 **702.301 Requisites for exercise of power of appointment.** (1) (a) A power  
22 of appointment is exercised only if all of the following apply:

23 1. The instrument exercising the power is valid under applicable law.

24 2. The terms of the instrument exercising the power do all of the following:

25 a. Manifest the powerholder's intent to exercise the power.

1           b. Subject to s. 702.304, satisfy the requirements of exercise, if any, imposed by  
2 the donor.

3           (b) A power of appointment is exercised under par. (a) only to the extent the  
4 appointment is a permissible exercise of the power.

5           **(2)** If the donor requires the consent of the donor or any other person for the  
6 exercise of a power of appointment, the consent must be expressed in the instrument  
7 exercising the power of appointment or in a separate written instrument, signed in  
8 either case by the persons whose consent is required. If any person whose consent  
9 is required dies or becomes legally incapable of consenting, the power of appointment  
10 may be exercised by the powerholder without the consent of that person unless the  
11 terms of the instrument creating the power of appointment manifest a contrary  
12 intent.

13           **(3)** (a) Except as provided in par. (b) and unless the terms of the instrument  
14 creating a power of appointment manifest a contrary intent, if a power of  
15 appointment is vested in 2 or more persons, the joint powerholders may only exercise  
16 the power of appointment unanimously.

17           (b) If a power of appointment is vested in 2 or more persons and one or more  
18 of the joint powerholders die, become incapable of exercising the power of  
19 appointment, or renounce, release, or disclaim the power of appointment, the power  
20 of appointment may be exercised unanimously by the other powerholders.

21           **702.302 Intent to exercise: determining intent from residuary clause.**

22           **(1)** In this section:

23           (a) “Residuary clause” does not include a residuary clause containing a  
24 blanket-exercise clause or a specific-exercise clause.

**ASSEMBLY BILL 803****SECTION 118**

1 (b) "Will" includes a codicil and a testamentary instrument that revises another  
2 will.

3 (2) A residuary clause in a powerholder's will, or a comparable clause in the  
4 powerholder's revocable trust, manifests the powerholder's intent to exercise a  
5 power of appointment only if all of the following apply:

6 (a) The terms of the instrument containing the residuary clause do not manifest  
7 a contrary intent.

8 (b) The power of appointment is a general power of appointment exercisable in  
9 favor of the powerholder's estate.

10 (c) There is no gift-in-default clause in the instrument creating the power of  
11 appointment or the gift-in-default clause in the instrument creating the power of  
12 appointment is ineffective.

13 (d) The powerholder did not release the power of appointment.

14 **702.303 Intent to exercise: after-acquired power.** Unless the terms of the  
15 instrument exercising a power of appointment manifest a contrary intent, all of the  
16 following apply:

17 (1) Except as otherwise provided in sub. (2), a blanket-exercise clause extends  
18 to a power of appointment acquired by the powerholder after executing the  
19 instrument containing the clause.

20 (2) If the powerholder is also the donor of the power of appointment, a  
21 blanket-exercise clause does not extend to the power of appointment unless there is  
22 not a gift-in-default clause or the gift-in-default clause is ineffective.

23 **702.304 Substantial compliance with donor-imposed formal**  
24 **requirement.** A powerholder's substantial compliance with a formal requirement  
25 of appointment imposed by the donor, including a requirement that the instrument

1 exercising the power of appointment make reference or specific reference to the  
2 power, is sufficient if all of the following apply:

3 (1) The powerholder knows of and intends to exercise the power of  
4 appointment.

5 (2) The powerholder's manner of attempted exercise of the power of  
6 appointment does not impair a material purpose of the donor in imposing the  
7 requirement.

8 **702.305 Permissible appointment.** (1) A powerholder of a general power  
9 of appointment that permits appointment to the powerholder or the powerholder's  
10 estate may make any appointment, including an appointment in trust or creating a  
11 new power of appointment, that the powerholder could make in disposing of the  
12 powerholder's own property.

13 (2) A powerholder of a general power of appointment that permits appointment  
14 only to the creditors of the powerholder or the creditors of the powerholder's estate  
15 may appoint only to those creditors.

16 (3) Unless the terms of the instrument creating a power of appointment  
17 manifest a contrary intent, the powerholder of a nongeneral power of appointment  
18 may do any of the following:

19 (a) Make an appointment in any form, including an appointment in trust, in  
20 favor of a permissible appointee.

21 (b) Create a general or nongeneral power of appointment in a permissible  
22 appointee that may be exercisable in favor of persons other than permissible  
23 appointees of the original nongeneral power of appointment.

**ASSEMBLY BILL 803****SECTION 118**

1 (c) Create a nongeneral power of appointment in any person to appoint to one  
2 or more of the permissible appointees of the original nongeneral power of  
3 appointment.

4 **702.306 Appointment to a deceased appointee.** Subject to s. 854.06, an  
5 exercise of a power of appointment is ineffective to the extent it is in favor of a  
6 deceased appointee.

7 **702.307 Impermissible appointment.** (1) Except as otherwise provided in  
8 s. 702.306, an exercise of a power of appointment is ineffective to the extent it is in  
9 favor of an impermissible appointee.

10 (2) An exercise of a power of appointment in favor of a permissible appointee  
11 is ineffective to the extent the appointment is a fraud on the power.

12 **702.308 Selective allocation doctrine.** If a powerholder exercises a power  
13 of appointment in a disposition that also disposes of property the powerholder owns,  
14 the owned property and the appointive property must be allocated in the permissible  
15 manner that best carries out the powerholder's intent.

16 **702.309 Capture doctrine: disposition of ineffectively appointed**  
17 **property under general power.** To the extent a powerholder of a general power  
18 of appointment, other than a power to withdraw property from, revoke, or amend a  
19 trust, makes an ineffective appointment, all of the following apply:

20 (1) The gift-in-default clause controls the disposition of the ineffectively  
21 appointed property.

22 (2) (a) If there is no gift-in-default clause or to the extent the gift-in-default  
23 clause is ineffective, the ineffectively appointed property passes to one of the  
24 following:

25 1. If the powerholder is a permissible appointee and living, the powerholder.

1           2. If the powerholder is an impermissible appointee or deceased, the  
2 powerholder's estate if the estate is a permissible appointee.

3           (b) If there is no taker under par. (a), the ineffectively appointed property  
4 passes under a reversionary interest to the donor or the donor's transferee or  
5 successor in interest.

6           **702.310 Disposition of unappointed property under released or**  
7 **unexercised general power.** To the extent a powerholder releases or fails to  
8 exercise a general power of appointment other than a power to withdraw property  
9 from, revoke, or amend a trust, all of the following apply:

10           (1) The gift-in-default clause controls the disposition of the unappointed  
11 property.

12           (2) (a) If there is no gift-in-default clause or to the extent the gift-in-default  
13 clause is ineffective, except as otherwise provided in par. (b), the unappointed  
14 property passes to any of the following:

15           1. If the powerholder is a permissible appointee and living, the powerholder.

16           2. If the powerholder is an impermissible appointee or deceased, the  
17 powerholder's estate if the estate is a permissible appointee.

18           (b) To the extent the powerholder released the power, or if there is no taker  
19 under par. (a), the unappointed property passes under a reversionary interest to the  
20 donor or the donor's transferee or successor in interest.

21           **702.311 Disposition of unappointed property under released or**  
22 **unexercised nongeneral power of appointment.** To the extent a powerholder  
23 releases, ineffectively exercises, or fails to exercise a nongeneral power of  
24 appointment, all of the following apply:

1           (1) The gift-in-default clause controls the disposition of the unappointed  
2 property.

3           (2) (a) If there is no gift-in-default clause or to the extent the gift-in-default  
4 clause is ineffective, the unappointed property passes to the permissible appointees  
5 if all of the following apply:

6                 1. The permissible appointees are defined and limited.

7                 2. The terms of the instrument creating the power do not manifest a contrary  
8 intent.

9           (b) If there is no taker under par. (a), the unappointed property passes under  
10 a reversionary interest to the donor or the donor's transferee or successor in interest.

11           **702.312 Disposition of unappointed property if partial appointment to**  
12 **taker in default.** Unless the terms of an instrument creating or exercising a power  
13 of appointment manifest a contrary intent, if the powerholder makes a valid partial  
14 appointment to a taker in default of appointment, the taker in default of  
15 appointment may share fully in unappointed property.

16           **702.313 Appointment to taker in default.** If a powerholder makes an  
17 appointment to a taker in default of appointment and the appointee would have  
18 taken the property under a gift-in-default clause had the property not been  
19 appointed, the power of appointment is considered not to have been exercised and the  
20 appointee takes under the gift-in-default clause.

21           **702.314 Powerholder's authority to revoke or amend exercise.** A  
22 powerholder may revoke or amend an exercise of a power of appointment only to the  
23 extent that any of the following applies:

24           (1) The powerholder reserves a power of revocation or amendment in the  
25 instrument exercising the power of appointment and, if the power is a nongeneral

1 power of appointment, the terms of the instrument creating the power of  
2 appointment do not prohibit the reservation.

3 (2) The terms of the instrument creating the power of appointment provide that  
4 the exercise of the power of appointment is revocable or amendable.

5 **702.315 Presumption of nonexercise of a power of appointment. (1)**

6 A personal representative, trustee, or other fiduciary who holds property subject to  
7 a power of appointment may administer that property as if the power of appointment  
8 was not exercised if the personal representative, trustee, or other fiduciary has no  
9 notice of the existence of any of the following within 6 months after the death of the  
10 powerholder:

11 (a) A document purporting to be a will of the powerholder if the power of  
12 appointment is exercised by the will.

13 (b) Other documentation of the powerholder purporting to exercise the power  
14 of appointment if the power of appointment is exercisable other than by a will.

15 (2) A personal representative, trustee, or other fiduciary who acts in good faith  
16 is not liable to any person for administering property as if a power of appointment  
17 was not exercised as provided in sub. (1).

18 **SUBCHAPTER IV**

19 **DISCLAIMER OR RELEASE; CONTRACT**

20 **TO APPOINT OR NOT TO APPOINT**

21 **702.401 Disclaimer. (1)** A powerholder may disclaim all or part of a power  
22 of appointment as provided under ss. 700.27 and 854.13.

23 (2) A permissible appointee, appointee, or taker in default of appointment may  
24 disclaim all or part of an interest in appointive property, as provided under ss. 700.27  
25 and 854.13.

**ASSEMBLY BILL 803****SECTION 118**

1           **702.402 Authority to release.** A powerholder may release a power of  
2 appointment, in whole or in part, except to the extent the terms of the instrument  
3 creating the power prevent the release.

4           **702.403 Method of release.** A powerholder of a releasable power of  
5 appointment may release the power in whole or in part by any of the following  
6 methods:

7           (1) Substantial compliance with a method provided in the terms of the  
8 instrument creating the power.

9           (2) If the terms of the instrument creating the power do not provide a method,  
10 a writing that manifests the powerholder's intent by clear and convincing evidence.

11           **702.404 Revocation of amendment of release.** A powerholder may revoke  
12 or amend a release of a power of appointment only to the extent that any of the  
13 following applies:

14           (1) The instrument of release is revocable by the powerholder.

15           (2) The powerholder reserves a power of revocation or amendment in the  
16 instrument of release.

17           **702.405 Power to contract: presently exercisable power of**  
18 **appointment.** A powerholder of a presently exercisable power of appointment may  
19 contract to do any of the following:

20           (1) Not to exercise the power.

21           (2) To exercise the power if the contract when made does not confer a benefit  
22 on an impermissible appointee.

23           **702.406 Power to contract: power of appointment not presently**  
24 **exercisable.** A powerholder of a power of appointment that is not presently

1 exercisable may contract to exercise or not to exercise the power only if all of the  
2 following apply:

3 (1) The powerholder is also the donor of the power.

4 (2) The powerholder reserved the power in a revocable trust.

5 **702.407 Remedy for breach of contract to appoint or not to appoint.**

6 The remedy for a powerholder's breach of a contract to appoint or not to appoint  
7 appointive property is limited to damages payable out of the appointive property or,  
8 if appropriate, specific performance of the contract.

9 SUBCHAPTER V

10 RIGHTS OF POWERHOLDER'S CREDITORS

11 IN APPOINTIVE PROPERTY

12 **702.501 Creditor claim: general power created by powerholder.** (1) In  
13 this section, "power of appointment created by the powerholder" includes a power of  
14 appointment created in a transfer by another person to the extent the powerholder  
15 contributed value to the transfer.

16 (2) Appointive property subject to a general power of appointment created by  
17 a powerholder is subject to a claim of a creditor of the powerholder or of the  
18 powerholder's estate to the extent provided in ch. 242 and any other applicable law  
19 relating to fraudulent conveyances.

20 (3) Subject to sub. (2), appointive property subject to a general power of  
21 appointment created by a powerholder is not subject to a claim of a creditor of the  
22 powerholder or the powerholder's estate to the extent the powerholder irrevocably  
23 appointed the property in favor of a person other than the powerholder or the  
24 powerholder's estate.

**ASSEMBLY BILL 803**

1           (4) Subject to subs. (2) and (3), and notwithstanding the presence of a  
2 spendthrift provision or whether the claim arose before or after the creation of the  
3 power of appointment, appointive property subject to a general power of  
4 appointment created by a powerholder is subject to a claim of a creditor of any of the  
5 following:

6           (a) If the power of appointment is a presently exercisable power of  
7 appointment, the powerholder, to the same extent as if the powerholder owned the  
8 appointive property.

9           (b) If the power of appointment is exercisable at the powerholder's death, the  
10 powerholder's estate, to the extent the estate is insufficient to satisfy the claim and  
11 subject to the right of a decedent to direct the source from which liabilities are paid.

12           **702.502 Creditor claim: general power not created by powerholder. (1)**

13 Except as otherwise provided in sub. (2), appointive property subject to a general  
14 power of appointment created by a person other than the powerholder is subject to  
15 a claim of a creditor of any of the following:

16           (a) If the power of appointment is a presently exercisable power of  
17 appointment, the powerholder to the extent the powerholder's property is  
18 insufficient.

19           (b) If the power of appointment is exercisable at the powerholder's death, the  
20 powerholder's estate or revocable trust, subject to the right of a decedent to direct the  
21 source from which liabilities are paid, but only to the extent of the powerholder's  
22 exercise of that general power of appointment and only to the extent that the claim  
23 of the creditor has been filed and allowed in the powerholder's estate or filed with and  
24 approved by the trustee of a revocable trust but not paid because the assets of the  
25 estate or revocable trust are insufficient. For purposes of this paragraph, a revocable

1 trust is a trust that is revocable, as defined in s. 701.0103 (22), by the powerholder  
2 or jointly by the powerholder and the powerholder's spouse.

3 (2) Subject to s. 702.504 (3), a power of appointment created by a person other  
4 than the powerholder that is subject to an ascertainable standard relating to an  
5 individual's health, education, support, or maintenance within the meaning of 26  
6 USC 2041 (b) (1) (A) or 2514 (c) (1), is considered for purposes of this subchapter as  
7 a nongeneral power of appointment.

8 (3) If during the powerholder's lifetime, the powerholder exercises a general  
9 power of appointment created by a person other than the powerholder, a creditor of  
10 the powerholder can reach the appointed interests to the same extent that under the  
11 law relating to fraudulent conveyances the creditor could reach property that the  
12 powerholder has owned and transferred during the powerholder's lifetime.

13 **702.503 Power to withdraw.** (1) For purposes of this subchapter, and except  
14 as otherwise provided in sub. (2), a power to withdraw property from a trust is  
15 considered, during the time the power may be exercised, as a presently exercisable  
16 general power of appointment to the extent of the property subject to the power to  
17 withdraw.

18 (2) On the lapse, release, or waiver of a power to withdraw property from a  
19 trust, the power is treated as a presently exercisable general power of appointment  
20 only to the extent the value of the property affected by the lapse, release, or waiver  
21 exceeds the greater of the following:

22 (a) The amount referenced in section 2041 (b) (2) or 2514 (e) of the Internal  
23 Revenue Code.

24 (b) The amount referenced in section 2503 (b) of the Internal Revenue Code for  
25 each individual other than the beneficiary who makes a transfer to the trust or who

1 is considered to make a transfer to the trust pursuant to an election to split gifts  
2 under section 2513 (a) of the Internal Revenue Code.

3 **702.504 Creditor claim: nongeneral power of appointment.** (1) Except  
4 as otherwise provided in subs. (2) and (3), appointive property subject to a  
5 nongeneral power of appointment is exempt from a claim of a creditor of the  
6 powerholder or the powerholder's estate.

7 (2) Appointive property subject to a nongeneral power of appointment is  
8 subject to a claim of a creditor of the powerholder or the powerholder's estate to the  
9 extent that the powerholder owned the property and, reserving the nongeneral  
10 power, transferred the property in violation of the law relating to fraudulent  
11 conveyances.

12 (3) For purposes of this subchapter, if the initial gift in default of appointment  
13 is to the powerholder or the powerholder's estate, a nongeneral power of appointment  
14 is treated as a general power of appointment.

15 **702.505. Third parties in good faith protected.** Any person acting without  
16 actual notice of claims of creditors under this subchapter incurs no liability to those  
17 creditors for transferring property that is subject to a power of appointment or that  
18 has been appointed. A purchaser without actual notice and for a valuable  
19 consideration takes an interest in property, legal or equitable, and takes the interest  
20 free of any rights that a powerholder's creditor may have under this subchapter.

21 SUBCHAPTER VI

22 MISCELLANEOUS PROVISIONS

23 **702.601 Recording instruments relating to a power of appointment.** (1)  
24 Each of the following instruments relating to a power of appointment is entitled to  
25 be recorded as a conveyance upon compliance with s. 706.05 (1):

3 (c) A disclaimer.

4 (d) A release.

7 **702.602 Uniformity of application and construction.** In applying and  
8 construing this section, consideration shall be given to the need to promote  
9 uniformity of the law with respect to its subject matter among states that enact it.

10 **702.603 Relation to electronic signatures in global and national**  
11 **commerce act. (1)** Except as provided in sub. (2), this chapter modifies, limits, and  
12 supersedes the federal Electronic Signatures in Global and National Commerce Act,  
13 15 USC 7001, et seq.

14 **(2)** This chapter does not modify, limit, or supersede 15 USC 7001 (c) or  
15 authorize electronic delivery of any of the notices described in 15 USC 7003 (b).

16 **702.604 Applicability. (1)** (a) This chapter applies to a power of appointment  
17 created before, on, or after the effective date of this paragraph .... [LRB inserts date].

18 (b) This chapter applies to a judicial proceeding concerning a power of  
19 appointment commenced on or after the effective date of this paragraph .... [LRB  
20 inserts date].

21 (c) This chapter applies to a judicial proceeding concerning a power of  
22 appointment commenced before the effective date of this paragraph .... [LRB inserts  
23 date], unless the court finds that application of a particular provision of this chapter  
24 would interfere substantially with the effective conduct of the judicial proceeding or

1 prejudice a right of a party, in which case the particular provision of this chapter does  
2 not apply and the superseded law applies.

3 (d) A rule of construction or presumption in this chapter applies to an  
4 instrument executed before the effective date of this paragraph .... [LRB inserts  
5 date], unless there is a clear indication of a contrary intent in the terms of the  
6 instrument.

7 (e) Except as otherwise provided in pars. (a) to (d), this chapter does not apply  
8 to an action taken before the effective date of this paragraph .... [LRB inserts date].

9 **(2)** If a right is acquired, extinguished, or barred on the expiration of a  
10 prescribed period that commenced under a law of this state other than this chapter  
11 before the effective date of this subsection .... [LRB inserts date], the law continues  
12 to apply to the right.

13 **SECTION 119.** 711.03 (4m) of the statutes is created to read:

14 711.03 (4m) "Consent instrument" means a written notarized document in  
15 physical or electronic form evidencing the user's consent to the disclosure of the  
16 contents of electronic communications to a then acting fiduciary.

17 **SECTION 120.** 711.04 (1) of the statutes is renumbered 711.04 (1) (intro.) and  
18 amended to read:

19 711.04 (1) (intro.) A user may use an online tool to direct the custodian to  
20 disclose or not disclose to a designated recipient ~~or not to disclose~~ some or all of the  
21 user's digital property, including the content of electronic communications. If the  
22 online tool allows the user to modify or delete a direction at all times, a direction  
23 regarding disclosure using an online tool overrides a contrary direction by the user
