2023 ASSEMBLY RESOLUTION 15

September 6, 2023 - Introduced by Representatives KATSMAN, AUGUST, BALDEH,
BINSFELD, DITTRICH, DONOVAN, GOEBEN, KRUG, MAGNAFICI, MURPHY, O'CONNOR,
OHNSTAD, PENTERMAN, RETTINGER, SINICKI, SPIROS, SUBECK, TITTL and TRANEL.
Referred to Committee on Rules.

1 **Relating to:** honoring the life and public service of Representative Mike Endsley.

2 Whereas, Michael “Mike” Dee Endsley was born to Laverne and Beverly
3 Endsley on March 4, 1962, in Sheboygan, Wisconsin; and

4 Whereas, Mike Endsley graduated from Sheboygan Falls High School in 1980
5 and from UW-Platteville in 1984, where he received a bachelor’s degree in
6 psychology and excelled as a collegiate football player; and

7 Whereas, Mike Endsley had a fulfilling career in business, spending more than
8 25 years in sales, including as a regional sales manager for Gardner Denver, before
9 being elected to represent the 26th Assembly District in November 2010; and

10 Whereas, during his two terms in the Wisconsin State Assembly, Mike Endsley
11 served as Chair of the Aging and Long-Term Care Committee, and as Vice-Chair of
12 both the Jobs, Economy, and Small Business Committee and the Small Business
13 Development Committee; and

14 Whereas, while serving in the legislature, Mike Endsley authored and
15 advocated for various bills relating to transportation, infrastructure, therapeutic

1 medicine, mental health, law enforcement, corrections, and tax reform, among
2 others; and

3 Whereas, despite Mike Endsley's eagerness to continue serving in the
4 legislature, his political career was cut short after being diagnosed with mild
5 cognitive impairment in 2014, which developed into early-onset Alzheimer's
6 disease; and

7 Whereas, Mike Endsley's tenacity and spirit persevered over the next nine
8 years as he advocated tirelessly for those experiencing memory loss, lobbied for
9 funding to support patients and caregivers, and educated others about Alzheimer's
10 disease; and

11 Whereas, Mike Endsley volunteered with the Sheboygan County Walk to End
12 Alzheimer's committee and spent many hours volunteering at The Gathering Place,
13 a day program for adults with memory loss where he built friendships, facilitated
14 activities, and took great pride in serving others while facing his own challenges with
15 the disease; and

16 Whereas, Mike Endsley passed away peacefully, surrounded by family, on July
17 13, 2023; and

18 Whereas, Mike Endsley will be remembered by his family and friends for his
19 optimism, sense of humor, heartwarming smile, and passion for serving his
20 community; now, therefore, be it

21 ***Resolved by the assembly, That*** the members of the Wisconsin State
22 Assembly join in honoring the life and public service of Representative Mike Endsley
23 and extend their condolences to his family and friends.
