## 2023 SENATE BILL 663

November 9, 2023 - Introduced by Senators LARSON, L. JOHNSON, SPREITZER and ROYS, cosponsored by Representatives CLANCY, C. ANDERSON, MADISON, RATCLIFF, PALMERI, BALDEH, BARE, CABRERA, DRAKE, EMERSON, SHELTON, SINICKI, SNODGRASS, STUBBS, HONG, MOORE OMOKUNDE, OHNSTAD, JOERS, ORTIZ-VELEZ and J. ANDERSON. Referred to Committee on Housing, Rural Issues and Forestry.

1     **AN ACT** *to amend* 799.05 (3) (b), 799.05 (7), 799.06 (3) (a), 799.12 (3), 799.16 (4)  
2           (c), 799.20 (4), 799.206 (3), 799.21 (3) (a), 799.21 (3) (b), 799.25 (10) (b) and  
3           799.27 (1); and *to create* 799.01 (1) (ag) and 799.47 of the statutes; **relating**  
4     **to:** actions for relief from extrajudicial eviction in small claims court.

### *Analysis by the Legislative Reference Bureau*

Under current law, actions for eviction are heard in small claims court. Under this bill, actions brought by a tenant for relief from extrajudicial (also known as “self-help”) evictions may also be heard in small claims court.

Under the bill, a tenant is required to file a summons and complaint in small claims court and serve the summons and complaint on the defendant landlord. The return date must be held between five and 25 days from the date that the summons is issued, which is the same time period for eviction actions. Also, similar to eviction actions, if the defendant appears on the return date and raises a defense, the court or circuit court commissioner hearing the action must hold a trial within 30 days of the return date. The bill also provides that a court hearing an action for relief from extrajudicial eviction may grant a temporary injunction against a landlord or a landlord’s agent that has removed or attempted to removed the tenant or the tenant’s belongings from the premises as part of an extrajudicial eviction.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

1           **SECTION 1.** 799.01 (1) (ag) of the statutes is created to read:

2           799.01 (1) (ag) *Extrajudicial evictions.* Actions for relief from extrajudicial  
3 evictions as described in s. 799.47.

4           **SECTION 2.** 799.05 (3) (b) of the statutes is amended to read:

5           799.05 (3) (b) Except in eviction actions and actions for relief from extrajudicial  
6 evictions, the return date for a summons served upon a resident of this state shall  
7 be not less than 8 days nor more than 30 days from the issue date, and service shall  
8 be made not less than 8 days prior to the return date. In eviction actions and actions  
9 for relief from extrajudicial evictions, the return date for a summons served upon a  
10 resident of this state shall be not less than 5 days nor more than 25 days from the  
11 issue date, and service shall be made not less than 5 days prior to the return date.

12           **SECTION 3.** 799.05 (7) of the statutes is amended to read:

13           799.05 (7) FORM; CIRCUIT COURT COMMISSIONER. Except as provided in s. 799.22  
14 (4) (b) 3., in counties in which a circuit court commissioner is assigned to assist in  
15 small claims matters, the summons shall be substantially in the following form:

21           799.12 (3) If authorized by court rule under sub. (2), service may be made by  
22 mail by filing the summons with the clerk of court, together with a request for mail  
23 service and the fee prescribed in s. 814.62 (4). The court shall require the use of  
24 certified mail with return receipt requested for all eviction and relief from  
25 extrajudicial eviction cases for which service by mail is authorized under sub. (2),  
1 and for all other cases may by rule require the use of certified mail with return receipt  
2 requested. Whenever the use of certified mail is required, the additional fee  
3 prescribed in s. 814.62 (4) shall be paid for each defendant. The clerk shall mail a  
4 copy to each defendant at the last-known address as specified in the summons.  
5 Service of the summons is considered completed when it is mailed, unless the

5 799.20 (4) INQUIRY OF DEFENDANT WHO APPEARS ON RETURN DATE. If the defendant  
6 appears on the return date of the summons or any adjourned date thereof, the court  
7 or circuit court commissioner shall make sufficient inquiry of the defendant to  
8 determine whether the defendant claims a defense to the action. If it appears to the  
9 court or circuit court commissioner that the defendant claims a defense to the action,  
10 the court or circuit court commissioner shall schedule a trial of all the issues involved  
11 in the action, unless the parties stipulate otherwise or the action is subject to  
12 immediate dismissal. In a residential eviction action or action for relief from  
13 extrajudicial eviction, the court or circuit court commissioner shall hold and  
14 complete a court or jury trial of the issue of possession of the premises involved in  
15 the action within 30 days of the return date of the summons or any adjourned date  
16 thereof, unless the parties stipulate otherwise or the action is subject to immediate

22 forthwith scheduled for a hearing, to be held as soon as possible before a judge and  
23 in the case of an eviction action or action for relief from extrajudicial eviction, not  
24 more than 30 days after the return date.

25 **SECTION 9.** 799.21 (3) (a) of the statutes is amended to read:

1 799.21 (3) (a) Any party may, upon payment of the fees prescribed in ss. 814.61  
2 (4) and 814.62 (3) (e), file a written demand for trial by jury. If no party demands a  
3 trial by jury, the right to trial by jury is waived forever. In eviction actions and actions  
4 for relief from extrajudicial eviction, the demand shall be filed at or before the time  
5 of joinder of issue; in all other actions within 20 days thereafter.

6 **SECTION 10.** 799.21 (3) (b) of the statutes is amended to read:

7 799.21 (3) (b) In counties in which a circuit court commissioner is assigned to  
8 assist in small claims matters, except in eviction actions and actions for relief from

10 shall be made at the time a demand for trial is filed. If the party requesting a trial  
11 does not request a jury trial, any other party may request a jury trial by filing the  
12 request with the court and mailing copies to all other parties within 15 days from the  
13 date of mailing of the demand for trial or the date on which personal notice of demand  
14 is given, whichever is applicable. If no party demands a trial by jury, the right to trial

20 eviction or action for relief from extrajudicial eviction the attorney fees taxable shall

21 be \$10 plus such sum as is taxable under par. (a) on account of the recovery of  
22 damages.

23 **SECTION 12.** 799.27 (1) of the statutes is amended to read:

24 799.27 (1) ON REQUEST. Except in eviction actions and actions for relief from  
25 extrajudicial eviction, a party who appears on the return date shall be given, on  
1 request, an adjournment of at least 7 days, or such longer period as the court grants.  
2 In eviction actions and actions for relief from extrajudicial eviction, no adjournments  
3 shall be granted except for cause shown under sub. (2) and (3), unless with the  
4 consent of the plaintiff.

5 **SECTION 13.** 799.47 of the statutes is created to read:

6 **799.47 Actions for relief from extrajudicial evictions. (1) WHEN**  
7 **COMMENCED.** A civil action for relief from extrajudicial eviction may be commenced  
8 by a person entitled to the possession of real property if a landlord or landlord's agent  
9 has removed or attempted to remove the person or the person's belongings from the  
10 real property by any method other than by an action under s. 799.40.

11 **(2) JOINDER OF OTHER CLAIMS.** The plaintiff may join with the claim for  
12 restitution of the premises or other injunction any other claim against the defendant  
13 arising out of the defendant's extrajudicial eviction of the plaintiff.

14 **(3) ORDER FOR JUDGMENT.** If the court finds that the plaintiff is entitled to  
15 possession of the premises, the court shall immediately enter an order for judgment  
16 for the restitution of the premises to the plaintiff. If an additional cause of action is  
17 joined under sub. (2) and the plaintiff prevails thereon, the court shall enter  
18 judgment for such other relief as the court orders. A court may grant an injunction  
19 against a person that has removed or attempted to remove a person entitled to the  
20 possession of real property or the person's belongings from the real property by any

21 method other than by an action under s. 799.40. Chapter 813 governs any temporary  
22 or interlocutory injunction or ex parte restraining order in an action under this  
23 section. Judgment shall be entered accordingly as provided in s. 799.24.
