ELECTION OF SENATORS AND REPRESENTATIVES IN CONGRESS, AND ELECTORS OF PRESIDENT AND VICE PRESIDENT.

9.01 Election of representative in congress. A representative in the congress of the United States shall be chosen in each of the congressional districts into which the state is or shall be divided, at the general election in the year one thousand eight hundred and ninety-eight and every two years thereafter.

9.02 Election of United States senator. (1) A senator in the congress of the United States shall be chosen at the general election in the year one thousand nine hundred and fourteen and every six years thereafter and also in the year one thousand nine hundred and sixteen and every six years thereafter.

(2) The names of all persons nominated for the office of United States senator shall be printed on the ballot provided in subsection (1) of section 6.23 in substantially the manner and form indicated in the annexed form "A" provided in subdivision (a) of subsection (17) of section 6.23. All provisions of the statutes relating to the preparation, printing, distribution, voting, counting and returning of ballots used at general elections for state and county offices shall, as far as applicable and not inconsistent herewith, apply to the election of United States senators.

9.04 Presidential electors; election. At the general election next preceding the time fixed for the choice of president and vice president of the United States, there shall be elected, by general ticket, as many electors of president and vice president as this state may be entitled to elect senators and representatives in congress.

9.05 Presidential electors; certificate of election. The secretary of state shall prepare three lists of the names of the electors, procure thereto the signature of the governor, affix the great seal of the state to the same, and deliver such certificates thus signed to one of the electors on or before the first Monday after the second Wednesday in December. 9.06 Meeting of presidential electors. The electors of president and vice president shall convene at the capitol of this state on the first Monday after the second Wednesday in December next after their election, at the hour of twelve o'clock, noon, of that day, and if there shall be any vacancy in the office of an elector, occasioned by death, refusal to act, neglect to attend or other cause, the electors present shall immediately proceed to fill by ballot, and by plurality of votes, such vacancy in the electoral college; and when all the electors shall appear, or the vacancies shall have been filled as above provided, they shall proceed to perform the duties required of such electors by the constitution and laws of the United States.
