WORK OF THE 2019-20 JOINT LEGISLATIVE COUNCIL

The Joint Legislative Council held two meetings between January 1, 2019 and June 30, 2020 (the period covered by this report), on the following dates:

- February 13, 2019
- March 6, 2019

The proposals introduced by the Joint Legislative Council and the Law Revision Committee are discussed in Part II of this report.

Council Study Committees

During the period covered by this report, two statutory study committees met, and nine study committees were established to report to the 2019-20 Joint Legislative Council.

The statutory committees were:

- Law Revision Committee
- State-Tribal Relations

The study committees were:

Organization and Activities of the Joint Legislative Council

Twenty-two legislators serve on the Joint Legislative Council: 11 from the Senate; and 11 from the Assembly. Twelve of these members are *ex officio* and serve on the Council because of their positions as legislative leaders. These members are: the speaker of the Assembly; the president of the Senate; the speaker pro tempore of the Assembly; president pro tempore of the Senate; the majority and minority leaders of the Assembly and Senate; the two co-chairs of the Joint Committee on Finance (JCF); and the ranking minority member of JCF from each house. The other 10 members are appointed in the same manner as members of standing committees are appointed: five are appointed by the chair of the Senate Committee on Organization; and five by the speaker of the Assembly. [s. 13.81 (1), Stats.]

The Joint Legislative Council establishes study committees during the recess periods of the Legislature. The council determines which studies will be conducted and establishes committees to review, study, and propose recommendations. These studies generally are of four types:

- Intensive examination of problems that are expected to confront a succeeding Legislature.
- Review of controversial subjects that were unresolved by the previous Legislature.
- Major codifications and revisions of portions of the law.

- Methods of improving the operation and effectiveness of state agencies.

There are two continuing council committees currently required by statute: the Special Committee on State-Tribal Relations; and the Law Revision Committee. [s. 13.83, Stats.]

Each committee submits a report to the Joint Legislative Council. In almost all cases, the report makes recommendations for legislative changes based upon its study. The council reviews the recommendations for legislation and introduces those approved by a majority of the membership of the council (12 votes).

Operation of Legislative Council Staff

The Joint Legislative Council and the council's study committees are staffed by a nonpartisan legislative service agency. The Legislative Council staff serves in the unclassified service. As of June 30, 2020, the council staff included, in addition to the Director, 17 attorneys, two analysts, and five administrative staff.

The basic duties of the staff include:

Services for the council and its committees. The Legislative Council staff provides services for the Joint Legislative Council and its study committees.

Services for legislative committees. The Legislative Council staff provides nonpartisan legal analysis and policy research for standing committees and their subcommittees, select or special committees of the Legislature, and a number of joint statutory committees. The Legislative Council staff serves as the secretariat for the Joint Committee on Legislative Organization and for the Joint Committee on Employment Relations.

Services for individual legislators. Upon request, the Legislative Council staff provides legal analysis and other research to individual legislators.

Administrative Rules Clearinghouse. Prior to any public hearing on a proposed rule, or prior to notification of the chief clerks if no hearing is required, the agency proposing the rule must submit the proposed rule to the Legislative Council staff for review. The Legislative Council staff is required to review the rule for various technical requirements, such as statutory authority for promulgation of the rule and the form and clarity of the rule and issue a clearinghouse report with its comments on the rule. The Legislative Council staff also works with and assists the appropriate standing committees throughout the rule-making process. Summary of Committee Activity

The Joint Legislative Council established the Study Committee on Alcohol Beverages Enforcement and appointed the chairperson by an April 9, 2018 mail ballot. The committee's assignment was the following:

...review the structure and staffing of the Department of Revenue's efforts to enforce Wisconsin's alcohol beverage laws found in ch. 125, Stats., and compare the regulatory and enforcement structure of alcohol law enforcement efforts in other states. The committee shall further examine whether establishments and venues that serve alcohol are properly licensed to do so. The committee may recommend legislation that ensures the proper enforcement of alcohol beverage laws, including increased clarity and education.

Membership of the study committee was appointed by a June 4, 2018 mail ballot. Final committee membership consisted of two Senators, two Representatives, and 11 public members. A list of the committee membership can be found in the **Appendix** to this report.

Actions of the Joint Legislative Council

At its March 6, 2019 meeting, the Joint Legislative Council voted to introduce the following legislation:

- 2019 Assembly Bill 92, relating to enforcement of alcohol beverage laws against out-of-state alcohol beverage shippers and direct wine shippers.

The Joint Legislative Council established the Study Committee on Bail and Conditions of Pretrial Release and appointed the chairperson by an April 9, 2018 mail ballot. The committee's assignment was the following:

...review Wisconsin's pretrial release system, including considerations for courts in imposing monetary bail and for denying pretrial release. The committee shall review relevant Wisconsin constitutional and statutory provisions and best practices implemented by Wisconsin counties and other states, including use of risk assessment tools for informing pretrial detention decisions. The committee is directed to recommend legislation regarding bail and pretrial release that enhances public safety, respects constitutional rights of the accused, considers costs to local governments, and incorporates evidence-based strategies.

Membership of the study committee, appointed by a June 4, 2018 mail ballot, consisted of two Senators, three Representatives, and nine public members. Final committee membership can be found in the **Appendix** to this report.

The Joint Legislative Council established the Study Committee on Child Placement and Support and appointed the chairperson by an April 9, 2018 mail ballot. The committee's assignment was the following:

...review the standards under current law for determining periods of physical placement and child support obligations. The committee may consider alternatives to current law concerning physical placement, including a rebuttable presumption that equal placement is in the child's best interest. The committee may also consider whether the current standard for determining child support adequately and equitably provides for the support of children and alternative models for determining child support obligations.

Membership of the study committee was appointed by a June 4, 2018 mail ballot. Final committee membership consisted of two Senators, three Representatives, and eight public members. A list of the final committee membership can be found in the **Appendix** to this report.

Summary of Committee Activity

The Joint Legislative Council established the Study Committee on Direct Primary Care and appointed the chairperson by an April 9, 2018 mail ballot. The committee's assignment was the following:

...review the emergence of “direct primary care” as a healthcare delivery option and assess its potential impact on the healthcare delivery system and health outcomes in the state. The committee shall recommend legislation regarding requirements for direct primary care arrangements in the private market. In addition, the committee is directed to review options for incorporation of direct primary care arrangements into the fee-for-service and managed-care parts of the Medical Assistance (MA) program and assess its potential impact on the functionality, efficiency, and effectiveness of service delivery and health outcomes in both parts of the MA program. The committee shall recommend legislation regarding a direct primary care pilot in the MA program, including an evaluation of the impact of the pilot on service delivery and health outcomes for participating individuals and the MA program as a whole.

Membership of the study committee, appointed by a June 4, 2018 mail ballot, consisted of three Senators, three Representatives, and eight public members. A list of the committee membership can be found in the **Appendix** to this report.

Summary of Committee Activity

The Joint Legislative Council established the Study Committee on the Identification and Management of Dyslexia and appointed the chairperson by an April 9, 2018 mail ballot. The committee's assignment was the following:

...review current screening, identification, school intervention, and treatment protocols for dyslexia in K-12 schools; to examine the effects of current state statutes and regulations on literacy outcomes for students with dyslexia; and to evaluate the effects of dyslexia on literacy outcomes in the state. The committee shall study recent research on evidence-based instructional techniques for students with dyslexia; determine the components and costs of successful dyslexia education practices and laws in other states; and identify institutional obstacles to academic attainment for these students. The committee shall consider legislation to implement screening for characteristics of dyslexia in early grades; to ensure that reading instruction and intervention practices incorporate relevant research findings from the University of Wisconsin; to improve the partnership between parents, educators, counselors, and others on early identification and effective interventions for dyslexic learners; and to enhance statewide access to updated resources and training on dyslexic education.

Membership of the study committee, appointed by June 4 and June 28, 2018 mail ballots, consisted of two Senators, three Representatives, and six public members. A list of the committee membership can be found in the **Appendix** to this report.

Summary of Committee Activity

The Law Revision Committee was first created by the Legislative Council at its May 30, 1980 meeting, as a statutory committee of the Council, pursuant to s. 13.83 (1), Stats., as created by Ch. 204, Laws of 1979. The membership of the committee is to be appointed in "each biennium." Members were most recently appointed on April 24, 2019. The membership of the committee consisted of four Senators and four Representatives. A list of the committee membership can be found in the **Appendix** to this report.

The statute directs the committee to:

1. Review remedial legislation based on non-substantive changes recommended by agencies;
2. Review court decisions and opinions of the Attorney General which state that a statute is unconstitutional, ambiguous, or otherwise in need of revision; and
3. Review correction bills and minor substantive revision bills prepared by the Legislative Reference Bureau.

The committee is also directed to introduce the bills prepared on these subjects directly, not through the Council, into the Legislature.
