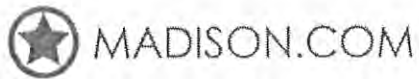
This letter is to express support for the consideration being given to crimes that occur at gas stations. Over the past three years, our office has reviewed over one hundred charges involving incidents where gas stations throughout Milwaukee County have been victimized by criminal behavior. We have issued criminal charges and obtained convictions in the overwhelming majority of these incidents. These incidents do not include the many occasions when a gas station is used as a meeting place for individuals who then depart a station to engage in criminal activity in a surrounding neighborhood.

We would be happy to work with the Legislature to identify ways to make gas stations safer by adding deterrents to criminal activity at these places commonly used by the public. Assembly Bill 357 is a good foundation for that discussion.

A man injured in a possible shooting on E. Washington Avenue was released from the hospital, according to police.

At approximately 1:25 a.m., police reported to calls from 3019 E. Washington Avenue, a Mobil Gas Station, about men fighting, possible shots fired and a fleeing vehicle.

Police made a traffic stop nearby, where they located a victim with a non-lethal gunshot wound, Madison police said in a report.

The victim was taken to a local hospital, treated and released, and the investigation is still on-going, according to Madison police sergeant Jason Sweeney.

Lawmaker, D.A. Visit Sikh Temple in Oak Creek

Officials pledge help for the Sikh community, which has been increasingly victimized by crime.

State Rep. Josh Zepnick and District Attorney John Chisholm visited 7512 S. Howell Ave. on Sunday to discuss public safety issues in the Sikh community.

Satwant Singh Kaleka, president of the Sikh Temple, requested the meeting after the July 4 melee in Milwaukee's Riverwest neighborhood, according to a news release from Zepnick's office. Those incidents included the looting of at least one Sikh-owned business.

Singh Kaleka told local officials that what was seen in Riverwest has become too common at gas stations and convenience stores owned by members of the Sikh community. Many businesses and workers have been the victims of robberies and vandalism, he said.

Sikh Indians, because of religious tradition, wear turbans to cover their uncut hair and have longer beards. They are often mistaken for Muslims and have been the targets of racially-motivated crimes by anti-Muslim people and groups, as evidenced by the epithets shouted at them, according to the news release.

Chisholm and Zepnick spoke to the congregation on Sunday, expressing support of the Sikh community's concerns and pledging to work to improve safety.

"The Sikh community is a strong and positive force within Milwaukee's diverse ethnic population," Zepnick said. "It's unacceptable that they, or any law-abiding business owner, be the target of what appears to be an escalating pattern against certain businesses and segments of the population."

Zepnick, a Democrat from Milwaukee, also said he would introduce legislation that would increase penalties for crimes committed on the premises of gas stations. Oak Creek's state representative, Republican Mark Honadel, for perpetrators of mob-like attacks.

"My hope is that this just the beginning of an open dialogue that will ... help make our neighborhoods and streets safer," Zepnick said, "as well as ensure the safety of people working in any public-serving business."

26-year-old woman shot dead at gas pump, has car stolen

MILWAUKEE (WITI) — 26-year-old Sheresa ‘Shay’ Moore was shot and killed on Wednesday, August 7th at a Citgo station near Sherman and Capitol as she filled her car with gas.

Family members say Moore, a local rap artist, was on her way home from the studio the night she was shot.

“She is smiling down to all of us right now,” said Moore’s aunt, Joyce Nelson. “It’s devastating to us all and it hurts so bad.”

Surveillance video from the Citgo station shows Moore pumping gas when she is approached by a man. Moore backs up before she is shot and falls to the ground. The suspect then drives off in her vehicle.

“I’m thinking it’s a carjacking. A lot of us were thinking it was set up for someone to just single her out,” said Nelson.

Moore’s friends and family have many unanswered questions, mainly why someone would shoot their loved one so brazenly.

“She was a beautiful young lady and kind and nice to everyone so I couldn’t understand why someone would just kill her like that,” said Nelson.

Lekeysha Wells, the victim’s cousin, says Moore will be remembered for her passion for music.

“That’s all she believed in, that’s all she worked on,” said Wells.

No one has been taken into custody in connection with the shooting. Loved ones are asking the public for help.

“Anybody out here, anybody at the gas station that night, even if they are scared, you don’t have to say a name just please help,” said Wells.

The family will hold a vigil to honor Moore on Saturday, August 10th at 3 p.m. near Sherman and Capitol, where the shooting happened.

Police identify Waukesha gas station clerk killed in shooting; reward offered

Waukesha - A \$3,000 reward is being offered for information that leads to the arrest of a suspect in the shooting death early Tuesday of 56-year-old gas station clerk Nayyer M. Rana.

A customer saw Rana on the floor of the Broadway Petro Mart, 114 E. Broadway, about 4:20 a.m. and called police, Capt. Ron Oremus said.

Rana died of apparent gunshot wounds before emergency units arrived, Oremus said in a news release.

Robbery is being investigated as a possible motive in the slaying, but police have not determined how much, if any, money is missing.

No suspect is in custody, and there is no description of a suspect, police said.

The reward is being offered by family and friends of Rana. Police are asking anyone with information about the killing to call the department at (262) 524-3818.

Rana is survived by his wife and four children.

Attorney Michael P. Maxwell, who announced the reward on behalf of Rana's family and friends, said in a news release that the family is asking for privacy "as they deal with the grief of the loss of a beloved husband and father."

Friends of Rana's family also are establishing a memorial fund for the family to help with expenses, Maxwell said. Contributions to the fund can be made at any Landmark Credit Union branch.

Waukesha police said Tuesday that the gas station also was robbed about 1 a.m. May 14 but noted in a news release that there is no known connection between that robbery and Tuesday's shooting death.

In the May 14 robbery, a man with a black handgun robbed the store. Rana was not working at the time, the news release says.

Police also said Jimmy's Grotto restaurant, 314 E. Main St., a few blocks from the gas station, was robbed just before midnight May 10. Investigators also don't know whether this robbery is related to the homicide.

The suspects in the two earlier robberies are different, according to descriptions police supplied.

In the May 14 gas station robbery, the suspect was described as a black man, possibly about 25, 6 feet tall and 140 pounds. The suspect was wearing a black ski mask, dark jeans and a black jersey or hooded sweat shirt.

In the May 10 restaurant robbery, the suspect was described as a white or Hispanic man, age 20 to 25, about 5-foot-7 and 170 pounds. The suspect was wearing a gray hooded sweat shirt, jeans, a black baseball hat with a red emblem, black gloves with white skeletons on them, and a white and black bandanna covering his face, police said.

Oremus said Tuesday's shooting death was the first homicide this year in Waukesha. There was one in 2010, also a shooting death.
