RE: Testimony in Support of Assembly Bill 57
DATE: May 13, 2015

Chairman Cowles, and members of the committee, thank you for hearing AB 57 on the proof of financial responsibility for landfills.

This bipartisan bill is designed to give counties more control and flexibility to save money and keep costs low to citizens and businesses.

The Department of Natural Resources (DNR) requires landfills to have proof of financial responsibility to cover the long-term care and eventual closure of landfills. These accounts are long-term investments and range in the amount of several thousand dollars to tens of millions. The funds are controlled by elected county treasurers and managed by professional portfolio managers. The DNR currently allows landfills to invest in securities issued by the federal government.

This bill will allow landfills additional safe options for investment, such as:

- securities issued by the federal government
- debt securities issued by an instrumentality of the federal government that have the highest rating assigned by a nationally recognized rating agency
- bonds issued by the State of Wisconsin
- corporate bonds that have the highest rating assigned by a nationally recognized rating agency.

These options allow funds to earn a higher interest rate and fulfill the landfill's financial responsibility sooner.

With my bill, landfills will rely less on tipping fees thereby freeing up revenue for county and municipal landfills and potentially lowering tipping fees to citizens and businesses.

Dina Mumford, the Outagamie County Treasurer, brought this to my attention when I first took office in the Assembly. The Outagamie County Landfill Trust in my district could earn an additional \$150,000 by increasing their interest yield by 1% based off of their fund balance of approximately \$15,000,000.

I urge you to support this common-sense bill. Thank you for your time and consideration.

Senator Lasee's Testimony

Senate Committee on Natural Resources & Energy Public Hearing, May 13, 2015

Assembly Bill 57

The Wisconsin Department of Natural Resources (DNR) requires landfill operators to provide proof of financial responsibility to cover the upkeep and eventual closure of a landfill. This protects taxpayers and the public by providing a level of insurance against problems which may arise in the future.

Currently, this mandated savings account has a restricted set of options on the types of investments which can be made with the funds. The current low-yield options, while positive, provide less gains than other safe, higher-yield options could be providing.

This bipartisan bill gives additional investment options for these funds and is designed to allow local governments and landfill operators the ability generate a greater return on the money they are required to hold.

This will give local governments more flexibility and control to increase savings yields, keep costs low, and reduce the burden on residents and local businesses.

Current law only allows the following investment option:

- Securities issued by the federal government

This bill will allow additional low-risk, higher yield options for investment:

- Debt securities issued by an instrumentality of the federal government that have the highest rating assigned by S&P, Moody's and other highly regarded raters
- Bonds issued by the State of Wisconsin
- Corporate bonds that have the highest rating assigned by a nationally recognized rating agency (only up to 50% of the total)

These additional low-risk investment options allow funds to earn a higher interest rate and fulfill the landfill's financial responsibility sooner generating millions of dollars in higher investment earners across the state. This will allow for less reliance on tipping fees and may even drive down costs for users.

This bi-partisan bill passed the Assembly Committee 13-0 and passed on the Assembly Floor with a voice vote. I urge you to join me in support of this common-sense legislation to help local governments do more with less.
