Chairman Wanggaard and Members of the Senate Judiciary and Public Safety Committee:

Thank you for the opportunity to testify in support of Assembly Bill 666. I am very pleased to bring forward this common sense, bi-partisan legislation with Sen. Risser and Sen. Taylor to more effectively address the crime of sexual abuse of an animal by increasing the penalty to a felony and increasing penalties for repeat offenses, and making a technical change to the definition of sexual contact with an animal to prohibit perpetrators from using any body part or object on an animal for sexual gratification, not just their sex organ, closing a loophole that has unfortunately been exploited. These changes were drafted in consultation with and at the request of district attorneys, law enforcement agencies, farmers, and animal advocates.

A study of 44,000 adult sex offenders found that prior sexual abuse of animals is the number one behavioral predictor for sexual abuse of a child, and individuals who sexually abuse animals are very frequently violent, predatory sex offenders who share many common traits with pedophiles. In addition, 37% of sexually violent juvenile offenders are reported to have sexually abused animals, and 95 percent of juveniles who had reported engaging in animal sexual assault had also sexually assaulted individuals. In one jurisdiction in Virginia, of ten adult males convicted of crimes related to bestiality, eight had also been involved in sexual crimes involving children (child pornography, soliciting sex from a minor).

This bill further prohibits abusers from participating in certain state licensed programs such as foster care and operating a child care service, and prohibits them from owning animals or working with them. They must also surrender any animals in their possession and are required to undergo a psychological assessment. The legislation also prohibits trafficking or advertising animals for sex, engaging in sexual contact with animals in the presence of a minor or coercing minors to engage in sexual contact with animals. Sexual abuse of animals is currently a felony in twenty three states.

I am pleased to note that the Wisconsin State Horse Council, Badger State Sheriffs Association, Wisconsin Sheriffs and Deputy Sheriffs Association, Wisconsin Veterinary Medical Association,



Thank you for holding this public hearing on Assembly Bill 666, bipartisan legislation that would heighten the penalty for sexual abuse of animals.

AB 666 is necessary to provide a stronger deterrent and punishment for sexually abusing animals. A list of cases in Wisconsin, compiled by experts on the matter and provided to the Assembly Committee on Criminal Justice and Public Safety, details the grisly and disturbing accounts of sexual abuse and mistreatment of animals in our state. As can be inferred from these Wisconsin cases, our current laws are not serving as a strong enough deterrent or punishment for this serious crime.

AB 666 would increase the penalties for sexual abuse of animals to felony charges, and increase the felony classifications for subsequent violations. Currently, this crime is a Class A misdemeanor.

AB 666 was passed out of the Assembly Committee on Criminal Justice and Public Safety unanimously and was passed by the Assembly by voice vote on February 15<sup>th</sup> of this year. I look forward to this committee recommending passage of AB 666 so that the Senate may take swift action in moving this important bill forward this session.

As the Senate author of this bipartisan Assembly bill, I appreciate the Committee's consideration of AB 666 and would be happy to answer any questions you may have.

Written Testimony in Support of Senate Bill 802/Assembly Bill 666
Presented to the Senate Committee on Judiciary and Public Safety

Honorable Chairman Wanggaard, Vice-Chair Testin, and Senators Risser, Taylor, and Stroebel:

On behalf of The Humane Society of the United States (HSUS), the nation's largest animal protection organization, and our Wisconsin supporters, I urge you to vote in favor of S.B. 802/A.B. 666.

I recognize that this bill raises an uncomfortable subject that decent people don't like to discuss, and humor is often employed to deflect from conversation. But the matter this bill addresses is no joke. Animal sexual abuse is a serious crime, often perpetrated by repeat offenders who extend their criminal activity to human beings.

Here in Wisconsin an individual by the name of Sterling Rachwal has put a notorious face to animal sexual abuse for more than three decades; he's a recidivist in every sense of the word. It's because of Rachwal's repeated crimes that the Wisconsin public and many members of our state law enforcement have become aware of animal sexual abuse and the inability of our current law to adequately respond.

But S.B. 802/A.B. 666 is not about one individual; thousands of people nationwide, including here in Wisconsin, solicit or offer animals for sex every year. Ads posted on Craigslist and bestiality websites indicate that the sexual abuse of animals is happening in every area of our state, urban and rural. On one popular bestiality forum, the most recent Wisconsin "roll call," dated March 4, 2018, has 125 replies and has been viewed more than 8500 times.

We know that animal sexual abuse is linked to human crime and cruelty. Extensive case history shows that bestiality has strong ties to pedophilia; in fact, researchers suggest that bestiality is the single largest risk factor and strongest predictor of increased risk for committing child sexual abuse.

The FBI has found high rates of sexual assault of animals in the backgrounds of serial sexual homicide predators, which is why bestiality and other forms of animal cruelty are now tracked as a Group A offense in the National Incident Based Reporting System, the same category as rape and murder.

The Wisconsin legislature decided decades ago to prohibit the sexual abuse of animals. As times have changed, the language addressing animal sexual abuse in our current law, Ch. 944, has become outdated and is no longer sufficient to prosecute the variety of crimes related to the sexual abuse of animals. This has caused cases to be dismissed, overturned on appeal, or not able to be charged at all.

# Strengthen Wisconsin's Law on Animal Sexual Abuse!

### What is animal sexual abuse?

It is the sexual molestation of an animal by a human. Animal sexual abuse, like rape, is the eroticization of violence, control and exploitation.

### Why does it matter?

Animal sexual abuse is the single strongest predictor of increased risk for committing child sexual abuse. In a study of over 44,000 adult male sex offenders, researchers concluded that animal sexual abuse is the number one risk factor and the strongest predictor of increased risk for sexual abuse of a child.

Some studies have found high rates of sexual assault of animals in the backgrounds of serial sexual homicide perpetrators. This is one reason why bestiality and other forms of animal cruelty are now tracked by the FBI as a Group A offense in the National Incident Based Reporting System, in the same category as rape and murder.

### Isn't it already illegal?

Wisconsin Chapter 994, Crimes Against Sexual Morality, makes it a crime for anyone to commit an act of sexual gratification using his or her sex organ, mouth, or anus and the sex organ, mouth, or anus of an animal. Only prohibiting contact with a sex organ is a major loophole in the law that has caused convictions to be overturned on appeal.

In addition, Wisconsin's animal cruelty law only applies in cases where there is provable physical injury to the animal. Many acts of animal sexual abuse are filmed and discovered well after the incident occurs, so the requisite animal or medical evidence to substantiate physical injury cannot be recovered.

Finally, animals, like women and children, are trafficked, sold, and traded for sex and frequently used in the pornography industry. Trafficking animals for sex is not currently prohibited in Wisconsin.


Establishing animal sexual abuse as a separate crime allows law enforcement to identify potentially dangerous sexual predators in their community.

### **AB 666:**

- Prohibits engaging in sexual contact with animals with any part of the body or an object;
- Prohibits promoting, trafficking, advertising, or soliciting animals for sex;
- Prohibits engaging in sexual contact with animals in the presence of a minor or coercing others;
- Increases the penalty from misdemeanor to a felony;
- Requires the court to order the convicted person to refrain from contact with animals and surrender any animals in their possession;
- Requires psychological assessment;
- Exempts veterinary procedures, accepted animal husbandry and animal care, artificial insemination, and conformation judging.

As a field researcher and subject matter expert on animal sexual abuse and exploitation, I am writing in support of Assembly Bill 666 which is currently before the committee on Criminal Justice and Public Safety.

I have thirteen years' experience in collection, analysis, and dissemination of bestiality-related information, fifteen years' experience in the shelter and rehabilitation of animals seized in criminal proceedings, and eight years' experience in assisting law enforcement and prosecutors with bestiality investigations and convictions. In addition to conducting original research, I have contributed to or authored numerous publications, and recently completed a large-scale study on bestiality arrests in the U.S. over the past 45 years. There is additional information on my website: <a href="http://mjennyedwards.com">http://mjennyedwards.com</a>, including a copy of my *curriculum vitae*.

There are several misconceptions about animal sexual abuse. Chief among them are the notion that it is a minor crime that occurs only rarely, that animals are not generally injured, and that it is a solitary event perpetrated by someone with a mental illness. None of these notions are supported by the facts.

Bestiality is a complex crime, the full impact and extent of which is unknown. Virtually all statistics related to bestiality are artificially low and may create a false sense of security that "it never happens in my district." Like human sex crimes, only a tiny percentage of animal sexual assaults are ever reported, and even when reported, charges are often not filed, dismissed, pleaded down to a lesser crime, or treated as a misdemeanor not worthy of jail time. The result is the nature and number of these offenses are minimized or hidden altogether.

There is growing evidence that bestiality may be a lifelong behavior and not just something that happens rarely or is easily controlled. While the sexual attraction of people to animals is considered abnormal, it is not considered a mental health disorder, and no treatment has been proven effective. Animal sexual abuse and exploitation also does not happen in a vacuum. The Internet has made it extremely easy for offenders to connect with one another to share information, contacts, pornography, and victims. The result is that offenders have frequently been arrested in multiple jurisdictions, in distant states, and often in concert with another offender.

There are direct, measurable links between animal sexual abuse and other forms of criminal behavior. Animal sexual abuse is more a form of sexual assault than a form of animal cruelty, and research suggests that more than 30% of animal sex abusers also offend against children and adults. The crimes that most often co-occur are child pornography, interpersonal violence, drug possession, and trespass.

### A sampling of Wisconsin cases demonstrates the above points:

Much attention has been paid recently to Sterling Rachwal, a 55-year-old Wisconsin man who has been
arrested or hospitalized repeatedly since 1982 for violent and sometimes deadly sexual assaults on horses in
multiple counties across the state.

- Janesville resident Barry Herbeck tortured and killed a puppy and five cats, one of whom he sodomized. Herbeck was previously convicted of raping his 6-year-old stepdaughter.
- Tod Bergemann of Brown County has been arrested multiple times for sexual assaults, including the sodomy or rape of his sister, two foster brothers, a 2-year-old toddler, and the family dog. At least one assault involved the coercion of another person to have sex with the dog.
- Nicholas Bradley was arrested in Dodge County after he was caught sodomizing his girlfriend's dog. The following year he moved to Alaska where he was arrested for sexually assaulting a 14-year-old girl.
- Mackenzie Behrman, an 18-year-old from Manitowoc County, sexually assaulted a girl under the age of 13, and videotaped himself having sex with two different dogs.
- Two young men in Eau Claire County John Bullock and Damonta Jones raped an unconscious young woman with a pet snake. Both men had prior criminal records.
- Last year, Christopher Ehlenfeldt of Portage County was arrested and found to have the largest child porn stash in history. Like numerous child porn collectors, many images were of children being sexually assaulted by animals as well as adults.

Thank you for your support of Assy. 666. This bill ensures the rest of the country that Wisconsin takes the issue of animal sexual abuse and exploitation seriously, thus protecting its citizens and animals from predatory sexual practices.
