**Wisconsin Department of Public Instruction
Testimony in Support of Assembly Bill 261**

I want to thank Chairman Thiesfeldt and members of the committee for the opportunity to testify today in support of Assembly Bill 261 (AB 261). My name is Chanell Crawford, and I am the director of the Parental Education Options Team (PEO) at the Department of Public Instruction (DPI). The PEO team administers and provides technical assistance related to a number of program areas, including the Private School Choice Programs (Choice), the Special Needs Scholarship Program, and charter schools.

AB 261 extends DPI's authority to waive requirements and establish alternative deadlines for schools participating in the Choice and the Special Needs Scholarship Program and for independent charter schools.

While school districts have an existing mechanism for requesting statutory requirements or administrative rules be waived under Wis. Stat. s. 118.38, there is no similar process for private schools or independent charter schools. The authority granted under 2019 Wisconsin Act 185 to the DPI during the 2019-20 school year, allowed the DPI to work with private schools and independent charter schools to waive requirements and shift deadlines based on COVID-related needs and issues.

For example, for each choice program, the school must identify which of the open application periods the school will accept applications. Students may only apply to a school during a participating private school's open application periods. The Milwaukee Parental Choice Program (MPCP) has open application periods from February through January, and the Racine Parental Choice Program (RPCP) has available open application periods from February through September. Schools participating in the MPCP or RPCP may choose all or some of the open application periods and must select these periods by January 10 as part of the Intent to Participate. The DPI heard from private schools participating in the Racine Parental Choice Program (RPCP) and Milwaukee Parental Choice Program (MPCP) that, had they known in January 2020 that they would be contending with the conditions of the pandemic, the schools would have identified additional open application periods during which they would accept applications for the 2020-21 school year. Establishing an alternative deadline through the waiver authority, by which RPCP and MPCP schools could identify which application periods they would participate in, allowed those schools to add application periods, which limited some of the impact COVID had on the application process for those MPCP and RPCP participating schools.

Given that schools have continued to be impacted by COVID in the 2020-21 school year, the DPI believes the extension of DPI's authority in this bill will allow the agency to continue to be responsive to the COVID-related needs of private schools participating in the Choice and Special Needs Scholarship Program and independent charter schools.

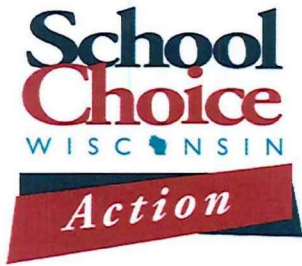

Requirements Being Waived for the Independent Charter Schools

1. For any schools that included 4-year-old kindergarten pupils in the 0.6 full-time equivalent category on the third Friday in September or second Friday in January enrollment reported under s. 118.40 (2r) (e) or s. 118.40 (2x) (e), waive the requirement that the school provide at least 87.5 hours of 4-year-old kindergarten outreach activities for the 2019-20 school year.
2. For any schools that included 4-year-old kindergarten pupils in the 0.6 full-time equivalent category on the third Friday in September or second Friday in January enrollment reported under s. 118.40 (2r) (e) or s. 118.40 (2x) (e), waive the requirement that the auditor test whether the 4-year-old kindergarten program provided at least 87.5 hours of 4-year-old kindergarten outreach activities for the 2019-20 school year.
3. Public Hearing on Assembly Bill 261

Thank you, Chairwoman Darling and members of the Education committee, for the opportunity to testify today in support of Assembly Bill 302 (AB 261). I am here representing School Choice Wisconsin Action (SCWA) as their Government Affairs Consultant. We are here testifying with the Department of Public Instruction to highlight the work both organizations have done to find solutions during this pandemic for administration of the Parental Choice Programs.

AB 261 extends by one additional year the waiver authority found under 2019 Wisconsin Act 185 to the DPI which applied to the 2019-20 school year. In partnership with DPI, SCWA and DPI also drafted a Memorandum of Understanding (MOU) around specific requirements where this authority was to be used. The success of that process is what brings us back here today. We are still identifying items for this year's MOU and continue talks with the Department. However, with the recent influx of federal dollars, that process is not quite complete. We anticipate finalizing that agreement very soon.

We are supportive of the one-year extension found in AB 261 and I am happy to take any questions.

This letter is to express our support of SB302 and AB261. Seton Catholic Schools supports 10 schools located primarily in the city of Milwaukee, with over 2,400 students. A majority of our students are economically disadvantaged and we have had to raise money from private donors to fund student Chromebooks, Internet access and technology support to keep students learning. Our dedicated teachers have often worked without breaks for lunch or prep time during the day to meet the full needs of our students including COVID safety in the classroom and school

Among the many accomplishments of the Seton team during the pandemic are:

- O Delivery of 211,000 meals to students in our neighborhoods at the end of the spring trimester
- O Being among the first schools to have in-person instruction plans approved by the Milwaukee Health Department
- O Offering parents the choice of in-person or digital instruction for 2020-21
- O Developing concurrent instruction capabilities for teachers to engage both their in-person and digital students as an integrated classroom community
- O Ensuring that every Seton student has a laptop and home internet access to succeed
- O Continuation of MAP testing to measure student progress and implementation of plans to overcome gaps

Throughout this pandemic, we are doing our best to meet the requirements of participation in the Parental Choice Programs. But with staff often unable to meet and collaborate in person, many of our processes have been difficult to execute with periodic quarantines required for individual pods, schools and/or grade levels.

Due to these and the many more challenges this school year has required us to address, we fully support SB302 and AB261 to provide the Department of Public Instruction with the authority to waive state education statutes, and rules. The per pupil cost of education at our schools is far less than most public schools. Without this waiver authority, our schools may not be able to receive the voucher funds applicable to the students we have been educating – which would negatively impact our schools' financial viability.

Dear Chairman Thiesfeldt,

Thank you for your communication regarding transportation reimbursement funding for bussing this 2020-21 school year for our Choice students. With an approved re-opening plan through the Milwaukee Health Department in August, 2020, we (Cross Trainers Academy) were able to open and hold in-person school all year (August 2020-May 2021).

Our transportation reimbursement total from MPS for the 2019-20 school year (last year) was \$74,057, or \$8,228 per month (this covered 93 eligible CTA families for the school year/9 months).

Our transportation reimbursement total from MPS for this 2020-21 school year was \$0. We were informed in a written letter from MPS that they (MPS) would not be providing any transportation reimbursement to our school this year due to the fact that they were not providing transportation for their own students (during the time THEY were in remote/virtual learning, DESPITE the fact that we (CTA) were in fact open for in-person learning all school year and providing bus transportation for our students.

The purpose of this letter is to provide written testimony relating to waiver bill SB302, the department of public instruction's waiver authority related to parental choice programs, the Special Needs Scholarship Program, and independent charter schools. This testimony specifically relates to K4 Outreach in a virtual world.

Messmer Catholic Schools is a K-12 school serving more than 1,200 students in the City of Milwaukee. The area that our students and their families live in has been extremely hard hit in many ways by the COVID-19 pandemic. They live in some of the areas most affected by COVID cases and struggle to continue working due to that and the many jobs lost due to the conditions of the pandemic. For these reasons, families have been working very hard to assist their children in what this year has been a virtual, hybrid and moving into a four day a week educational model.

Messmer has arranged for far more than the 87.5 hours of outreach for our 44 K-4 students and their parents this year. The activities have been adapted and changed throughout the year to try to make the activities flexible in dates and times that would allow them to be completed while ensuring the health and safety of all. There was much success with in-person activities in prior years that took place in our elementary buildings at various times throughout the school year and summer.

Despite the planning to make activities available to our K4 families, they have not been utilized except for a few parents and their K4 students. This is a direct symptom of the fact that these families are overwhelmed by the circumstances of the pandemic. Messmer Catholic Schools has already begun to plan K4 outreach for the 21-22 year using all the feedback from families from this year. Although we expect that many of our families will continue to be overwhelmed, we do expect that we will be able to continue to adapt and provide the flexibility that will be needed to carry out the K4 outreach plans. We hope to be able to provide in-person activities at points during the 21-22 school year and summer in addition to the activities that can be done on Zoom meetings and at home.
