Subject: Testimony in Support of Senate Bill 336

Thank you Chairman Testin and members of the committee for the opportunity to testify in favor of Senate Bill 336. I appreciate your time and consideration of this important piece of legislation.

We're living in a strange time where people are feeling compelled to share their private medical information, and even if they aren't, employers are asking for it. Some of the major cities in the United States are requiring citizens to share their private medical information to go into a restaurant or gym. There is an unprecedented amount of pressure to receive an experimental therapy, and if you don't, you have to follow a different set of rules. Health is not a one-size-fits-all approach and Wisconsinites shouldn't be discriminated for receiving or declining a vaccine.

Currently, vaccination status is not a protected characteristic under anti-discrimination law. Protections to prevent discrimination on the basis of a person's vaccine status is lacking in Wisconsin. There are no employment protections, or protections to ensure access to housing, medical care, higher education, life or health insurance for persons who have chosen not to receive one or more vaccines in Wisconsin law. Senate Bill 336 is a comprehensive bill that will prevent discrimination of any kind against persons who have chosen not to receive one or more vaccines.

This means both vaccinated and unvaccinated individuals will not be discriminated against, and prevented from equal access to education, services, employment, academia and more. Discrimination of any kind is unacceptable, and yet discrimination, bullying and shaming of people who have chosen to forgo one of more vaccinations is becoming acceptable by many in the media, public health, and large institutions like our schools. Protections are needed to stop this practice.

While the U.S. Department of Labor, Occupational Safety and Health Administration better known as OSHA allows employees to decline Hepatitis B Vaccines. OSHA and many labor unions have expressed opposition to the annual flu shot policies that do not include religious and/or personal objection exemptions. There are far too many gaps in protection for employees to refuse vaccines for work. Senate Bill 336 would ensure protection for all workers.

For nearly 20 years, I have served as a healthcare provider in my community. Although, I believe that the care I provide will help people live healthier, more enjoyable and longer lives. The care I provide may even improve their immunity or help their body adapt and cope with stressors and disease. There are risks in any health treatment. The treatment I might offer may not be appropriate for every individual and every condition. When a patient comes to me for treatment, they are informed of the benefits and risk associated with it. They are then able to choose for themselves what treatment they receive or

don't receive. As much as I would like to see a treatment that could truly change the health of my community, state and country mandated for everyone, it is wrong. Ultimately it is up the patient, the individual to choose for themselves.

Senate Bill 336 is a comprehensive bill that would prevent discrimination of any kind against persons who have chosen not to receive one or more vaccines.

Dear Senator Testin and the members of the Senate Committee on Health. My name is Anneka Bengston and I am speaking in support of SB336.

I have an older brother that was injured by vaccines as a child and I have seen firsthand the risk that comes with vaccination. As his sister, there are concerns that I could have the same reactions and long-term health problems that he suffers from.

There is no vaccine exemption available for people like me who has seen someone closely related to them suffer from the effects of a bad vaccine reaction, even though we are likely at the same risk. Children and families like mine who are at risk of vaccine injury are being discriminated against in all areas of society including places like concerts, movies, and restaurants in some cities in this country. No one seems to care about people who have previously been hurt by vaccines or about their family members. It seems to me that they are okay that some people get hurt, and because it didn't happen to them, they don't matter.

When I was little I wanted to be a nurse and help people but, unfortunately, I won't be able to go to school to become a nurse without taking every single recommended vaccine. But that's not the only career that I can't do without getting a vaccine. I worry that I won't be able to go to college in the future without getting all the recommended vaccines. This also makes me concerned that many careers will no longer be open to me. I worry if I will be able to travel out of state or whether I will even be allowed to leave the country in the future. I have cousins in Canada who I am very close with but I haven't been able to see them for over 2 years now. I often wonder if I'll ever be able to see them again.

I was taught by my parents that discrimination against people is wrong. I have learned in my history books on how, in the past, we treated people poorly and even harmed people because they looked different or believed differently. And that this was bad. I wish more people would learn from history and see that all discrimination is wrong, including discrimination against people who want to make vaccine choices that are best for their own health, based on their own personal risks.

Thank you for your time and I hope that you will protect me by voting to support SB336.

**TESTIMONY IN SUPPORT OF SENATE BILLS 383, 336, 337, AND 342, AND ASSEMBLY BILL 299
SENATE COMMITTEE ON HEALTH
WEDNESDAY, JANUARY 12, 2022
JULAIN K. APPLING, PRESIDENT**

Thank you, Chairman Testin and committee members, for the opportunity to testify on Senate Bill 383 and its Assembly companion, AB 299, as well as Senate Bills 336, 337 and 342. Wisconsin Family Action supports these bills that address a critical issue in our state. We are grateful for the authors who have taken the lead on these bills and for the co-sponsors who have stepped up to lend support.

At the outset, I want to be perfectly clear that we take no position on whether or not an individual should take the COVID-19 vaccine or any other vaccine for that matter. We are not in any way dismissive of the virus. Like virtually everyone in our state, we have been affected by its reach in our own families and organization. We are not making any kind of judgment in this testimony as to the efficacy of or the necessity for the vaccine. That is not the point or purpose of these bills.

The bills taken as a grouping each do what we believe needs to be done: prohibit any effort by any entity to require any COVID-19 vaccination or to require proof of one having had said vaccine.

One issue we do have with any vaccine, including the COVID-19 vaccine, is whether or not the research and/or testing has involved the use of the cells or tissue or any body part of an aborted baby. And that reality does play into our position on these bills because people should be able to choose not to take a vaccine that in its development violates a person's core, deep-seated beliefs and convictions. That choice should be protected—and we believe it is—by the First Amendment of the US Constitution and by Article I, Section 18 of our Wisconsin Constitution, which gives unequivocal protection to the right of conscience:

Article I, Section 18, Wisconsin Constitution

*Freedom of worship; liberty of conscience; state religion; public funds. SECTION 18. [As amended Nov. 1982] The right of every person to worship Almighty God according to the dictates of conscience shall never be infringed; nor shall any person be compelled to attend, erect or support any place of worship, or to maintain any ministry, without consent; **nor shall any control of, or interference with, the rights of conscience be permitted,** or any preference be given by law to any religious establishments or modes of worship; nor shall any money be drawn from the treasury for the benefit of religious societies, or religious or theological seminaries. [1979 J.R. 36, 1981 J.R. 29, vote Nov. 1982] [emphasis added]*

We believe deciding to take a vaccine is a personal matter, even a matter of conscience. Individuals might also involve a doctor in their decision, but even that choice is up to the individual. No vaccine should ever be forced on people, not even during a declared “emergency.” As you will hear today and as you know, vaccines are potent pharmaceuticals. Every vaccine has a risk-benefit associated with it, and people are entitled to determine for themselves whether they want to assume the risk for any benefit the vaccine may bring.

In a country where the rule of law is supposed to be at the heart of how we do government, we cannot set aside the Constitution, either the US Constitution or our state constitution, even during a health crisis. To the contrary, constitutions are meant to ensure protections even during the worst of times. Giving government

officials at any level of government the authority to mandate a vaccine or proof of vaccination threatens the rights of individuals. These bills appropriately restrict that authority and ensure that the rule of law is respected.

When it comes to employers, we firmly believe employees do not forego their constitutional or legal rights when they sign on to work at a given company. Receiving a vaccine or having to provide proof of vaccination should not be a condition of employment. Consider the precedent that would be set if this prohibition does not happen or if such discrimination is permitted. Right now, COVID-19 is the virus we are fighting. Tomorrow it could be something different for which scientists develop a vaccine. We could have situations where a person would need to get multiple vaccines just to have a job. To not prohibit this vaccine mandate and having to provide proof of vaccination would put us on the proverbial slippery slope—which seems to always take us further and take us faster than we ever imagined.

For those who would say that Wisconsin has three vaccine exemption options and that should be sufficient to cover the current vaccine situation, thereby making these bills unnecessary, we respond that we have learned over the last year that once a state or local official declares an “emergency,” safeguards and options we thought were available can be quickly set aside, legally or not. We have no confidence that these exemptions apply in general, say, to an employee or to an individual citizen seeking service at a business, or that if they do apply more generally, that they would be upheld during a declared emergency. Simply put, we need these specific safeguards.

Frankly, our only concern with all of these bills, with the exception of SB 336, is that they are specific to the COVID-19 vaccine. We believe they should be more generally applicable so that we do not have to revisit this issue for any future health crisis we face in the state. SB 336 appropriately makes vaccination status non-specific so that we are not back here next year seeking similar protections from possible vaccination mandates and/or proof of such vaccination regarding another virus or disease.

Individuals and families are being asked to deal with a great deal right now. They should not have to be concerned that they will be violating a law if they decide not to take the COVID-19 vaccine and therefore have no proof of such vaccination, and they should not have to be concerned that their employment would be in jeopardy should they decline the vaccine. Enacting the measures included in these bills would ensure authority would not be abused, would uphold the rule of law, and would help families avoid additional stress. We urge this committee to pass these bills quickly and move them to the full Senate where we hope they will receive swift passage.

Thank you for your attention and thoughtful consideration of our position on these bills.

My name is Judith Jolly and I am a resident of Pardeeville Wisconsin. I am a registered nurse with a Bachelor of Science in nursing and the Wisconsin State Director and the Director of Diseases and Vaccine Website Content for the National Vaccine Information Center, the nation's oldest vaccine safety and informed consent advocacy organization. For 40 years, the national charitable non-profit NVIC has been dedicated to preventing vaccine injuries and deaths through public education and advocating for informed consent protections in medical policies and public health laws.

I am testifying in support of SB336 and would like to thank Representative Moses and Senator Jacque and all of the co-sponsors for introducing this legislation. NVIC also supports SB 383/AB299 and SB337, however, as SB336 is the most comprehensive bill, its passage will ensure that discrimination based on vaccination status does not happen here in Wisconsin.

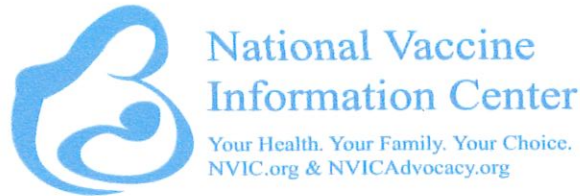
SB336 is about preventing discrimination. Discrimination against a subset of the population who have chosen to make a personal medical decision to decline one or more vaccine products based on multiple factors that may include personal or family health history, personal risk versus benefit, personal or religious beliefs, and more. Moreover, this bill does not prevent anyone who wants to get a vaccine from getting a vaccine. It simply offers some much-needed protections in the law to protect individuals who wish to decline one or more vaccines and ensures that they are not discriminated against and excluded from society.

Vaccination is a medical procedure that comes with risks. For some, the risk of this procedure outweighs any potential benefit, and in most cases, we do not know in advance who will be seriously injured or die as a result of vaccination.¹ This is why vaccination, like every other invasive medical procedure, must be a choice, and one where the choice does not come with a penalty. Discrimination against people who chose not to get one or more vaccine, whether it be the COVID-19 shot, or another vaccine, is real. Almost daily, we hear media stories, and statements from public health officials, shaming, bullying, and marginalizing individuals and families who do not wish to receive each and every CDC recommended vaccine. Individuals who dare question vaccine safety or effectiveness, or who chose to decline a vaccine product are given the "anti-vaccine" label, dismissed as conspiracy theorists, called public health threats, denied medical care, censored on social media, and denied educational, employment, and career opportunities.

Can we not learn from our history? When we create a two-tier system, we open the door to the dehumanizing of a subset of our population. History has shown that nothing good comes from these actions. Our history books are filled with stories of injustices and atrocities that began with discriminatory policies. Legislators have a duty to Wisconsin citizens to ensure that we do not evolve into a society that denies rights to individuals based on their willingness to receive a pharmaceutical product.

Here in the U.S., we now have many individuals facing termination from their employment for refusing to receive a liability-free pharmaceutical product that comes with a risk of injury and even death. Health care workers, many with natural immunity because they worked to care for the sick and dying during the COVID-19 pandemic, are losing their livelihoods and the ability to provide for their families because they do not wish to receive a COVID-19 vaccine.² At the same time hospitals are allowing vaccinated workers infected with COVID-19 to work due to staffing shortages.^{3 4} We have cities denying entry to restaurants, theaters, and businesses to individuals, children and families who do not show proof of vaccination.^{5 6 7} Colleges and universities are denying an education⁸ to our healthy young people because they do not wish to receive a product that has been shown to cause serious injuries⁹ and for which the risk of this product likely outweighs any potential benefit.

The CDC has acknowledged that the COVID-19 vaccine is unable to stop transmission and infection. This means that vaccinated people can still get sick and transmit the illness to others.¹⁰ However, because they have chosen to receive this product, they are given more rights than those who have declined this product. More rights than even individuals who have natural immunity and have not been shown to be capable of transmitting illness to others.¹¹



Some in government have made statement that employers should have the right to decide what is best for their business. But what is often missing in this discussion is the fact that vaccination is a medical procedure that changes the body and can cause permanent long-term health issues. Requiring a vaccine is not the same as requiring, for example, that an employee wear steel-toe boots or a hair net. Those items can be removed upon leaving a place of employment. The vaccine cannot be removed from the body after leaving work. Sadly, in some cases, harms suffered by these products can be devastating enough to impact a person for the rest of their life.¹²

The COVID-19 vaccine, like most other vaccines, are liability-free products.¹³ If you are injured or die as a result, you can't sue the vaccine maker or even the entity that mandated the product in a court of law. Instead, you must file for compensation and hope that you are one of the "lucky" ones who will be successful in receiving support for the damages suffered.¹⁴ In the past 12 months, over 4,700 individuals have filed for damages associated with COVID-19 vaccines and therapeutics; however, only 4 claims have been processed. Of these 4 claims, 3 have been denied, and the one approved claim has yet to be compensated because the government is waiting until every other payor source has paid out before determining whether there are any outstanding expenses that will require compensation. One can only guess how long it will take to process the backlog of claims given that they are currently processing approximately one claim every three months.¹⁵

While vaccine exemptions for medical, religious, or personal reasons are available to daycare and K to 12 school students (Chapter 252.04), and during a declared State of Emergency (Chapter 252.041), protections to prevent **discrimination** on the basis of a person's vaccine status are lacking in Wisconsin. There are currently no employment protections, or protections to ensure access to housing, medical care, life or health insurance, or higher education for persons who have chosen not to receive one or more vaccines in Wisconsin law. Without protections under the law, there are no guarantees. This is why a comprehensive vaccine discrimination bill is needed now.

If we as a society are not free to decide what pharmaceutical products we permit to be injected into ourselves and into our children, we are not free. Discrimination against individuals who do not wish to receive every single CDC recommended vaccine is real and it's a growing problem. It will not stop with the COVID-19 vaccine. You have the opportunity today to stop discrimination by voting in favor of SB336.

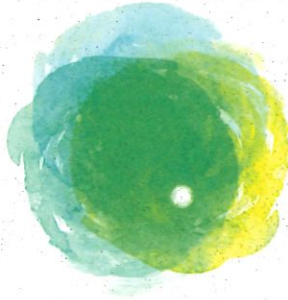

Good morning, Chairman Testin and Committee members. My name is Matt Sande and I serve as director of legislation for Pro-Life Wisconsin (PLW). Thank you for this opportunity to express our support for Assembly Bill 299/Senate Bill 383 and Senate Bill(s) 336, 337, and 342, legislation that prohibits vaccine discrimination against Wisconsin citizens.

Some of the bills (SB 336 & SB 337) apply generally to all vaccines and all epidemics, and some (AB 299/SB 383 and SB 342) only to those associated with the 2019 novel coronavirus. We prefer the former, particularly SB 336 which provides the most comprehensive protection against vaccine discrimination. But the remaining three bills are a good step in the right direction and will set a good precedent. Accordingly, we support passage of all four bills.

In the summer and fall of 2020, as Operation Warp Speed raced forward in the production and deployment of safe and effective vaccines for the novel coronavirus, it was imperative that the pro-life movement lay down firm ethical parameters around the effort. Accordingly, on October 13, 2020, the national Personhood Alliance (PA) published its official position on vaccine ethics, the culmination of two months of work by PA affiliate representatives from eight states, both Catholic and evangelical, and independent physician reviewers including Alan B. Moy, MD, President and Scientific Director of the John Paul II Medical Research Institute in Iowa.

As a founding board member of the Personhood Alliance, I participated in crafting the position throughout August and September 2020 as a working member of the PA Vaccine Ethics Committee. Our position was formally approved by the PA Board of Directors and subsequently by the PLW Board of Directors.

The Personhood Alliance/Pro-Life Wisconsin vaccine ethics position 1) opposes the production and testing of vaccines using the remains of aborted human beings, and 2) opposes forced or coerced vaccination. Concerning coercion, our position specifically

“affirms the rights of all people to refuse medical treatment and to reject violations of their and their family members’ bodily integrity, moral conscience, and Constitutional protections through forced or coerced vaccines.”

Assembly Bill 299/Senate Bill 383 and Senate Bill(s) 336, 337, and 342 all reinforce our vaccine ethics position. For the many Wisconsinites who earnestly avoid any entanglement in the abortion industry, discriminating against them for refusing a vaccine produced from or tested using aborted fetal cells is repugnant – a total violation of conscience. The Pfizer/BioNTech, Moderna, and Johnson & Johnson Covid-19 vaccine development and deployment are a case in point. While both the Pfizer and Moderna vaccines were ethically derived/produced, both were unethically tested using HEK293 aborted fetal cells harvested from the kidney of a preborn baby aborted in the Netherlands in 1973. The Janssen/Johnson & Johnson Covid-19 vaccine used the abortion-derived cell line PER.C6 in its development and production. PER.C6 is a proprietary cell line owned by Janssen, a subsidiary of Johnson & Johnson, that was developed from the retinal cells of an 18-week-old aborted fetus in 1985. Are there ethical alternatives? Dr. Alan B. Moy questioned, “Could Pfizer [and Moderna] have tested and validated their vaccine without using HEK293? The answer is yes. There are other immortalized human and non-immortalized human cell lines that could have been used. I have highlighted other alternative human cell lines that are ethically non-controversial.” These include HEPG2 (immortalized human cell line from a hepatic cancer), HeLA (immortalized human cervical cell line), alveolar cells (cells derived from induced pluripotent stem cells), and human adult stem cells.

This list of ethically derived human cell lines is readily available and can be used at all steps in the process. Importantly, the John Paul II Institute headed by Dr. Moy is developing its own ethically produced and tested coronavirus vaccine using perinatal human umbilical cord and placental cells. These are adult-type stem cells that do not involve the creation or destruction of human embryos. CureVac of Germany is also producing an ethical mRNA COVID-19 vaccine. To be sure, there were and are ethical coronavirus vaccines in the pipeline.

The Personhood Alliance/Pro-Life Wisconsin standard is high, eschewing both unethical *production and testing*, because if we continue to allow the use of aborted human beings in therapeutic development, *in any manner*, legal abortion will continue unabated. Government and the pharmaceutical industry will never stop using aborted babies in vaccine development and medical research unless the faithful, unequivocally, say no to their end products. The connection between abortion, biomedical science, and human trafficking must be completely severed. **Many pro-life Wisconsinites reject the use of the Pfizer, Moderna, and Janssen/Johnson & Johnson COVID-19 vaccines and vehemently oppose any discriminatory coercion of their use.**

And whether a vaccine is ethically produced and tested, it is unethical, and highly offensive, for the state, a business, or any entity to discriminate against individuals who may strongly resist it for a variety of health, conscience, religious, or personal reasons. Vaccines can kill or severely harm people with auto-immune disorders, who may not even know they have such disorders. The fact that vaccine injury and death is an acknowledged medical reality demands that a person’s choice to avoid the health risks for himself/herself be respected.

We are entering a time of unprecedented coercion. COVID-19 vaccination is required to engage in the daily activities of American life in many parts of the country, including our nation's capital. Privileges for the vaccinated; punishments for the non-vaccinated. Such requirements are discriminatory and divisive, dividing citizens and families into "separate but equal" groups. One would think we are long beyond this type of segregation in America. Last year the Archdiocese of Chicago required that parishioners may only return to Mass unmasked if they could provide "proof of vaccination."

Persuasion is the way vaccine campaigns must be conducted, especially in America where our civil liberties are sacrosanct...where personal autonomy and medical informed consent are bedrock principles. Coercion severely undermines the public trust and tramples on our cherished rights, including our First Amendment right to freely exercise our religious beliefs, our Fourteenth Amendment guarantees of liberty, equal protection, and due process of law, and our Article 1, Section 18 Wisconsin constitutional guarantee of freedom of worship and liberty of conscience.

These four bills protect our right to make our own health decisions, our right to follow our consciences, and our right to freely exchange in commerce. We urge you to recommend them for passage in the full Senate.

The Girl Who Stood Up By Sitting Down

Wednesday, September 29, 2021

I took Mikaila in to her pediatrician for her regularly scheduled well child check. We went to the wrong location and had to reschedule for a later time, so she ended up missing the whole day of school. The doctor gave her a clean bill of health and signed her athletic form to participate in sports at school.

When I returned home with Mikaila, I received a call from her dad stating that the school told him our daughter needed to quarantine due to a close contact that took place on Monday. She could return to school after 8 days with a negative covid test, or 14 days without one. No alternative to education would be offered. This also meant she would miss her first high school homecoming dance.

I sat Mikaila down in the kitchen and told her she couldn't go to school. She became very upset, because she loves school, and said, "but we have our fitness testing in Phy Ed, and I'm doing really well!" She was overwhelmed at the thought of the piles of homework she would have to get through on her own with no instruction. Then she said, "Why do I have to quarantine when the kids who are vaccinated don't? I had Covid already and I have antibodies! Plus, the doctor just said I'm fine, and that supposed contact was three days ago! I'm not sick!"

I explained to her that the school is trying to keep her and the other kids safe, and they're doing the best they can in these strange times. Mikaila said it was unfair that she was being treated differently than the kids who had the vaccine, because she has natural immunity. I agreed with her that it was a double standard.

Mikaila sat in silence at the counter with her head in her hands for several minutes. Then she looked up at me with fire in her eyes and said, "I'm going to school. I have just as much of a right to my education as the vaccinated kids." I've seen this look before, and I knew she had made up her mind. I encourage her to be independent and to use critical thinking skills. I couldn't argue with her statements because they actually made sense! She was putting me in the middle and I had to choose a side. Before doing that, I decided to gather more information.

I called the local police department and explained what my daughter wanted to do. I asked, "What is the worst that could happen?" They informed me that she wouldn't be committing any crime, so they wouldn't be involved. There was no law being broken.

CDC guidelines are only guidelines to help others make educated decisions. The public health mandates are not laws, and we are no longer in a state of emergency. The actions taken by public health need to be reasonable.

I reached out to Kyle Yudes, a man I knew was working on getting policy changed for freedom of choice in personal health decisions. He offered confirmation (he is not a lawyer, and this was only to help educate me) that she would not be breaking any laws. He also suggested that there should be a physician's affidavit and court order for her to legally be forced to quarantine. I looked up the information and found that he was correct.

I sat down with Mikaila and told her what I had found. I told her that her friends might not support her, teachers might treat her differently, she may not even get into the school in the first place, and that if she did she would probably be called to the principal's office. I told her that the school could decide to

An emergency school board meeting was called, and that evening I received a call from Leiska Giese, the head of the Public Health Department for Eau Claire County. Her voice was harsh and critical when I answered the phone. She told me who was calling, but the cordial introduction of calls with the school were not there. She informed me that my daughter needed to quarantine and that it is against the law for her not to. I informed her that there is no law stating you can quarantine the healthy, so without a physician's affidavit and court order, she would be attending school.

Giese's words became sharp and cut off aggressively as she informed me that if my daughter went to school the next day, she would be removed by police, and then she would have to appear in front of a judge to receive her "punishment". I informed her I already spoke with the police who stated they would not get involved. She said she would be at my house in 30 minutes with a court order signed by a judge, and she would be escorted by the ECPD.

Approximately 1.5 hours later, my doorbell rang. I did not answer, and Mikaila knew what was coming and was hiding in her room upstairs so she wouldn't be seen. I looked out the window and did not see an Eau Claire PD squad car. Once she left, I found a piece of paper left between my screen door and front door. It was a letter signed by her, a nurse, stating that my daughter needed to quarantine. There was no court order.

I showed it to my daughter, so she would know that there was no court order, and asked her again if she wanted to pursue this. She said they were trying to intimidate her into backing down, and she would make her stand. I was shaking and couldn't sleep that night, but she slept like a rock, firm in her convictions.

Thursday, September 30, 2021

It was my 40th birthday. All I could think about was what Mikaila would have to go through at school that day, and all the persecution she could possibly receive. I was shaking and nearly vomited in the sink. Her dad and I both asked her again if she was sure she wanted to follow through with this, and she came back with a resounding yes. We were so nervous that everyone in my family, including me, forgot it was my birthday.

Mikaila said she now understood how Rosa Parks must have felt when she made her decision to stand up for herself and all the oppressed by sitting her butt in that seat on the bus and refusing to move because she deserved to be there. She felt butterflies in her stomach and fear of the unknown, and wondered if that was what this woman who made history with her stand felt that day. I told her that well behaved women never make history, and she giggled.

Mikaila put on an oversized hoodie because she was afraid the staff would be looking for her, and she planned to tuck her bright blonde hair inside and keep her head down "like a depressed teenager" to blend in. I dropped her off at the tunnel that goes under the road in front of the school so she would have time before entering the door to find a group to insert herself into to get in the front door without being spotted. I also have a sign on my car with my name on it, so they definitely would have spotted us. My heart was pounding as I saw her walking to the tunnel in a swarm of children, and just before she disappeared, she turned around to give me our secret "I love you" sign.

Driving home was nearly an out of body experience, and I couldn't even imagine what Mikaila must have been feeling. Then I got a text that she made it through the front doors. More panic.

ensure other kids knew she wasn't trying to put anyone at risk. I said to her, "I know you would never do this if you thought you were putting others in jeopardy".

My next text from Mikaila said "What happens at lunch time? What if they don't let me into the lunch line? What if they don't let me eat? (Crying emoji)". I reminded her that, "The principal already asked if there's anything you need. They'll make sure you have food".

To encourage her again, I made a Facebook post about the stand she was taking. The comments were generally very positive and encouraging. I told her to check it out, and said, "Keep hanging in there little one. This is a battle of the wills."

She responded, "Yep. I got this."

At this point I sent the principal an email stating that I understand the difficult position he is in, and wanted him to know that I said a prayer for him.

Text from Mikaila, "The principal is on the phone with a health person (Giese), and she said that if I push past him, I can be expelled!".

I asked if she meant pushing past him to leave the classroom. She was going to all of her classes, and the principal wasn't blocking her way, so this sounded to me like Giese was trying to get him to block her path so there would be reason to expel her. I felt that advising a principal in disciplinary action was completely outside her lane.

Mikaila said, "Yeah, I'm still going to all my classes. All of my classmates have been going to the library."

I told her, "Keep it up!". She responded, "Will do".

At this point Mikaila began to feel more confident. She said, "Already on my third class, this is fun! My health teacher was waiting for me to go there, and made sure I didn't talk to anyone." I told her that her actions were speaking for her.

Mikaila said, "I saw my Spanish teacher, and she looked at me for a long second, then said, 'Oh, you're back...' I could tell she was confused and upset. (Friend's name) is thinking of going to lunch with (other student's name) instead of staying with me. Throughout this I found that many of my friends are not loyal to me."

I told her they were scared and not to hold it against them, then sent her to my Instagram post to respond to all the people writing supportive statements about what she was doing. I have an international following on Instagram, so I said, "You aren't just making a stand for yourself and your school. People all over the world are following along and supporting you. You are inspiring the whole world right now."

I saw her responses begin to pop up on Instagram. Then she texted me, "This is definitely tough. My English teacher said, 'I hope you change your mind'". I offered encouragement.

Later, she said, "I only have 3 more classes! I'm in marketing right now, and it's really confusing because I wasn't here yesterday. The principal gave up on trying to get me to go to his office."

When Mikaila went to gym class, it was outside, so she was allowed to go. In Spanish, Mikaila is the star pupil, so the teacher insisted that she be allowed to attend in person with 6 feet of social distancing

Pixie entered the room and sat next to me. I gave her a big reassuring hug and said I was proud of her for standing up for what she believes in. She appeared nervous, but relaxed into my hug. Geise slid a court order across the table to me. There was no wet ink signature as it was signed electronically, and there was no physician's affidavit. It was signed by a nurse. The nurse was Geise. I questioned the legality of these documents, but they had four "police officers" next door willing to enforce it, and I was not willing to let that happen to my little girl. Their intimidation tactic worked, and I felt the need to protect her.

Rather than continuing to make a stand that we needed proper documentation, I chose to not have my child traumatized by being dragged out by police in front of all of her classmates. I consented to the quarantine and stated I would bring her home in my care, and we would follow the court order.

This was a Thursday. Geise stated that on Sunday Mikaila would have to take a Covid test, and that if it was negative, she could return to school Tuesday. Her alleged exposure was Monday.

Although any covid test would be accepted by the court, Geise stated that we should not get the home test (this one tends to have false negatives). She recommended that we get the rapid test (this one was recalled for having false positives). I was aware of these skewed results when she said it should be the rapid test, but I did not respond, knowing my daughter would not be taking that test anyway. She also informed us that she could place armed guards outside our house, and that she would be confined to our address. This was listed on the court order to quarantine.

The tension emanating from Geise was thick enough to cut with a knife. The staff appeared to be very uncomfortable around her. Maybe even scared? She did not smile the whole time, and sat upright in her chair, stiff as a board. I didn't feel like a person that she was talking to. I felt like a disease that needed to be eradicated. Needless to say, for a nurse, her bedside manner was lacking.

At the end of the meeting, I thanked Geise for her time. I also thanked the principal and superintendent for treating my daughter with respect as she made her stand. They reiterated that she was very respectful and an impressive young lady, which made me smile.

My friend Tom and I took Mikaila home without other students having their attention called to her situation. On the way out of the principal's office, we once again passed the four armed men in brown uniforms. All of that for a little girl who just wanted to go to school! The response from public health was not reasonable, and my daughter was healthy!

It was a beautiful day, and upon return home, Mikaila ran to the garage to hop on her bike. I had to stop her so that she wouldn't be potentially reported and apprehended for leaving our home. Her face fell as she realized the extent of her limitations. She said, "If I stay in the car can we go out for ice cream?" I told her she had to stay home, but I would get her ice cream. She earned it!

I thought it was odd that although we live in the same home, I was not ordered by public health to quarantine. If they believed she was such a risk that they brought four armed men, then why wasn't I considered a risk as well? None of this made any sense.

Since Mikaila did not receive instruction in her classes other than Spanish and gym, she was already overwhelmed with the homework she received. She did not understand how to do it, and that was only day one! I had to teach her all of her school subjects and was unable to perform my own work duties.

even talking about, and it would be dismissed. This was a completely different story than when Giese stated that my daughter would have to appear before a judge to be "punished". He also stated that he understands how difficult it can be communicating with Giese, and that I could speak with him instead because he is much easier to talk to. Was he struggling to communicate with her? Was he finding her difficult? Was he tired of dealing with her harshness and irrational actions?

The lawyer stated that if I was not able to secure counsel, then a public defense lawyer could be appointed. I asked him to make the referral in case I didn't hear back from any of the others on such short notice. Any lawyer worth their salt was not going to be available with one business day and a weekend's notice!

When the offices closed for the day and I could no longer make any calls, I realized that I had not eaten anything at all for the entire day. I tried to eat one of my favorite dishes, but it turned to ash in my mouth. Mikaila was also struggling to eat.

I turned to social media to check for any leads. I shared encouraging comments with my daughter, and her mood changed from melancholy to fired up. I was so proud of her, and she was proud of herself. We invited her dad over to help with homework while I handled social media. When they were finished, we all sat down in the living room to watch the I Heart Media report cast to the TV. Her dad and I were beaming with pride. O'Donnel attempted to play devil's advocate, but it wasn't very convincing as public health and the school board didn't respond to him. Mikaila was confused about that, and said she wasn't sure if he was on her side. I explained that media is not supposed to pick a side, they are supposed to present the news equally from all sides involved.

Mikaila's dad went home, and I tucked my daughter into bed. I went downstairs to continue looking for lawyers, and made a list of contacts for Monday morning. Once again, I was up until after midnight.

Saturday, October 2, 2021

We spent the day interviewing with various reporter. During the times in between, I was on social media posting events and seeking advice. I was also continuing my search for legal representation, and received a few emails stating that the lawyers had too large of a case load to take on ours. I was also researching covid, CDC guidelines and state laws, along with reviewing the constitution and federal laws.

I began organizing a rally in front of the court house for the time Mikaila was scheduled to be in court. Many like-minded people were reaching out to ask what they could do, and I hoped a showing of numbers could help influence policy change. Many of the others I reached out to were parents of kids in the school district, and I knew they would be respectful and peaceful in taking a stand.

In addition, I was searching for testing sites that would get us results before court on Tuesday. I put in a call to the Covid testing nurse line at every hospital, but they were so backed up that I did not receive any calls back. I also looked at Walgreens and CVS, but they were completely booked. Most websites showed that PCR test results could take four days, and that was time we could not afford. My fear was that the deadline was going to force us into taking the rapid test known for false positives! This took the entire day, and again, I was up until well after midnight researching in case we had to resort to a public defender.

Giese had seemed so confident that judge Harless would sign that court order within 30 minutes Friday evening. She said that this judge would "punish" my daughter. Was that judge in Giese's back pocket? Would she fight for a "punishment" despite the negative test? It seemed that every time I had an answer, I only came back with more questions.

I had been up early every morning since this began, and once again, was up until after midnight continuing my research. I had been neglecting my work duties, and emails were piling up, along with tasks I could not take the time to accomplish. I did receive notice that the court date was, in fact, moved to Tuesday.

Monday, October 4, 2021

So many days in a row of intense anxiety, and I was barely able to eat anything. I made coffee, and check emails. The court appointed attorney had emailed a response to the negative test! He said that Mikaila was not allowed to attend school despite the negative test, because she had to quarantine for 8 days, meaning she could not return until Tuesday. He submitted the negative test to Public Health, and hoped to hear back soon.

Mikaila spent the day furiously working on her homework, and trying to get it done before returning to school. Her grades automatically update online, and her GPA was already dropping.

Later in the day I received an email from the public defender stating that the case was dismissed. He attached the dismissal document. I felt relief rush over me, and when I relayed the message to Mikaila, she was grinning ear to ear.

Mikaila had booked herself an interview on a live radio show in Madison. I was on the show with her, and she told her story. It was a prideful moment as a mom to see my daughter spread her wings and find her voice.

Later, I received an email from the principal welcoming her back "with open arms". I informed him that she would be missing the first two hours of school, because she would be attending a human rights rally. I also thanked him for being kind to Mikaila.

That evening, we bought signs at the craft store. We decorated them with paint and markers. One said, "natural immunity > artificial immunity", the other said, "No law states the healthy can be quarantined". Mikaila also drew a syringe on a sweatshirt. She drew the words, "My body my choice".

I explained to Mikaila that "my body my choice" was from the campaign for abortions. She said, "Yeah, and they won! I'm not putting that vaccine in my body and they can't force me to!"

Several of the people planning to attend the rally contacted local news. The news stations stated that it was not news. We could only hope that rallying together would be enough.

Tuesday, October 5, 2021

My name is Kara Nitz and I am a wife and mother of 3 boys from Menomonee Falls, WI.

Thank you for the opportunity to speak in favor of Bills SB336, SB383, SB337 and SB342.

I have a teenage son with special needs. He enjoys sports, but is unable to play at the same level as his neurotypical peers. A few years ago, we found Special Olympics. Special Olympics has allowed him the opportunity to exercise, meet new friends, and excel on a team that he otherwise would not have had a chance. Recently, Special Olympics Wisconsin decided to exclude all athletes that are not vaccinated from joining in their team sports such as basketball. Why? Vaccinated people can get and transmit the virus, according to the CDC. I fully appreciate that some people with special needs are at higher risk for illness, and if they feel they need to be vaccinated in order to be healthy, then I encourage them to do so. But my son is not at risk. *And he is not sick.* As a matter of fact, COVID has made it through our household twice now and my son has been uninfected and unscathed by the exposures. COVID made its way into our home by way of exposure to an infected vaccinated person.

According to the Vaccine Adverse Event Reporting System, as of December 31, 2021, there have been 11,421 deaths and 833,978 total adverse events from the vaccine, including 12,234 life-threatening reactions. I am not willing to put him at risk of severe side effects or even death, when he is not otherwise at risk from COVID alone. *He is not sick.* His vaccination status alone has no effect on anyone else's risk of contracting COVID.

Thank you, Chairman Testin, and committee members for the opportunity to testify at the public hearing for SB383, SB336, and SB337. Never before in my own lifetime, has the legislative process, in my opinion, been more important.

My name is Tara Czachor. I am the wife of a veteran, mother of four, and I am the Co-Founder of Wisconsin United For Freedom. I have a Bachelors degree in Psychology and Human Development from the University of Wisconsin Green Bay, and I am here representing thousands of mothers and fathers, college students, medical professionals, alternative health care providers, etc., throughout Wisconsin, who simply believe that the government should stay out of the decisions we make for ourselves and our families, and that the reason our Government actually exists is in order to help Wisconsinites achieve their own American Dream.

I firstly, wanted to thank each and every author, co-author, and co-sponsor of these bills. The type of power and control seen by agencies, such as the Wisconsin Department of Health Services, without any accountability over the last year is unprecedented in our country's history. The closure of churches and schools, businesses being shut down which prevented employees from making a living, quarantining of healthy individuals, the illegal safer at home orders executed by our current Governor, have all been part of two years of horrific governmental overreach. SB 336, which we strongly support, is an all-inclusive bill which prohibits discrimination on the basis of vaccination status, which is defined in the bill as whether an individual has received one or more doses of a vaccine. The bill makes changes to various discrimination laws, such as:

1. The bill adds vaccination status as a prohibited basis for discrimination in the following areas: employment, housing, and the equal enjoyment of a public place of accommodation or amusement, or on the basis of a person's disability. Current law also requires certain state agencies, authorities, and corporations to include provisions in contracts they execute obliging the contractor to similarly not discriminate against any employee or applicant for employment.
2. The bill prohibits the University of Wisconsin System, the Technical College System, public elementary and secondary schools, and charter schools from discriminating against a student on the basis of the student's vaccination status. The bill also prohibits the UW System Board of Regents from investing gifts, grants, and bequests in companies that practice discrimination based on vaccination status.
3. The bill adds vaccination status as a prohibited basis for exclusion of an individual from jury duty.
4. The bill prohibits discrimination against an otherwise qualified person in the adoption of minor children because of the person's vaccination status.

5. The bill requires the heads of departments and independent agencies in the executive branch of state government to determine if there is discrimination on the basis of vaccination status and take remedial action regarding such discrimination.
6. The bill adds vaccination status as a prohibited basis of discrimination with regards to discrimination against an employee, prospective employee, patient, or resident of an approved treatment facility providing treatment of alcoholic, drug dependent, mentally ill, or developmentally disabled persons on several bases.
7. Current law prohibits discrimination on several bases in the provision of vocational rehabilitation or mental health services. The bill adds vaccination status to the prohibited bases of discrimination.

--Wisconsin United For Freedom wants to ensure those who need access to mental health services are not denied based on their vaccine status.

8. Current law prohibits state agency rules from discriminating against a person on several bases. The bill adds vaccination status as a prohibited basis of discrimination.
9. The bill prohibits an insurer from discriminating against an individual on the basis of vaccination status and also prohibits motor carriers, automobile insurers, transportation network companies, and real estate brokers and salespersons from discriminating against an individual on the basis of vaccination status.

My Great-Grandparents settled here from Switzerland, in 1934, to escape extremism. In fact, I just recently found out that my great-grandmother was quoted in a newspaper article. She was asked why they came to the United States of America. She said they came here because they wanted to escape the European Governmental overreach, and America, is where they chose to come. The reason we need the bills in this committee today, is because currently, there are no employment protections, or protections to ensure access to housing, medical care, higher education, or life or health insurance for people who have chosen not to receive one or more vaccines in Wisconsin state law. Because these protections are not in place, you have employers exerting their power and control over their employees, by trying to start a trend of mandates and coercion, which much of what they are doing, they have learned from all levels of our government. Not only that, but you have cases backlogging our court system to fight these unprecedented new rules.

We spend an exorbitant amount of time celebrating marginalized communities; and now we are openly chastising a group of people that are making their own sound decisions and encouraging hate towards this group. How can our elected officials encourage a form of discrimination when we're supposed to be progressive and forward thinking?

We have medical doctors and nurses contacting us in secrecy, because they are sincerely concerned with the Covid-19 vaccines and the safety issues they are seeing, but are fearful of retaliation, or in fear of losing their medical license if they come out and speak openly. They have seen other medical doctors who were silenced and censored these past two years, and that great personal threat, is a huge moral and ethical issue they are struggling through. We have college students, public and private, reaching out to us asking for guidance on these issues for their expensive college educations they're trying to receive. We have parents frantic that their children will be discriminated against if they choose against a medical procedure that they are working with their trusted healthcare provider on and making an informed medical decision. We are currently being bombarded with information about how everyone, young and old, should go and get the Covid-19 vaccine and all of the boosters that come with it. The Wisconsin DHS has spent millions of dollars on radio ads, including entire news segments encouraging vaccination.

What they are not doing, however, is discussing, or even mentioning, any of the potential risks. In fact, social media platforms are involved in playing their part in order to shape the narrative and censor real stories of injury following vaccination. They want their narrative to be that these EUA vaccines are perfectly safe and effective for absolutely everyone, and that there are zero risks. The medical conglomerates are doing the same, and I think are causing a huge awakening in distrust between the average American and their medical provider. When our medical professionals are not humble enough in acknowledging that there is indeed information out there that they are not aware of, and do not provide informed consent by sharing all the information with their patients, this is of grave concern. We need humbleness in healthcare again. We need common sense, and we need to simply pause, and take a step back, and have an open dialogue.

At what point is it acceptable for parents to question standard routine care provided by medical doctors? Is there a number of vaccines that need to be on the schedule that give us, as parents, the right to question? When I was born, the schedule was around 24 doses from birth to age 18. Now, it is 69 doses from birth to 18, and that does not include the new Emergency Use Authorization granted to the covid-19 vaccines for SARS-CoV2, or their boosters.²

I wanted to share some information regarding adverse events following Covid-19 vaccination. You can access the Vaccine Adverse Event Reporting System, also known as VAERS, data yourself by going to the CDC's website:

According to the latest data available, as of December 31, 2021, there have been 1,016,999 total adverse events reported, including 21,382 deaths, 36,758 cases of permanent disability, and over 224,000 hospitalizations and emergency room visits following COVID-19 vaccination, reported to the Vaccine Events Reporting System (VAERS). I would like to note that VAERS is a passive surveillance system in the United States that captures adverse events following vaccination, but is unable to prove causation (i.e. that the vaccine in question caused the adverse event or possible side effect). While there are issues with this reporting system – the CDC has refused to update the system and make it more efficient, more effective, and more forthcoming and transparent.

Many of us here today are trying to research and become as educated as possible so that we can make sound, educated medical decisions for ourselves and our families. Vaccines, like any medical procedures, do not come without risk, and one does not need to have a PhD in molecular biology or be a toxicologist to read scientific studies or research. I implore every single Wisconsinite to look into these issues with an open mind, and with the empowerment that you are competent and educated individuals, who have a right to make an informed medical decision, even if that decision goes against the narrative all over the news right now. If Public Health officials reported, and continue to report on every Covid-19 death, one has to ask oneself why they are not reporting on deaths following vaccine administration.

There is also an **undeniable underreporting** issue with VAERS, which is of significant importance as the agencies at the top of our country and state are continuing to dedicate millions of dollars to push these vaccines. It is entirely possible that serious reactions occurring after Covid-19 vaccine administration are significantly higher given that historically, vaccine reactions are rarely reported.

One of the most undeniable pieces of evidence regarding underreporting of vaccine injuries includes an Agency for Healthcare Research and Quality-funded study by Harvard Medical School which tracked reporting to VAERS over a three-year period at Harvard Pilgrim Health Care involving 715,000 patients and found that **“fewer than 1% of vaccine adverse events are reported.”**³ A U.S. House Report from the year 2000 similarly stated: “Former FDA Commissioner David A. Kessler has estimated that VAERS reports currently represent only a fraction of the serious adverse events.”⁴

Ignoring and casting aside these issues in the drive to vaccinate and promote vaccine confidence may eventually be the undoing of the very confidence the public health authorities seek to instill.

What I listed above, are just some of the reasons people might opt out of a medical procedure such as a vaccination, and is exactly why it is incredibly important for the passage of legislation protecting our choices in Wisconsin.

Wisconsin United For Freedom also supports SB383, though we would encourage an amendment to this bill to include not just Covid-19 vaccination, but all vaccinations. We support SB337, as well.

We are strong proponents for health freedom in our state. We believe in medical privacy. We believe that our medical decisions need to remain between ourselves and our trusted healthcare providers. We believe in equal treatment, in preserving our American dream, and we are against discriminatory policies becoming the norm. We believe in health choice, and we believe in informed consent.

It is imperative that the Wisconsin State Legislature help ensure fair and equal treatment of Wisconsinites, and our organization stands firmly on the side of equal treatment with regards to vaccine status.

To be extremely open and honest before this committee, we are extremely stunned and much of the time barely recognize what is occurring in our country right now. It is incredibly unfortunate that we are at a point in time where we need our State Legislature to help protect the fundamental rights we have as Americans to live freely, move around freely, and participate in living out our American Dream – whether vaccinated or not.

We strongly support SB336, as we believe it is the most inclusive and all-encompassing piece of legislation we have before us on this topic. We hear directly from fellow Wisconsinites on a daily basis, who are fighting hard to preserve their American way of life. These families want to wake up, get their kids ready for school, go to work, come home and make dinner, take their children to basketball practice, read bedtime stories, have a glass of wine, and go to bed. They want to attend a Green Bay Packer game on the weekend, - thank you Aaron Rodgers for standing in favor of health freedom, by the way. They want to go to an awesome supper club like Ishnala, or High Rock Café in Wisconsin Dells in the summer, and maybe tailgate at a Brewer game – all without fear of persecution over their vaccine status.

We must “follow the science,” and the science shows both vaccinated and those who opt out, are becoming infected with and transmitting COVID-19, and therefore, there should be equal treatment under the law.

10.2 Nonconformity and corrective action

10.2.1 When a nonconformity occurs, including any arising from complaints, the organization shall:

- a) react to the nonconformity and, as applicable:
 - 1) take action to control and correct it;
 - 2) deal with the consequences;
- b) evaluate the need for action to eliminate the cause(s) of the nonconformity, in order that it does not recur or occur elsewhere, by:
 - 1) reviewing and analysing the nonconformity;
 - 2) determining the causes of the nonconformity;
 - 3) determining if similar nonconformities exist, or could potentially occur;
- c) implement any action needed;
- d) review the effectiveness of any corrective action taken;
- e) update risks and opportunities determined during planning, if necessary;
- f) make changes to the quality management system, if necessary.

Corrective actions shall be appropriate to the effects of the nonconformities encountered.

10.2.2 The organization shall retain documented information as evidence of:

- a) the nature of the nonconformities and any subsequent actions taken;
- b) the results of any corrective action.

The pharmaceutical companies manufacturing the COVID-19 vaccination are NOT doing anything about the thousands and thousands of people on the VAERs report and probably the V-safe smart phone system report.

SB336 complies with the following Federal law that any person may accept or refuse administration of an emergency use product, Title 21 U.S.C. § 360bbb-3(e)(1)(A)(ii)(I-III) of the Federal Food, Drug, and Cosmetic Act, about products granted Emergency Usage Authorization (EUA):

Individuals to whom the product is administered are informed—

- (I) that the [DHHS] Secretary has authorized the emergency use of the product;
- (II) of the significant known and potential benefits and risks of such use, and of the extent to which such benefits and risks are unknown; and
- (III) of the option to accept or refuse administration of the product, of the consequences, if any, of refusing administration of the product, and of the alternatives to the product that are available and of their benefits and risks.

Dr Patricia Lee stated, "... The problem resides with the indiscriminate vaccination of all people irrespective of risks and benefits, the denial of the vaccine injuries that are occurring, and the lack of urgency in addressing these injuries even if they are to be recognized."

Hello, thank you Senator Testin for holding this hearing today. Thank you to the members of this committee for being here today to listen to our testimony. And thank you to the authors of the bills before us today. My name is Denise Brusveen, and I am a wife and mother of three children. I live in Columbia County, where I also serve on the Columbia County Board of Supervisors. On a professional level, I earned two bachelor of science degrees and my Master of Science degree from UW-Madison with a research emphasis in reproductive physiology and now own my own business. I am also the co-founder of Vaccine Choice Wisconsin.

We have taken a strong stance in favor of SB336, specifically, because it is the most comprehensive of all the bills before you today. Yes, the other bills also aim to protect our freedom and we support them, but they each only tackle one part of what SB336 covers. SB336 is a well thought out bill that not only addresses discrimination that began well before 2020, but it also looks to the future to prevent this type of discrimination from ever happening again.

As the lead author on two scientific journal articles, and a co-author on two others, with my research being cited more than 500 times by other researchers, I'd like to think I know a thing or two about the scientific process. And I find it insane that such narrow-minded, hard conclusions are being drawn before the studies are even completed or that recommendations are being made based on assumptions of safety vs actual studies. Someone, somewhere along the way forgot that the scientific process starts with a hypothesis with the willingness to be wrong. Then they need to carefully design their trial with an adequate number of test subjects and as little bias as possible – including a placebo group, including diverse test subjects, and then choosing appropriate, measurable outcomes. Then, AFTER their study is complete, they need to take adequate time to analyze their data, reflect on their findings, and only THEN draw a conclusion. After that conclusion is drawn, it does NOT mean that “the science is settled.”

Yet here we are... study data is being withheld from the public; some studies included only a few hundred study participants; COVID case numbers being released to the public are intentionally misleading; mix and match brands of COVID shots are being administered based on an assumption of safety; and some employers have already implemented COVID vaccine mandates based on this mess of data, or lack thereof.

So why, with so little safety or long-term data, is it that employers, businesses, and colleges are mandating this vaccine that still does not even have full FDA approval? I have heard the excuse that it is to protect themselves from liability. But if you all make it ILLEGAL for them to mandate it by passing SB336, then how can they be liable if it is out of their control?

I know that some of you may feel it is not the legislature's job to tell businesses what they can and cannot do. But you already do. You tell them which taxes they need to pay. You require various licenses and permits. You have state inspectors for restaurants, daycares, and even dairy farms. And you also have made it clear that employers cannot discriminate. They can't decline to hire women of childbearing age because they might request maternity leave...potentially multiple times. They can't hire only people of one race. And they can't discriminate based on religion.

They also can't request any private medical information in order to make a decision about employment – except, it seems, vaccines. Let's take the medical system for example, since some are saying it is imperative to mandate the COVID vaccine for hospital and clinic employees since they are likely to be in close contact with patients and could spread the virus to them. Currently, a doctor or nurse could have a hepatitis B infection, HIV, herpes, c. diff, or any other number of infections that they could infect their patients with. Yet the employer is not allowed to know this.

So, then, why is it ok not only for an employer to know someone's vaccination status, but then also to discriminate based on that status? Nursing students and employees at hospitals and clinics across our state have been denied the ability to opt out of the CDC-recommended schedule of vaccines, which includes an annual flu shot for years already. In some cases, they have been allowed to wear masks during flu season in lieu of the annual flu shot. But now they are facing indefinite masking or loss of employment if they choose to opt out of the COVID vaccine.

The discrimination isn't limited just to hospitals though, unfortunately. A teacher in my school district, last year, decided to do a poll in her classroom by asking all of her 7th grade students to raise their hand if they had already received the vaccine. The children who didn't raise their hands were instructed to tell their parents that they needed to get it as soon as possible. It is unconscionable to be putting children in this situation to be bullied, mocked, and discriminated against due to a medical decision that their parents have made for them.

This is not ok. Why is it that individuals are not allowed to make their own healthcare decisions? We are constantly told to listen to doctors for medical advice, yet hospital CEOs, liability insurance company employees, business and store owners and CEOs, school superintendents, and college presidents aren't doctors. So why are they being allowed to make sweeping medical decisions for their employees, students, and those who wish to do business or shop in their store? And why are they allowed to make one size fits all decisions based on only a single piece of medical history – vaccination status.

As a health practitioner myself, I could not imagine giving health advice to a client after knowing only this amount of information about them. But even if I had a full medical history, my approach to helping them achieve optimal health might be different from what another practitioner might suggest. This is

My name is Karen Sharkey and I am here to voice my *strong support* for Senate Bills 336, ~~333~~, 337, and 342.

To all of the representatives gathered here today, I would like to offer my sincere thanks for this opportunity in allowing We the People to be heard on these crucial bills.

I started out my last testimony at the Capitol the same way I will start today's because I believe it is of utmost importance:

At the beginning of this assembly, we all raised our right hands and pledged allegiance to our great nation's flag with a promise ending in the words:

"One nation, under God, indivisible, with liberty and justice for all".

And since I believe it is always helpful to define terms, let's do that first.

Liberty is defined both as "*the power of choice*" and also as "*The condition of being free from oppressive restriction or control by a government or other power.*"

Justice - the principle of moral rightness and decency.

Now, another word that I think demands to be defined is the word "coerce". "Coerce means to persuade an unwilling person to do something by force or threat; to force to act or think in a given manner; to compel by pressure, or threat.

For instance, "If you want to eat at this restaurant, you'll have to be vaccinated." Does that sound like pressure to you? What about, "You won't be able to buy groceries at this store unless you are vaccinated..." Does this seem like a threat? "You can't get a job working in this company unless..." "You can't go to this school until..." These very real examples are not examples of a free and equal society. They are examples of coercion in a society run by an archaic class system and tyranny. Not only so, but these examples violate 18 US Code section 2331, subsection 802, which expands the definition of domestic terrorism resulting in death of American citizens. Inside this expanded definition of domestic terrorism is anytime a US citizen or a government in the US is forced to do something that they would not otherwise do. This is not only coercion but domestic terrorism. And it comes with a 99 year prison sentence or a \$100 million fine.

Now, you may say, "but that's only for an act "dangerous to human life". To which I would call your attention to recent VAERS statistics.

VAERS, the Vaccine Adverse Events Reporting System, a government website that is self-admittedly grossly underreported, as of January 03, has recorded over 1 million adverse events from COVID vaccines, including over 21,000 deaths. By the way, that is more deaths from a single vaccine than the deaths from every other vaccine in the history of VAERS combined. And this does not take into account the thousands of permanent disabilities and life-altering events reported in that same system - things like anaphylaxis, paralysis, blood clotting disorders, autoimmune disorders, myocarditis and other heart problems, spontaneous late-term miscarriages and still-births, and infertility issues, to name a few.)

In 2011, the Supreme Court ruled that vaccines are "unavoidably unsafe" - and this was in reference to vaccines that had undergone years of studies, (unlike the COVID vaccine, which breaks the Nuremberg code of ethics, and has been pushed past animal trials because, in trials, all the animals were dying.

Where there is risk there *MUST* be choice.

Vaccines contain ingredients that different peoples' bodies react to differently. Just as not everyone can take the same antibiotic (which passes through the digestive system and which you can stop taking), not everyone's bodies can handle the ingredients in these vaccines (which you cannot reverse or stop taking, and many of which cross the blood-brain barrier). Furthermore, *dozens* of aborted fetuses are used in the studies for the making of a single lot of vaccines. For many with various religious beliefs, this alone is reason to choose not to receive the COVID-19 vaccine.

In a world where the scientific gold standard is a double-blind, placebo-controlled study, ironically, there have been ZERO double-blind, placebo-controlled studies done on any vaccine EVER. Yet compared health outcomes of the vaccinated versus unvaccinated are astoundingly better in the unvaccinated.

COVID19 vaccine manufacturers also hold ZERO liability for any injury or death caused by or correlated to their products, and these companies stand everything to gain. Doctors receive incentives for giving these vaccines, creating a major conflict of interest.

Lastly, COVID-19 survival rates, per the CDC, for the *entire population from birth to 82 is 99.8%*. And, vaccinated or unvaccinated, it makes no difference when it comes to transmitting the virus.

Now that we have some of these facts covered, I would like to zero-in on the issue of prohibiting anyone from discrimination based off of vaccination status, which is what We the People assembled are here for.

As someone who is disabled with a number of invisible but debilitating health issues, I understand a thing or two about the notion of "equal access".

And I would like point out that "equal access" is *not* Jim Crow. It is NOT "separate

restaurants and businesses for the vaccinated versus unvaccinated” It is equal access for ALL - regardless of their - very personal- healthcare decisions. Anything other than true equal access is a separation of society by “class” of vaccinated vs unvaccinated. And it is a major step backward toward a very ugly history.

For businesses that are entertaining (or have already begun to entertain) the idea of checking vaccination status, the question must be asked “Why? What would this accomplish?” Since we now clearly know that social distancing, masking, and vaccination has not succeeded in “stopping the spread” of COVID 19, in all of its widespread and continuous forms, and since vaccines do not prevent transmission - we can conclude that separation of vaccinated versus unvaccinated truly accomplishes nothing of virtue - but *DOES* absolutely accomplish division amongst society. And that does not sound like the “one nation, under God, indivisible, with liberty and justice for all” that I know.

In a world where everything must be politically correct and we do not allow even the appearance of discrimination for any other reason, it is only common sense to **insure that personal health choices be proactively protected**. Not to wait for the lawsuits to come in - because they will - but to take a stand, loud and clear, that we will protect the rights of ALL Wisconsinites, regardless of their personal choices. To not protect this freedom of choice is not only violating HIPPA privacy laws and opening up the door to discrimination of the worst kind, but it is downright unethical. “Forward, Wisconsin” - not backward toward discrimination, segregation, and divisiveness.

Henri Frederic Amiel said “...Health is the first of all liberties.”
And John Adams said “Liberty once lost is lost forever.” Let us not lose all that those before us wisely held so dear and fought so hard to gain.

I stand today before God, urging you to do what your title calls you to - to REPRESENT the people of Wisconsin - by the people, for the people . Someone once said “Bureaucrats protect the establishment. Leaders protect individual rights.” I urge you to protect individual rights in voting yes to these bills. protect health freedom and health choice, to protect what is right and good and true, to protect ethical, constitutional law. Please distribute this testimony to other committee members and vote YES for the four protective Senate Bills 336, 338, 337 and 342.

As a Lyme/MSIDS patient and advocate, I work with ill Wisconsinites who have severe immune issues. Forcing employers to implement vaccine requirements as terms of employment unnecessarily subjects employers to potential, significant Workers' Compensation claims for anyone who experiences injury from the vaccine, including death.

Studies show that even though a drug or treatment is approved by the FDA it does not automatically deem it safe as we see TV ads daily from law firms stating: "If you've been injured by... you may have a case." Thalidomide is an example as it was deemed safe in the 1950's but by 1960's (one decade later) it was found to be the cause of horrible birth defects. There have been no long-term studies regarding this experimental MRNA vaccine which serves to artificially create a "spike protein" within your cell's RNA (which is the protein that makes up your DNA and is in every cell and organ in your body). The body is then supposed to recognize this spike protein (which is in every cell/organ throughout your body) and attack it. This is exactly how auto immune diseases operate.

Additionally, as natural immunity and herd immunity increases, and spring approaches, infections will naturally decrease on their own within a few months. Facts and studies show that individuals who contract covid develop natural immunity, which lasts longer (10+ years), is more effective than any artificial vaccine immunity and is broad in nature meaning it

will also recognize similar variants and fight them. Vaccine immunity only lasts a few months, is not broad in nature and does nothing to prevent the person from also catching the virus. Vaccinated people can catch the virus and spread it to others (vaccinated and non-vaccinated). Additionally, vaccinated individuals tend to be sicker for longer periods of time compared to non-vaccinated individuals. I personally know vaccinated individuals who have been hospitalized (more than once) and others that have been sick for several days/weeks rather than just a couple days. Published studies have also shown that individuals who contracted the SARS-Cov1 virus back in 2003 still had active antibodies against it 17 years later. It is time that natural immunity is recognized and acknowledged. It is also time that more focus and money is given to cost-effective, therapeutic treatments (not solely pharmaceutically driven) rather than just vaccines, which are short-term and largely ineffective in slowing the spread. Providers should be allowed to prescribe treatments for their patients as they deem appropriate, not dictated by the government.

Back in 2020, the goal was to minimize the spread so the health care system did not get overloaded. Current issues being experienced by the health care field are not due to unvaccinated individuals, but rather due to the staffing shortage, which is largely a result of health care workers being fired over the vaccine mandate or quitting. Additionally, all individuals presenting to the hospital are tested, and if a person tests positive they are admitted to a covid unit, even if they don't have symptoms or have an issue related to covid. Constant testing, re-testing and excessive quarantining are leading to the demise of our economy, mental and emotional well-being, education system and health care system.

The pandemic can and will end as soon as all of the testing and quarantining ends and this virus is treated like any other respiratory virus such as the flu and common cold. Vaccines should be voluntary for those who want it and for those most vulnerable and not forced upon others, employers or the education system.

In summary, please preserve our rights and ability to make our own health care choices. Please vote "YES" on these bills.

It is with sadness that I share news about both my husband age 61 and son age 25 after taking a Moderna and Pfizer vaccination last April. Both were diagnosed with cancer last June. My son recovered from kidney cancer after chemotherapy. My husband,

David, died in late November with cancer in kidneys, lungs and bones (his spine was broken). David had a healthy life, no surgeries and no family history of a rare cancer that presents mainly in children. - In December, I took my father to Summit View ER, Oconomowoc. Their standard question to registering patient is, "Do you have any renal failure?" THIS is where we are today.

In the news recently was a court case against the FDA over a Freedom of Information request that the FDA wanted to hide related paperwork for 75 years. Also recently, the CDC refused to provide deidentified (meaning withheld personal information) data from the V-Safe smart phone app used by the general public to tell the CDC about any side effects after the COVID-19 vaccination. Whistleblowers like Quality Assurance, Melissa Strickler, former employee at Pfizer, are banned by big tech. It is no wonder that people around the world do not trust the media and government. I've held a career in Quality Assurance for many years. With the problems previously stated, below is one of the most important sections of ISO 9001:2015:

10.2 Nonconformity and corrective action

10.2.1 When a nonconformity occurs, including any arising from complaints, the organization shall:

- f) make changes to the quality management system, if necessary.

Corrective actions shall be appropriate to the effects of the nonconformities encountered.

10.2.2 The organization shall retain documented information as evidence of:

- a) the nature of the nonconformities and any subsequent actions taken;
- b) the results of any corrective action.

The pharmaceutical companies manufacturing the COVID-19 vaccination are NOT doing anything about the thousands and thousands of people on the VAERs report and probably the V-safe smart phone system report.

SB336 complies with the following Federal law that any person may accept or refuse administration of an emergency use product, Title 21 U.S.C. § 360bbb-3(e)(1)(A)(ii)(I-III) of the Federal Food, Drug, and Cosmetic Act, about products granted Emergency Usage Authorization (EUA):

Individuals to whom the product is administered are informed—

(I) that the [DHHS] Secretary has authorized the emergency use of the product;

These Bills 383, 337, 342 and 336 are to be discussed by the WI Senate on January 12, 2022 and are available for public comment.

Senate Bill 342

This bill forbids the state and any governmental entity from discriminating against any person based on whether the person has received a vaccine against the SARS-CoV-2 coronavirus, which causes COVID-19, or is able to show proof of having received such a vaccine.

Senate Bill 337

This bill prohibits any business or legal entity engaged in any enterprise in the state from discriminating against any customer, client, or potential customer or client based on that person's vaccination record.

Senate Bill 383

This bill forbids the state, any governmental entity, and any business or legal entity engaged in any enterprise in the state from requiring any person to provide proof that the person has received a vaccine against the SARS-CoV-2 coronavirus, which causes COVID-19, as a condition of receiving any services, transacting any business, accessing any building, or participating in any function.

Senate Bill 336

This bill prohibits discrimination on the basis of vaccination status, which is

defined in the bill as whether an individual has received one or more doses of a vaccine. The bill also make changes to various discrimination laws.

I am I favor of these Bills ! This discrimination against the unvaccinated has gone far enough. My name is Renee Thelen. I am a resident of Saint Cloud in Fond du Lac County. I am emailing to request that the Senate Committee on Health vote YES to Senate bill numbers 336, 383, 337 and 342.

I have worked for Sargento Foods in Plymouth for 26 years. Those of us who choose not to receive the COVID-19 vaccine are being treated differently than those employees who choose to be vaccinated. Because of the difference in treatment, morale is low and the workforce is divided. While Sargento has always been known to be a great place to work, employees are quitting and retiring like I have never seen before. All at a time when every employer cannot find enough help. If unvaccinated employees contract COVID-19, they are sent home without pay while those who are vaccinated are sent home with pay. We are forced to wear a mask all day while vaccinated are not, even though vaccinated people can get and transmit the virus. I know many people who have been vaccinated who have still gotten the virus. Some have even died.

Our daughter began her college career at Bellin College in Green Bay for nursing. About a month after she started classes, she was informed that she would have to get the COVID-19 vaccine by the end of 2021 or not be allowed to attend classes anymore. What is a young person just starting her college career supposed to do, even though she doesn't want to be vaccinated? She did not have the option to test. Even the large UW schools, of which many of our friends' children attend, are given the option to test.

Weekly testing is absurd.
