SUBJECT: 2021-22 Estimated State Support for School Districts

This memorandum provides information on the estimated level of state support provided for K-12 education statewide and to individual school districts in 2021-22.

Background

State support of K-12 education in Wisconsin has traditionally been measured using the concept of partial school revenues, which includes only revenues received by school districts from state aid and the property tax levy. The numerator of the state support calculation includes the sum of the following:

- General school aids, which are unrestricted aids that are under a district's revenue limit. The majority of general school aids are provided through the equalization aid formula, which distributes aid based on the relative fiscal capacity of each school district as measured by the district's per pupil value of taxable property. Integration aid, special adjustment aid, and high poverty aid are also considered general aids.
- Categorical aids, including per pupil aid and other aid programs that partially fund specific program costs (such as special education, achievement gap reduction, and pupil transportation) which are outside of a district's revenue limit.
- The school levy tax credit, which is distributed based on each municipality's share of statewide levies for school purposes during the preceding three years and allocated proportionately to reduce individual owners' property tax bills.
- The first dollar credit, which is extended to each taxable parcel of real estate on which improvements are located, and calculated by multiplying the property's gross school tax rate by the lesser of a credit base value or the property's fair market value.

- The general program operations appropriation for the Wisconsin Educational Services Program for the Deaf and Hard of Hearing and the Wisconsin Center for the Blind and Visually Impaired.

The denominator of the state support calculation, or partial school revenues, includes (with certain exceptions described below) the sum of state general and categorical aids and gross property taxes levied, including exempt property aids, for school districts. Exempt property aids are paid to local units of government, including school districts, by the state as a hold harmless from the impact of exempting specified equipment from the property tax. Exempt property aids are treated as school property tax levy, not school aids, for the purposes of the state support calculation because it is revenue for which districts would have levied if the value of the exempt property was included in full property value.

State support can be calculated on a statewide basis and for an individual school district. The level of state support received by a district may be higher or lower than the statewide percentage depending on the district's per pupil aidable costs and equalized property value, as well as the amount of funding the district received through categorical aids and the levy credit.

From 1996-97 to 2002-03, the state had a statutory commitment to fund two-thirds of K-12 partial school revenues. The 2003-05 biennial budget act (2003 Act 33) eliminated the state's two-thirds funding commitment and the associated statutory provisions. For purposes of this memorandum, the state support calculation is based on the statutory definition that was used to measure two-thirds funding in 2002-03, the year prior to its repeal.

Statewide Support for K-12 Education

Based on the funding appropriated for 2021-22 and the 2021 gross property taxes levied for school districts, the state share of K-12 education in 2021-22 was 66.20% of partial school revenues. Table 1 summarizes the state's support of K-12 education for 2019-20, 2020-21, and 2021-22.

State Support by School District

Attachments 1 and 2 present information on the level of state support provided to each of the 421 school districts in the state. Attachment 1 lists the districts in alphabetical order, while Attachment 2 lists the districts by rank order of state support. The following describes the information contained in each column of the attachments.

It should be noted that the property tax levies shown in Column 10 of Attachments 1 and 2 do not necessarily represent the entire amount levied by a school district in 2021-22. Under the two-thirds funding calculation as it existed in 2002-03, certain levies (described below) were excluded from the statewide calculation of partial school revenues. To maintain historical consistency, these levies are also excluded from the calculations for individual districts.

Under 2001 Act 16, levies by school districts statewide for community service activities and by the Milwaukee Public Schools (MPS) for the Milwaukee private school choice program were removed from the definition of partial school revenues. School districts can establish a fund for community service activities to account for such things as adult education, community recreation programs such as evening swimming pool operation and softball leagues, elderly food service programs, non-special education preschool or day care services, and other programs which are not K-12 educational programs but have the primary function of serving the community. Prior to Act 16, if a school district levied for community service activities, that fund was part of the limited levy under revenue limits and was included in partial school revenues. Act 16 removed the community service levy from that portion of the levy controlled by revenue limits and excluded these levies from partial school revenues.

Also under Act 16, the portion of the amount levied by MPS to replace its general aid reduction related to the choice program was removed from partial school revenues. By law, the general school aids that would otherwise have been paid to MPS in 2021-22 were reduced by a net amount totaling 9.6% of the estimated total cost of the Milwaukee program. Under revenue limits, MPS is able to levy to offset this choice reduction, but that levy was not counted in partial school revenues.

To be consistent with the definition of state support under the prior two-thirds funding law, the levy shown for MPS in Attachments 1 and 2 excludes the \$18.9 million net choice levy, after consideration of high poverty aid and additional aid paid to the City of Milwaukee to defray the choice levy. As a result, MPS is shown in those attachments with a state support level of 78.86%, ranking MPS 43rd among districts in state support. If the Milwaukee choice levy were included in the 2021-22 state support calculation, the percent support for MPS would drop to 77.43%, which would rank MPS 59th in state support.

Under 2001 Act 109, the amount of referenda-approved school district debt levy included in the definition of partial school revenues was limited to the lesser of the actual referenda-approved debt levy or \$490 million. The statewide total levy for referenda-approved debt in 2021-22 was \$856.0 million. As a result, 57.2% of the statewide levy for referenda-approved debt would have been included in the definition of partial school revenues for 2021-22, had that limit been in effect for that year.

Attachment 3 shows the total gross school property tax levy (prior to the distribution of the school levy and first dollar tax credits) as well as the community service levy, the net MPS choice program levy, and the excluded portion of referenda-approved debt levy for each district in 2021-22. The total levy, less the excluded levies, is the amount of each district's levy that would have been included in partial school revenues. The second column of Attachment 3 is the same as the school property tax levy included in the partial school revenues column of the first two attachments, which would have been consistent with the definition of partial school revenues used on a statewide basis to determine two-thirds funding.

The exclusion of the categories of levy described above has the effect of reducing the partial school revenues figure, and thus increasing the percent state support figure that a given level of funding provides. If the 2021-22 state support calculation had instead been based on the statutory definition used to measure two-thirds funding in the first year of that commitment, before the exclusions were enacted, the support percentage would have been 63.23%

Attachments 1 and 2 show that total state support equals 64.50% of partial school revenues, rather than 66.20% as shown in Table 1. This difference in estimated statewide support percentages occurs primarily for four reasons.

First, \$150 million in funding for the first dollar credit is not reflected in the attachments. The credit is funded from the same appropriation as the school levy tax credit. Similar to the levy credit, funding is distributed to counties or municipalities to be applied as a credit to property tax bills after school districts have set their levies. The Department of Revenue does not collect data on the number of taxable improved parcels by school district, and school district and municipal boundaries are generally not contiguous. As a result, credit amounts cannot be allocated by school district on a statewide basis.

Second, a net total of \$58.1 million in categorical aid funding is not accounted for in the attachments. Entities other than school districts are, by law, eligible for some categorical aid programs. Payments to these entities would not be reflected in the attachments. For example, the figures in the attachments do not include state aid payments to cooperative educational service agencies (CESAs), county children with disabilities education boards (CCDEBs), independent charter schools, private schools, or other individuals and organizations. Also, district-specific figures are not available for state debt service payments on behalf of school districts under the technology infrastructure bonding program.

Third, the general school aid amount shown for MPS in the attachments is net of the reduction reflected in the October 15, 2021, aid distribution associated with the Milwaukee private school choice program, rather than the gross aid eligibility amount generated under the general aid formula. The cost of the payments from the Milwaukee choice appropriation is partially offset by a reduction from the general school aids appropriation to the general fund. Based on the October 15, 2021, general school aids distribution, after consideration of City choice program levy aid, the 2021-22 general school aids payment to MPS was initially reduced by \$22.8 million (\$18.9 million net of high poverty aid) for the Milwaukee program. By law, under revenue limits, MPS may levy property taxes to make up for the amount of revenue lost due to this aid reduction. Consistent with DPI's October 15 aid distribution, aid reductions made for the Racine and statewide private school choice programs, the special needs scholarship program, and certain schools in the independent charter program, which districts by law are not able to levy to replace, are not reflected in the attachments.

Fourth, the \$12.9 million general program operations appropriation for the Educational Services Program for the Deaf and Hard of Hearing and the Center for the Blind and Visually Impaired is not reflected in the printouts. This state operations appropriation was included in the prior law definition of two-thirds funding, but is used for DPI staff and supplies costs at the state residential schools and is not paid directly to school districts.

The Norris School District is shown in the attachments with a support level of 99.51%. However, Norris is a unique school district that is a residential school whose district boundaries contain almost solely school district property. This means that there is very little property tax levy to contribute to the district's partial school revenues. Norris thus derives nearly all of its revenues from state and federal aid. As a result, while Norris is ranked as having the highest percentage of state support for the purposes of this exercise, the District's unique qualities preclude comparison with other school districts.

Table 2 shows the distribution across school districts of state support of partial school revenues. After Norris, the district with the highest percentage of state support is the Beloit School District, which received an estimated 89.40% of its partial school revenues from the state. The Gibraltar Area School District received the lowest estimated percentage state support at 22.49%. The district at the 10th percentile of state support (Wild Rose) received an estimated 34.91% state support, while the district at the 90th percentile (MPS) received an estimated 78.86% state support. Thus, 80% of all districts received between 34.91% and 78.86% state support. Excluding Norris, the median (middle point) percentage of state support is 66.21% and the mean (average) is 64.50%.
