2. Page 102, line 5: increase the dollar amount for fiscal year 2015–16 by
$$500,\!000$ and increase the dollar amount for fiscal year $2016-17$ by $$500,\!000$ for the
purpose of broadband expansion grants.

- **3.** Page 293, line 4: delete lines 4 to 9 and substitute:
- **"Section 511g.** 20.155 (3) (f) of the statutes is created to read:
- 20.155 (3) (f) Broadband expansion grants; state funds. Biennially, the amounts in the schedule for broadband expansion grants under s. 196.504.
- **SECTION 511i.** 20.155 (3) (g) of the statutes is renumbered 20.155 (3) (k) and amended to read:
- 20.155 (3) (k) *Broadband expansion grants*; *program revenues–service*. As a continuing appropriation Biennially, the amounts in the schedule for broadband expansion grants under s. 196.504. The amounts transferred from s. 20.505 (1) (is) to this appropriation shall be credited to this appropriation account.".
  - **4.** Page 1162, line 8: delete lines 8 and 9.
  - **5.** Page 1163, line 4: after that line insert:
- **Section 3535p.** 196.504 (1) (a) 3. of the statutes is amended to read:
- 196.504 (1) (a) 3. A city, village, town, or county, school district, technical college district, or public library board that submits an application in partnership with an eligible applicant under subd. 1. or 2.".
- **6.** Page 1163, line 15: delete lines 15 and 16 and substitute "appropriation appropriations under s. 20.155 (3) (g) (f) and (k).".
- 7. Page 1163, line 23: after "scalable," insert "that are located in counties with the highest unemployment rates in the state, that are located in counties with the lowest rates of broadband access in the state,".

<b>8.</b>	Page 1514.	line 19: dele	te lines 19 to	24 and substitute:

- "(2qu) Federal broadband opportunities. No later than January 1, 2016, the
   public service commission shall submit a report to the joint committee on finance on
- 4 federal broadband expansion funding opportunities.".
  - **9.** Page 1543, line 22: delete lines 22 to 24.
