1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 169, line 10: after that line insert:

3 “(fu) Grant for I 39 detour project,

4	state funds	SEG	B	576,300	-0-".

5 **2.** Page 169, line 13: after that line insert:

6 “(fw) Grant for I 39 landscaping proj-

8 **3.** Page 309, line 9: after that line insert:

9 **“SECTION 651L.** 20.395 (2) (fu) of the statutes is created to read:

1 20.395 (2) (fu) *Grant for I 39 detour project, state funds.* Biennially, the
2 amounts in the schedule for the grant under 2015 Wisconsin Act ... (this act), section
3 9145 (1u).

4 **SECTION 651n.** 20.395 (2) (fw) of the statutes is created to read:

5 20.395 (2) (fw) *Grant for I 39 landscaping project, state funds.* Biennially, the
6 amounts in the schedule for the grant under 2015 Wisconsin Act ... (this act), section
7 9145 (6L).”.

8 **4.** Page 803, line 7: after that line insert:

9 **“SECTION 2552m.** 84.013 (10) of the statutes is created to read:

10 84.013 (10) The department may not require the city of Wautoma to contribute
11 to any design engineering costs associated with design work for a proposed highway
12 construction project involving STH 22 running through the city of Wautoma and for
13 which design engineering was initiated in 2010–11.”.

14 **5.** Page 1524, line 22: after that line insert:

15 “(1u) VILLAGE OF COLOMA I 39 DETOUR PROJECT. In the 2015–17 fiscal biennium,
16 from the appropriation under section 20.395 (2) (fu) of the statutes, the department
17 of transportation shall award a grant in the amount of \$576,300 to the village of
18 Coloma in Waushara County to construct a highway connecting CTH “CH” and STH
19 21, to serve as a detour during the I 39 Coloma project commenced by the department
20 of transportation.”.

21 **6.** Page 1528, line 20: after that line insert:

22 “(6L) VILLAGE OF COLOMA I 39 LANDSCAPING PROJECT. In the 2015–17 fiscal
23 biennium, from the appropriation under section 20.395 (2) (fw) of the statutes, as
24 created by this act, the department of transportation shall award a grant in the

1 amount of \$50,000 to the Village of Coloma in Waushara County to remove trees and
2 construct a snow fence at the interchange of I 39 and STH 21.”.
