tion for the purpose of submitting to the said electors the question whether the aforesaid resolution shall remain in effect and its adoption be ratified, and such resolution shall not have force or effect unless the votes of a majority of the electors of the municipality voting on such question shall be in favor thereof.

2. The common council, commission council or governing board of such municipality may provide for the notice, the manner of holding such election and the method of voting thereon and of making returns thereof and the canvassing and determining of the result thereof; provided, that notice of the submission of the question contemplated herein to the electors shall be given by a brief notice of that fact once a week for three weeks in some newspaper of general circulation published in the municipality wherein the election is to be held, and if there be no newspaper published therein, then publication may be made in any newspaper of general circulation in the county seat of the county wherein the municipality is located. The notice of holding any special election shall be incorporated as a part of the aforesaid notice.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 394

- AN ACT to appropriate certain sums therein named to the state hoard of education, for the board of trustees of the Stout institute, for Stout institute.
- The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is appropriated from the general fund to the state board of education, for the board of trustees of the Stout institute, for Stout institute, not to exceed twenty-two thousand two hundred twenty-six dollars and sixty-two cents, for operation for the fiscal year 1916—17.

SECTION 2. There is appropriated from the general fund to the state board of education, for the board of trustees of the Stout institute, for Stout institute, ten thousand two hundred fourteen dollars and forty cents, of which one thousand two hundred twenty-seven dollars and seventy-nine cents shall be available for the purposes enumerated in subsection (3) of section 20.34, and the balance for the purposes enumerated in subsection (5) of section 20.34 of the statutes. SECTION 3. This act shall take effect upon passage and publication.

- AN ACT to create sections 1421-31, 1421-32 and 1421-33, and a new subsection of section 20.17, of the statutes, to establish the northern state tuberculosis sanitorium, and making an appropriation.
- The people of the State of Wisconsin, represented in Scnate and Assembly, do enact as follows:

SECTION 1. There are added to the statutes three new sections to be numbered and to read:

Section 1421—31. There is established a new institution, to be located north of the center line of the state, and to be known as the northern state tuberculosis sanitorium, for the treatment of pulmonary tuberculosis, and especially for cases in the incipient and moderately advanced stages. The state board of control shall construct the necessary buildings for such sanitorium on lands owned by the state if in the judgment of said beard any such lands will furnish a site which is appropriate and practicable; otherwise said board is authorized to purchase a suitable site at a price of not to exceed twenty-five dollars an aere.

Section 1421-32. The provisions of sections 1421-1 to 1421-8 shall apply to and govern said institution.

Section 1421—33. The state board of control is authorized to erect on such site, and equip, such buildings as it deems proper, to meet the demands for the admission of persons afflicted with tuberculosis.

SECTION 2. There is added to section 20.17 of the statutes, a new subsection to be numbered and to read:

(20.17) (28) For the northern state tuberculosis sanitorium, on July 1, 1917, seventy-five thousand dollars, for the purchase of a site and the erection and equipment of buildings.

SECTION 3. This act shall take effect upon July 1, 1917.
