



**ASSEMBLY SUBSTITUTE AMENDMENT 1,  
TO 1995 ASSEMBLY BILL 756**

February 29, 1996 – Offered by COMMITTEE ON HIGHWAYS AND TRANSPORTATION.

1     **AN ACT to amend** 341.13 (2); and **to create** 341.145 (1) (d), 341.145 (1) (e),  
2           341.145 (1g) (c) and 341.145 (1g) (d) of the statutes; **relating to:**  
3           personalization of special license plates that grant certain parking privileges  
4           to the physically disabled.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

5           **SECTION 1.** 341.13 (2) of the statutes is amended to read:  
6           341.13 (2) In addition to the matter specified in s. 341.12 (3), the registration  
7           plates for a vehicle registered on the basis of gross weight except a motor truck  
8           registered under s. 341.14 (6m) or 341.145 (1) (b), a dual purpose motor home, or a  
9           motor home, motor truck, farm truck or dual purpose farm truck registered under  
10          s. 341.14 (1), (1a), (1m), (1q), (1r) (a), (2) or (6r) or 341.145 (1) (a) ~~or~~, (c), (d) or (e) or  
11          a motor truck or dual purpose farm truck registered under s. 341.14 (6) shall indicate  
12          the weight class into which the vehicle falls in a manner prescribed by the  
13          department. The gross weight which determines the registration fee for a motor  
14          truck registered under s. 341.14 (6m) or 341.145 (1) (b), a dual purpose motor home,

1 or a motor home, motor truck, farm truck or dual purpose farm truck registered  
2 under s. 341.14 (1), (1a), (1m), (1q), (1r) (a), (2) or (6r) or 341.145 (1) (a) ~~or~~, (c), (d) or  
3 (e) or a motor truck or dual purpose farm truck registered under s. 341.14 (6) shall  
4 be shown on its certificate of registration.

5 **SECTION 2.** 341.145 (1) (d) of the statutes is created to read:

6 341.145 (1) (d) A registration plate of the same color and design as provided in  
7 s. 341.14 (1) for a vehicle specified in s. 341.14 (1), which displays a registration  
8 number composed of letters or numbers, or both, not exceeding 4 positions and not  
9 less than one position, requested by the applicant.

10 **SECTION 3.** 341.145 (1) (e) of the statutes is created to read:

11 341.145 (1) (e) A registration plate of the same color and design as provided in  
12 s. 341.14 (1a) for a vehicle specified in s. 341.14 (1a), which displays a registration  
13 number composed of letters or numbers, or both, not exceeding 6 positions and not  
14 less than one position, requested by the applicant.

15 **SECTION 4.** 341.145 (1g) (c) of the statutes is created to read:

16 341.145 (1g) (c) The department may issue personalized registration plates  
17 under sub. (1) (d) to a person who qualifies for special plates under s. 341.14 (1) or,  
18 if in lieu of special plates under s. 341.14 (1), s. 341.14 (1r).

19 **SECTION 5.** 341.145 (1g) (d) of the statutes is created to read:

20 341.145 (1g) (d) The department may issue personalized registration plates  
21 under sub. (1) (e) to a person who qualifies for special plates under s. 341.14 (1a), (1m)  
22 or (1q) or, if in lieu of special plates under s. 341.14 (1a), s. 341.14 (1r).

23 **SECTION 6. Effective date.**

24 (1) This act takes effect on January 1, 1998.
