**ASSEMBLY AMENDMENT 5,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO SENATE BILL 2**

May 19, 1998 – Offered by Representatives KUNICKI, BOCK, COGGS, CULLEN, KRUG, KRUSICK, LA FAVE, MORRIS-TATUM, NOTESTEIN, PLALE, R. POTTER, RILEY, WASSERMAN and L. YOUNG.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 2, line 5: after that line insert the following material:

3 “**SECTION 1m.** 20.255 (2) (ec) of the statutes, as affected by 1997 Wisconsin Act
4 27, is amended to read:

5 20.255 (2) (ec) *Aid to Milwaukee public schools.* The amounts in the schedule
6 to correct the academic deficiencies of educationally and economically
7 disadvantaged pupils and to achieve a more effective and responsive educational
8 program in the school district operating under ch. 119. In the 1998-99 school year,
9 moneys in this appropriation may also be used for the purposes specified in s. 119.76.

10 In the 1993-94 fiscal year and in each fiscal year thereafter, the amount in the
11 schedule shall be distributed according to the spending plan under s. 119.80. The
12 department of public instruction may not distribute any funds in the appropriation

1 under this paragraph in the 1993–94 fiscal year or in any fiscal year thereafter until
2 the spending plan for that fiscal year has been approved under s. 119.80.”.

3 **2.** Page 5, line 4: after that line insert the following material:

4 “**SECTION 6.** 119.76 of the statutes is created to read:

5 **119.76 After-school programs.** From the appropriation under s. 20.255 (2)
6 (ec), the state superintendent shall pay to the board the amounts specified in the
7 spending plan under s. 119.80 for the following programs in the 1998–99 school year:

8 (1) After-school educational programs.

9 (2) After-school recreational programs.

10 (3) After-school health programs.

11 **SECTION 9139. Nonstatutory provisions; public instruction.**

12 (1) AID TO MILWAUKEE PUBLIC SCHOOLS. Notwithstanding section 16.42 (1) (e)
13 of the statutes, in submitting information under section 16.42 of the statutes for the
14 purposes of the 1999–2001 biennial budget bill, the department of public instruction
15 shall submit information concerning the appropriation account under section 20.255
16 (2) (ec) of the statutes, as affected by this act, as though the increase in the dollar
17 amount of that appropriation by SECTION 9239 (1) of this act had not been made.”.

18 **3.** Page 6, line 20: after that line insert the following material:

19 “**SECTION 9239. Appropriation changes; public instruction.**

20 (1) AID TO MILWAUKEE PUBLIC SCHOOLS. In the schedule under section 20.005 (3)
21 of the statutes for the appropriation to the department of public instruction under
22 section 20.255 (2) (ec) of the statutes, as affected by the acts of 1997, the dollar

1 amount is increased by \$2,500,000 for fiscal year 1998-99 to increase funding for the
2 purposes for which the appropriation is made.”.
